We have performed audits of the accompanying financial statements of The Metropolitan Museum of Art 403(b) Retirement Plan for Non-Union Employees (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. #### 1. Plan Description

##### **General**

The Metropolitan Museum of Art 403(b) Retirement Plan for Non-Union Employees (the “Plan”) is a contributory, defined contribution plan covering substantially all non-union employees of The Metropolitan Museum of Art (the “Museum”). The original effective date of the Plan was July 1, 1987 and it has been amended and restated several times thereafter. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

##### **Plan Administration**

The Museum’s Trustee Employee Benefits Committee is responsible for the general oversight of the Plan and Plan amendments. The Museum’s Trustee Investment Committee periodically reviews investment options offered by the Plan to participants. Additionally, Fidelity Management Trust Company (“FMTC”) and Voya Retirement Insurance and Annuity Company (“Voya”) are the custodians and Fidelity Workplace Services, LLC is the recordkeeper of the Plan.

The following summary description of the Plan is provided for general information purposes only. Participants should refer to the plan documents for more complete information.

##### **Eligibility Requirements**

All non-union employees, other than temporary employees and nonresident aliens earning foreign source income, are eligible to participate in the Plan upon date of hire and completion of one hour of service.

##### **Contributions**

As a condition of employment, all eligible participants are required to make a 3% tax-deferred salary reduction contribution to the Plan commencing immediately upon hire, subject to the limitations of the Internal Revenue Code (“IRC”). Participants are not permitted to make additional contributions. During each plan year, the Museum makes annual contributions to the Plan based on 8% of each active participant’s earned compensation.

##### **Vesting**

Participants are fully vested in their own contributions and earnings. Participants are 100% vested in the Museum’s contributions after completing two plan (calendar) years and at least 1,000 hours of service in each of those two years. A participant becomes 100% vested in his or her employer contribution upon disability or death, while an employee of the Museum. Any eligible employee who was a participant in the Plan on May 31, 2008 is fully vested in the Museum’s contribution. Participants hired prior to 2008 but not yet participating in the Plan as of May 31, 2008, received a one-year credit toward vesting as of June 1, 2008, and received their second year of vesting credit if they worked at least 1,000 hours in their anniversary year ending in 2008, or in the next plan year in which they worked 1,000 hours.

##### **Forfeitures**

If a participant is terminated before two years of service, excluding death or disability, the accrued benefit derived from the Museum’s contributions are forfeited. Forfeitures will be used by the Museum to reduce administrative expenses of the Plan and then to reduce future matching contributions. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$327,843

and \$169,988, respectively. During 2024, \$293,103 of forfeitures were used to reduce employer contributions and no forfeitures were used to reduce administrative expenses.

#### **Investment Options**

Participants direct the investment of their contributions into various investment options offered by the Plan. The Voya Guaranteed Investment Account was closed to new contributions and investments effective June 1, 2013. Current balances may remain with Voya, but no future contributions can move into the account. Loans taken prior to June 3, 2013 remain with Voya, any subsequent loans are offered through FMTC (refer to Notes receivables from Participants). If an employee does not elect an allocation between the funds available, their contributions will be invested in the Qualified Default Investment Alternative designated by the Museum which is the Vanguard Institutional Target Retirement Date Fund. The fund chosen will be the target date fund closest to the employee's 65th birthday.

#### **Participant Accounts**

Each participant account is credited with the participant's contribution, the employer's contribution and Plan earnings (losses), and charged with investment losses, fees and withdrawals. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined.

#### **Benefit Payments**

The vested portion of a participant's benefits becomes payable on termination of employment (including due to retirement, resignation, dismissal, death or disability). The participant or beneficiary may elect to rollover funds into an eligible retirement plan, receive a lump-sum distribution equal to the value of the participant's vested interest in his or her account, or receive an annuity to be paid in monthly installments over a fixed reasonable period of time, not to exceed the life expectancy of the participant and/or designated beneficiary. A participant may also elect to leave the account in the Plan where it is subject to minimum distributions upon the later of retirement or age 73.

#### **Notes Receivables from Participants**

Participants may borrow a minimum amount of \$1,000 up to a maximum amount of \$50,000 from the participant's employee contribution balance, subject to certain restrictions. Loans used to purchase a primary residence may be repaid over twenty years, however loans for all other purposes must be repaid within five years.

Loans are provided by Fidelity directly from a participant's account. Adequate security of 100% is required for the full amount of the loan and a portion of the participant's employee contribution account is reserved and held as collateral which covers the outstanding loan and interest in the event of default. For all plan loans, interest and principal is paid by the participant to Fidelity. The interest rates are determined as Prime Rate plus 1 percent. The outstanding loan balance, which includes principal and any unpaid accrued interest, from Fidelity at December 31, 2024 and 2023 was \$626,165 and \$705,903, respectively.

Loans were provided by Voya to participants prior to June 3, 2013. The Plan offered a loan feature whereby a participant enrolled in the Plan may borrow a minimum amount of \$1,000 up to a maximum of 50% of their vested account balance or \$50,000, whichever is less. Loan transactions are treated as a transfer from the investment fund or to the loan fund. Loans are collateralized by the balance in the participant's account and bear interest as determined at the time of loan origination. Principal and interest are paid by the participant to Voya. The loan must be

repaid within a five year period, unless the loan is used to acquire the principal residence of the borrower. The outstanding loan balance, which includes principal and any unpaid accrued interest, from Voya was \$823,893 and \$900,058 at December 31, 2024 and 2023, respectively.

These loan balances are reported as notes receivable from participants on the Statements of Net Assets Available for Benefits.

#### **Hardship Withdrawals**

Participants may not make any hardship withdrawals from the Plan.

#### **Revenue Credit Account**

The Plan and FMTC entered into a revenue sharing arrangement whereby a portion of the revenue earned from certain funds is passed through to the Plan for payment of permitted Plan expenses. In order for the Plan to receive credits as a result of this revenue sharing arrangement, and to use this credit to pay Plan expenses, the Plan created the Revenue Credit Account under the Plan. The Revenue Credit Account is a cash account within the Plan, similar in design to forfeiture accounts, and is used to record the redistribution of Plan-generated fund revenue that exceeds the costs associated with Plan administration. The Revenue Credit Account balance was \$64,977 and \$40,656 at December 31, 2024 and 2023. During 2024, \$20,694 was used to pay Plan expenses from the Revenue Credit Account.

## **2. Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The accompanying financial statements have been prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP").

#### **Use of Estimates**

The preparation of financial statements, in accordance with U.S. GAAP, requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### **Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, foreign exchange and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' accounts and the amounts reported in the Statements of Net Assets Available for Benefits.

The global and domestic economic uncertainty has resulted in significant volatility in financial markets. This volatility has affected, and may continue to affect, the value of the Plan's net assets available for benefits. The effects of economic and market conditions subsequent to December 31, 2024 are not reflected in these financial statements and future effects on the Plan's net assets available for benefits cannot be predicted.

#### **Fair Value Measurements**

The Plan follows U.S. GAAP guidance on Fair Value Measurements which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist. At December 31, 2024 and 2023, all of the Plan's investments, that were stated at fair value, were classified within level 1 of the fair value hierarchy.

#### **Investment Valuation and Income Recognition**

All of the Plan's investments are stated at fair value, except for the guaranteed investment account, which is stated at contract value. Mutual funds held by the Plan are valued at fair value based on the daily closing price as reported by the funds. All of the mutual funds are open-ended and are registered with the Securities and Exchange Commission. These mutual funds are required to publish their daily net asset value and to transact at that price. The guaranteed investment account is valued at contract value, which represents contributions made to the account, plus earnings, less participant withdrawals and administrative expenses.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued unpaid interest. If a participant ceases to make loan repayments and the plan administrator deems the loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Expenses**

Investment related fees and administrative expenses are paid by the Plan and reported in administrative expenses in the Statement of Changes in Net Assets Available for Plan Benefits.

Effective October 1, 2016, the Plan was amended to require all administrative expenses of the Plan to be paid by the Plan.

#### **Subsequent Events**

Subsequent events have been evaluated through July 30, 2025, the date the financial statements were issued.

interest income, and interest on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by FMTC and Voya, qualified institutions.

#### 4. Guaranteed Investment Account

The Voya Fixed Account (the “Account”) is a fully benefit-responsive investment contract issued by Voya. The Account is an obligation of Voya’s general account and all guarantees are based on the financial strength and claims-paying ability of Voya. The Account guarantees principal and a minimum guaranteed interest rate for the life of the contract, as well as featuring two declared interest rates: a current rate, determined at least monthly, and a guaranteed minimum floor rate declared for a defined period – currently one calendar year. The guaranteed minimum floor rate may change after the defined period, but it will never be lower than the minimum guaranteed interest rate that applies for the life of the contract. The current rate, the guaranteed minimum floor rate and the minimum guaranteed interest rate are expressed as annual effective yields. Taking the effect of compounding into account, the interest credited to a participant’s account daily yields the then current credited rate. Voya’s determination of credited interest rates reflects a number of factors, including mortality and expense risks, interest rate guarantees, the investment income earned on invested assets and the amortization of any capital gains and/or losses realized on the sale of invested assets. Under this option, Voya assumes the risk of investment gain or loss by guaranteeing the principal amount allocated to this option and promises a minimum interest rate during the accumulation period and also throughout the annuity payout period. Voya may impose limitations on the ability to transfer funds into or out of this investment option. Withdrawals from the Account for reasons other than benefits paid to participants may be subject to a market value adjustment and a surrender charge.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The Account is presented on the face of the statements of net assets available for benefits at contract value. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The plan administrator does not believe that the occurrence of any event, which would limit the Plan’s ability to transact at contract value with participants, is probable.

Voya is contractually obligated to repay the principal and the specified interest rate that is guaranteed to the Plan. The credit risk of the issuer was evaluated by nationally recognized statistical rating agencies as follows: Moody’s Investors Service (A2 as of September 2024) Standard and Poor’s (A+ as of September 2024), and Fitch (A+ as of September 2024).

#### 5. Tax Status

The Plan has been designed to qualify for tax-exempt status under Section 403(b) of the IRC. The Plan is required to operate in conformity with the IRC to maintain the tax-exempt status for plan participants under Section 403(b). The plan administrator believes that the Plan is currently designed and operating in accordance with the applicable requirements of Section 403(b) of the IRC and, therefore, believes the Plan satisfies the Internal Revenue Service’s final regulations and the related accounts are tax-exempt. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

U.S. GAAP require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

**6. Termination Provision**

Although it has not expressed any intent to do so, the Museum has the right under the Plan to discontinue its contributions at any time and to amend or terminate the Plan, subject to the provisions of ERISA. If the Plan is terminated for any reason, the rights of all participants to their accounts shall be nonforfeitable.

**7. Party-in-Interest Transactions**

Certain investments of the Plan are managed by FMTC or Voya, the custodians of the Plan. Therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statement of net asset available for benefits.
