We have performed audits of the accompanying financial statements of The Metropolitan Museum of Art 403(b) Voluntary Contribution Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. #### 1. Plan Description

##### **General**

The Metropolitan Museum of Art 403(b) Voluntary Contribution Plan (the “Plan”) is a voluntary contributory, defined contribution plan. Effective June 1, 2008, only temporary and union employees of The Metropolitan Museum of Art (the “Museum”) are permitted to make contributions to the Plan. Non-union employees who held accounts after June 1, 2008 are permitted to maintain their accounts. The original effective date of the Plan was January 1, 1975 and it has been amended and restated several times.

##### **Plan Administration**

The Museum’s Trustee Employee Benefits Committee is responsible for the general oversight of the Plan. The Museum’s Trustee Investment Committee periodically reviews investment options offered by the Plan to participants. Additionally, Fidelity Management Trust Company (“FMTC”) and Voya Retirement Insurance and Annuity Company (“Voya”) are the custodians and Fidelity Workplace Services, LLC is the recordkeeper of the Plan.

The following summary description of the Plan is provided for general information purposes only. Participants should refer to the plan documents for more complete information.

##### **Eligibility Requirements**

Union and temporary employees are currently eligible to participate in the Plan upon completion of one hour of service.

##### **Contributions**

Participants may make voluntary salary reduction contributions to the Plan subject to the limitations of the Internal Revenue Code (“IRC”). Participants may also rollover or transfer amounts representing distributions from other qualified plans. The Museum makes no contributions to the Plan.

##### **Vesting**

Participants are fully vested in their accounts at all times.

##### **Investment Options**

Participants direct the investment of their contributions into various investment options offered by the Plan. The Voya Guaranteed Investment Account was closed to new contributions and investments effective June 1, 2013. Loans taken prior to June 2, 2013 remain with Voya, any subsequent loans are offered through FMTC (refer to Notes Receivables from Participants). Current balances may remain with Voya, but no future contributions can move into the account. If an employee does not elect an allocation between the funds available, their contributions will be invested in the Qualified Default Investment Alternative designated by the Museum which is the Vanguard Institutional Target Retirement Date Fund. The fund chosen will be the target date fund closest to the employee’s 65th birthday.

##### **Participant Accounts**

Each participant account is credited with the participant’s contribution and Plan earnings and charged with investment losses, fees and withdrawals. Allocations are based on participant earnings (losses), account balances, or specific participant transactions, as defined.

#### **Benefit Payments**

A participant's benefits become payable on termination of employment (including due to retirement, resignation, dismissal, death or disability). The participant or beneficiary may elect to rollover funds into an eligible retirement plan, receive a lump-sum distribution equal to the value of his or her account, or receive an annuity to be paid in monthly installments over a fixed reasonable period of time, not to exceed the life expectancy of the participant and/or designated beneficiary. A participant may also elect to leave the account in the Plan where it is subject to minimum distributions upon the later of retirement or age 73.

#### **Notes Receivable from Participants**

Participants may borrow a minimum amount of \$1,000 up to a maximum amount of \$50,000 from the participant's employee contribution balance, subject to certain restrictions. Loans used to purchase a primary residence may be repaid over twenty years; however loans for all other purposes must be repaid within five years.

Loans are provided by FMTC directly from a participant's account. Adequate security of 100% is required for the full amount of the loan and a portion of the participant's employee contribution account is reserved and held as collateral which covers the outstanding loan and interest in the event of default. For all Plan loans, interest and principal is paid by the participant to FMTC. The interest rates are determined as Prime Rate plus 1 percent. The outstanding loan balance, which includes principal and any unpaid accrued interest, from FMTC at December 31, 2024 and 2023 was \$256,277 and \$249,907, respectively.

Loans were provided by Voya to participants prior to June 3, 2013. The Plan offered a loan feature whereby a participant enrolled in the Plan may borrow a minimum amount of \$1,000 up to a maximum of 50% of his or her vested account balance or \$50,000, whichever is less. Loan transactions are treated as a transfer from the investment fund or to the loan fund. Loans are collateralized by the balance in the participant's account and bear interest as determined at the time of loan origination. Principal and interest are paid by the participant to Voya. The loan must be repaid within a five year period, unless the loan is used to acquire the principal residence of the borrower. The outstanding loan balance, which includes principal and any unpaid accrued interest, from Voya was \$180,933 and \$184,529 at December 31, 2024 and 2023, respectively.

These loan balances are reported as notes receivable from participants on the Statements of Net Assets Available for Benefits. Related fees are recorded as administrative expenses and are expensed when they are incurred.

#### **Hardship Withdrawals**

Withdrawals are generally not permitted by employees under age 59 1/2 years of age. However, under certain conditions, participants under 59 1/2 years of age, while still employed by the Museum, are permitted to withdraw, in a single sum, the vested contribution portion of their account balance. No withdrawal shall be for \$500 or less. Withdrawals are only permitted for financial hardship, including, unreimbursed medical expenses, the purchase of the participant's principal residence, the payment of post-secondary education tuition and related costs, the payment of burial or funeral costs of immediate family members, the payment for any expenses or losses incurred as a result of a disaster declared by the Federal Emergency Management Agency ("FEMA") to the participant's principal residence, to prevent eviction or foreclosure from the participant's principal residence or such financial needs as may be specifically promulgated by the Internal Revenue Service.

#### **Revenue Credit Account**

The Plan and FMTC entered into a revenue sharing arrangement whereby a portion of the revenue earned from certain funds is passed through to the Plan for payment of permitted Plan expenses. In order for the Plan to receive credits as a result of this revenue sharing arrangement, and to use this credit to pay Plan expenses, the Plan created the Revenue Credit Account under the Plan. The Revenue Credit Account is a cash account within the Plan, similar in design to forfeiture accounts, and is used to record the redistribution of plan-generated fund revenue that exceeds the costs associated with Plan administration. The Revenue Credit Account balance was \$13,129 and \$8,061 at December 31, 2024 and 2023. During 2024, none were used to pay Plan expenses from the Revenue Credit Account.

## **2. Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The accompanying financial statements have been prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP").

#### **Use of Estimates**

The preparation of financial statements, in accordance with U.S. GAAP, requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### **Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, foreign exchange, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' accounts and the amounts reported in the Statements of Net Assets Available for Benefits.

The global and domestic economic uncertainty has resulted in significant volatility in financial markets. This volatility has affected, and may continue to affect, the value of the Plan's net assets available for benefits. The effects of economic and market conditions subsequent to December 31, 2024 are not reflected in these financial statements and future effects on the Plan's net assets available for benefits cannot be predicted.

#### **Fair Value Measurements**

The Plan follows U.S. GAAP guidance on Fair Value Measurements which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist. At December 31, 2024 and 2023, all of

the Plan's investments, that were stated at fair value, were classified within level 1 of the fair value hierarchy.

#### **Investment Valuation and Income Recognition**

All of the Plan's investments are stated at fair value, except for the guaranteed investment account, which is stated at contract value. Mutual funds held by the Plan are valued at fair value based on the daily closing price as reported by the funds. All of the mutual funds are open-ended and are registered with the Securities and Exchange Commission. These mutual funds are required to publish their daily net asset value and to transact at that price. The guaranteed investment account is valued at contract value, which represents contributions made to the account, plus earnings, less participant withdrawals and administrative expenses.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued unpaid interest. If a participant ceases to make loan repayments and the plan administrator deems the loan to be in default, the participant loan balance is reduced and a benefit payment is recorded upon a distributable event.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Expenses**

Investment related fees and administrative expenses are paid by the Plan and reported in administrative expenses in the Statement of Changes in Net Assets Available for Benefits.

#### **Subsequent Events**

Subsequent events have been evaluated through July 30, 2025, the date the financial statements were available to be issued.

### **3. Information Certified (Unaudited)**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required Schedule H, Line 4i – Schedule of Assets (Held at End of Year) including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in value of investments, dividend income, interest income, and interest on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by FMTC and Voya, qualified institutions.

### **4. Guaranteed Investment Account**

The Voya Fixed Account (the "Account") is a fully benefit-responsive investment contract issued by Voya. The Account is an obligation of Voya's general account and all guarantees are based on the financial strength and claims-paying ability of Voya. The Account guarantees principal and a minimum guaranteed interest rate for the life of the contract, as well as featuring two declared

interest rates: a current rate, determined at least monthly, and a guaranteed minimum floor rate declared for a defined period – currently one calendar year. The guaranteed minimum floor rate may change after the defined period, but it will never be lower than the minimum guaranteed interest rate that applies for the life of the contract. The current rate, the guaranteed minimum floor rate and the minimum guaranteed interest rate are expressed as annual effective yields. Taking the effect of compounding into account, the interest credited to a participant's account daily yields the then current credited rate. Voya's determination of credited interest rates reflects a number of factors, including mortality and expense risks, interest rate guarantees, the investment income earned on invested assets and the amortization of any capital gains and/or losses realized on the sale of invested assets. Under this option, Voya assumes the risk of investment gain or loss by guaranteeing the principal amount allocated to this option and promises a minimum interest rate during the accumulation period and also throughout the annuity payout period. Voya may impose limitations on the ability to transfer funds into or out of this investment option. Withdrawals from the Account for reasons other than benefits paid to participants may be subject to a market value adjustment and a surrender charge.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The Account is presented on the face of the statements of net assets available for benefits at contract value. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The plan administrator does not believe that the occurrence of any event, which would limit the Plan's ability to transact at contract value with participants, is probable.

Voya is contractually obligated to repay the principal and the specified interest rate that is guaranteed to the Plan. The credit risk of the issuer was evaluated by nationally recognized statistical rating agencies as follows: Moody's Investors Service (A2 as of September 2024), Standard and Poor's (A+ as of September 2024), and Fitch (A+ as of September 2024).

#### **5. Tax Status**

The Plan has been designed to qualify for tax-exempt status under Section 403(b) of the IRC. The Plan is required to operate in conformity with the IRC to maintain the tax-exempt status for plan participants under Section 403(b). The plan administrator believes that the Plan is currently designed and operating in accordance with the applicable requirements of Section 403(b) of the IRC and, therefore, believes the Plan satisfies the Internal Revenue Service's final regulations and the related accounts are tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

#### **6. Termination Provision**

Although it has not expressed any intent to do so, the Museum has the right under the Plan to amend or terminate the Plan at any time, subject to the provisions of ERISA.

**7. Party-in-Interest Transactions**

Certain investments of the Plan are managed by FMTC or Voya, the custodians of the Plan. Therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.
