### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Saturn of St. Paul Salary Deferral 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). **NOTE 1 PLAN DESCRIPTION**

The following description of the Saturn of St. Paul Salary Deferral 401(k) Profit Sharing Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a multiple-employer defined contribution plan covering substantially all employees of White Bear Autos, LLC., Inver Grove Autos, LLC., and Rydell Auto Outlet and Garage, LLC (collectively, "the Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan is administered by a committee appointed by the Company. A Third Party Administrator serves as the trustee of the plan, maintains records of the participant data and holds the Plan assets.

**Eligibility**

Employees who have attained the age of 18 years and completed one month of service are eligible to defer into the plan. In order to be eligible to receive the corresponding discretionary Company matching contribution and the additional Company nonelective discretionary contribution, the employee must complete 1,000 hours of service during a 12-month period immediately following their date of hire or in any subsequent calendar year if 1,000 hours are not met during the initial 12-month period. Once the eligibility requirements have been satisfied, an employee may enter the plan on the first day of the month coinciding with or next following.

**Contributions**

Each year, participants may contribute up to 100 percent of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan allows participants to allocate contributions between pretax and after tax (Roth 401(k)) deferrals. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). The Company has the option to provide discretionary contributions. In 2024 and 2023, the Company contributed 50 percent of the participants' salary reduction contribution for the Plan year not exceeding 4 percent of the participants' salary. Contributions are subject to certain limitations.

**Participant Accounts**

Each participant's account is credited with the participant's contribution, the Company's contributions, and an allocation of the Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. The Plan allows for participant-directed investment programs for which separate funds are maintained. The value of each participant's account is determined daily.

**Participants' Investment Options**

Participants must direct their salary deferral contributions and Company contributions, if any, to selected investments as offered by the Plan. Participants may change their investment options throughout the year by contacting Alerus.

**Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50 percent of the participant's vested account balance. Participants are limited to one outstanding loan at any point in time. Loans bear interest rates of prime plus 1 percent. Generally, loans are for a period of five years. Only loans used to aid in the purchase of a principal residence may be for a period exceeding five years. Loan proceeds are available from all sources. Principal and interest are paid ratably during the year through payroll deductions and credited to the participant's account.

**Vesting**

Participants are immediately vested in their elective contributions plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of service. A participant is 100% vested after six years of credited service.

**Payment of Benefits**

Upon retirement, termination, disability, or death, a participant or his or her beneficiary in the event of death, may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, or a series of substantially equal periodic installments. Additionally, participants may take an in-service distribution upon reaching age 59½ if they are fully vested. Upon termination, automatic distributions are required for balances of less than \$7,000. Automatic distributions above \$1,000 made without the participant's consent are rolled into an individual retirement account designated by the trustee. Generally, certain minimum distributions are required for participants who have separated from service and have reached the required minimum distribution age. The Plan permits hardship withdrawals, subject to account balance limits and applicable laws.

**Forfeitures**

Forfeitures may be used to pay administrative expenses of the Plan or to reduce employer contributions. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$0. For the years ended December 31, 2024 and 2023, the employer contributions were reduced by \$20,754 and \$12,800, respectively, from forfeited nonvested accounts.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Basis of Presentation**

The accompanying financial statements are presented in accordance with accounting principles generally accepted in the United States of America, ("GAAP"), as codified by the Financial Accounting Standards Board.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the trustee of the Plan. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are reflected on a trade date basis. Income is recorded as earned on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year and is reflected in the statements of changes in net assets available for benefits.

**Contributions**

Contributions from Plan participants and matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

**Payment of Benefits**

Benefit payments to participants are recorded when paid.

**Administrative Fees**

Several of the investment fund options are subject to investment fees based on a percentage of invested assets, as disclosed in the fund's prospectus. All such fees are charged directly against the fund's investment performance and thus are not separately disclosed in the accompanying financial statements. Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements.

**Income Taxes**

The Plan's policy is to evaluate the likelihood that its uncertain tax positions will prevail upon examination based on the extent to which those positions have substantial support within the Internal Revenue Code and Regulations, Revenue Rulings, court decisions, and other evidence.

**Excess Contributions Payable**

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 excess contributions to the applicable participants in 2025.

**NOTE 3 FAIR VALUE MEASUREMENTS**

FASB ASC Topic 820, *Fair Value Measurements*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under Topic 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:  
Quoted prices for similar assets or liabilities in active markets;  
Quoted prices for identical or similar assets or liabilities in inactive markets;  
Inputs other than quoted prices that are observable for the asset or liability;  
Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds (including money market mutual funds): Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Stable Value Collective Trust Fund: Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 4 AMENDMENT AND TERMINATION OF PLAN**

Although it has not expressed any intent to do so, the Company reserves the right at any time to amend or terminate the Plan subject to the provisions of the Plan and ERISA. If the Company terminates contributions or the Plan is terminated, all participants become fully vested.

**NOTE 5 EXEMPT TRANSACTIONS WITH PARTIES IN INTEREST**

Alerus Financial, N.A. is the trustee as defined by the plan document. As such, transactions with the trustee qualify as party-in-interest transactions. Fees paid by the Plan for trustee and recordkeeping services (net of revenue sharing) amounted to \$25,097 and \$23,734 for the years ended December 31, 2024 and 2023, respectively.

Alerus Financial N.A. receives revenue sharing from mutual fund service providers. This revenue is used to offset certain amounts owed to Alerus Financial, N.A. for recordkeeping services Alerus Retirement and Benefits provides to the Plan. For the years ended December 31, 2024 and 2023, \$25,493 and \$34,003 of revenue sharing was used to pay fees. At December 31, 2024 and 2023, unused revenue in excess of fees totaled \$7,507 and \$5,602, respectively.

**NOTE 6 INCOME TAX STATUS**

The Plan is a pre-approved plan sponsored by the trustee and adopted by the Company. The Internal Revenue Service informed the trustee by an opinion letter dated June 30, 2020, that the pre-approved plan is acceptable under section 401(a) of the Internal Revenue Code. The Plan has been amended since receiving the opinion letter, however, the Company and plan administrator believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and the Plan continues to be tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken a significant uncertain tax position that more likely than not would not be sustained upon examination by taxing authorities. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

**NOTE 9 NON-EXEMPT TRANSACTIONS**

During 2024, the Company failed to timely remit to the Plan withheld employee contributions in the aggregate amount of \$1,018 in accordance with the plan asset provisions of the Department of Labor (“DOL”) Regulation 2510.3-102, resulting in prohibited, or nonexempt transactions. The accompanying Schedule of Delinquent Participant Contributions discloses these transactions in accordance with the DOL’s Rule and Regulations for Reporting and Disclosure under ERISA. The Company is in the process of calculating the required corrections to the Plan to reflect foregone earnings that would have been credited to the participants’ accounts if the late remittances had been made on a timely basis.

**NOTE 10 SUBSEQUENT EVENTS**

No significant events occurred subsequent to the Plan’s year end. Subsequent events have been evaluated through July 11, 2025, which is the date these financial statements were available to be issued.
