NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

NOTE A - DESCRIPTION OF PLAN

The following description of the 401(k) Retirement Plan for Employees of Mather (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan covers all employees age 21 and over of Mather (Mather; Mather Institute, LLC; Mather Community Initiatives, LLC; Wilmette Affiliate, LLC; Georgian Affiliate, LLC; Pavilion Affiliate, LLC; Hinman-Davis, LLC; Virginia Mather Management, LLC and Tucson Mather Management, LLC) (collectively, the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

The Plan has safe harbor employer matching contributions. Upon eligibility, employees are automatically enrolled at a 5% pre-tax salary deferral with an automatic annual increase of 1%, not to exceed 15%. The Company will not increase a participant's deferral percentage if the employee has made a change to this deferral percentage, opted out, or if the employee has taken a hardship withdrawal. Participants can change their deferral percentages or elect not to make deferrals to the Plan at any time.

Eligibility

Employees are eligible to participate and to receive matching employer contributions immediately upon hire if they are age 21 or over. Employees are also eligible to receive a non-elective employer contribution if they are 21 or over, have been paid during the Plan year, and are employed as of the last day of the Plan year or are permanently disabled or terminated from service on or after attaining normal retirement age.

Contributions

Participants may contribute up to 75% of eligible compensation, as defined by the Plan and subject to Internal Revenue Service ("IRS") contribution maximums. Participants may elect to have all or a portion of their deferrals contributed to a Roth investment option. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also make rollover contributions to the Plan. Employer safe harbor matching contributions by the Company are non-elective. The Company will contribute an amount equal to 100% of up to and including 3% of the active participant's compensation contributed to the Plan, plus an additional 50% for the next 2% of the active participant's compensation contributed to the Plan. In addition, the Company provides an additional non-elective contribution equal to 3% of eligible compensation for eligible employees who were employed on December 31 of the Plan year. Non-elective contributions of \$993,178 and \$850,229 were contributed for 2024 and 2023, respectively. Contributions are subject to certain compensation limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's safe harbor matching contributions, the additional non-elective contribution, the additional supplemental contribution, if any, and an allocation of plan earnings (losses). Allocations of plan earnings (losses) are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is limited to the participant's vested account balance.

Investment Options

Participants may direct the investments of their accounts among the various investment funds provided under the Plan. Participants may change their investment selections in accordance with the rules established by the Plan Administrator.

Vesting

A year of service is earned when an employee is credited with at least 1,000 hours of service during the Plan year. All participants are immediately vested in their contributions plus actual earnings (losses) thereon.

All participants vest 100% in employer contributions after completing two years of service. Regardless of the foregoing, a participant becomes fully vested upon the occurrence of certain specified events, including attainment of age 65, death or permanent disability.

Notes Receivable from Participants

Participants may borrow from their vested account balances the lesser of 50% or \$50,000. The minimum loan amount for the Plan is \$1,000. Loans are secured by the participant's account balance. Participants may have one outstanding loan at a time. All loans shall bear interest at prime plus 1%. The terms of the loan may be up to five years, or 30 years if the loan is for the purchase of a primary residence. Principal and interest are automatically paid through payroll deductions.

Payment of Benefits

Upon termination of service by retirement, death, disability or termination from the Company, a participant may receive a lump-sum amount equal to the vested value of his or her account or can roll the vested amount over into another qualified plan or individual retirement account. In-service and hardship withdrawals are permitted under the Plan in certain circumstances.

Forfeitures

Forfeitures are used to reduce employer contributions. Forfeitures of \$96,043 and \$42,974 were used to reduce employer contributions during 2024 and 2023, respectively. At December 31, 2024 and 2023, forfeited accounts totaled \$151,077 and \$73,835, respectively.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Delinquent loans are reclassified as distributions based on the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Expenses of the Plan

All expenses of maintaining the Plan are paid by the Company. Expenses specific to processing notes receivable from participants are charged against participant accounts. Investment fees incurred are deducted from investment earnings, which are allocated to participant accounts.

NOTE C - FAIR VALUE MEASUREMENTS

The financial instruments recorded at fair value were measured and reported at fair value using a three-level hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. Classification of assets and liabilities within the fair value hierarchy considers the markets in which the financial instruments were traded and the reliability and transparency of the assumptions used to determine fair value. Level 1 financial instruments consist of investments, the values of which are based on quoted market prices for identical investments in an active market. Level 2 financial instruments are valued using models or other valuation methodologies. These models use inputs that are observable, either directly or indirectly. Level 3 financial instruments are valued using pricing models that utilize significant inputs that are primarily unobservable, and also include instruments for which the determination of fair value requires significant management judgment or estimation.

In determining fair value, the Plan uses various methods, including market, income and cost approaches. Based on these approaches, the Plan utilizes certain assumptions that market participants would use in pricing the asset or liability, including assumptions about risk inherent in the inputs to the valuation technique. These inputs can be readily observable, market corroborated or generally unobservable inputs.

The following is a description of the valuation methodologies used to measure assets at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds - Valued at the quoted NAV of shares held by the Plan at year end.

Commingled Funds - Valued using the NAV provided by the administrator of the fund as a practical expedient for fair value. The NAV is based on the value of the underlying assets owned by the fund, minus liabilities, and then divided by the number of shares/units held by the Plan at year end. The NAV is quoted on a private market and the underlying assets owned by the fund are traded on public markets. Were the Plan to initiate a full redemption of a commingled fund, the investment advisor generally reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. Participant redemption is permitted daily.

NOTE D - RELATED-PARTY TRANSACTIONS

Certain plan investments are managed by Principal, the recordkeeper and trustee of the Plan. Therefore, these transactions qualify as party-in-interest transactions.

Notes receivable from participants are also considered party-in-interest transactions.

NOTE E - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

NOTE F - TAX STATUS

The Plan obtained its latest determination letter on June 30, 2020. The Plan has been amended since submission for the updated determination letter. However, the Plan Administrator and the Plan's ERISA counsel believe that the Plan is designed and is currently being operated in all material respects in compliance with the applicable requirements of the Internal Revenue Code.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE G - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE H - INFORMATION CERTIFIED BY THE TRUSTEE

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Delaware Charter Guarantee & Trust Company, doing business as Principal
