## Alarm.com 401(k) Plan

### Notes to Financial Statements

- 1. Description of the Plan** The following description of the Alarm.com 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan covering substantially all employees of Alarm.com Holdings, Inc. and its affiliates (collectively, the "Company"), except for nonresident aliens, employees covered by a collective bargaining agreement, leased employees, independent contractors, and interns. The Plan was amended effective April 1, 2024 to include Shooter Detection Systems, LLC and All Aware, LLC as adopting employers of the Plan. Effective October 1, 2024, the Plan was amended to provide for the merger of Shooter Detection Systems LLC 401(k) Profit Sharing Plan and Trust. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

**Contributions:** Each year, participants may contribute up to 100 percent of pretax annual compensation, as defined in the Plan. Roth contributions are also permitted. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). The Plan provides for automatic enrollment. Any newly eligible employee who has not affirmatively elected to contribute to the Plan or has not affirmatively declined to participate in the Plan will be automatically enrolled in the Plan with a three percent withholding of pretax annual compensation. The Plan allows for discretionary matching contributions. During 2024, the Company contributed a discretionary matching contribution of 100 percent of the first ten percent of compensation that a participant contributed to the Plan up to a maximum of \$5,000. Additional contributions may be contributed at the discretion of the Company. Participants must be active on the last day of the Plan year or complete more than 500 hours of service during the Plan year to receive an allocation of any additional discretionary Company contributions. No such contributions were made during 2024. Participants direct the investment of their contributions and Company contributions into various investment options offered by the Plan. Contributions are subject to certain limitations.

### Notes to Financial Statements

---

**Participant accounts:** Each participant's account is credited with the participant's contributions, the Company's discretionary matching contributions, if any, as well as allocations of the Company's discretionary additional contribution, if any, and Plan earnings. Participant accounts may also be charged with an allocation of certain administrative expenses. Investment earnings and losses are allocated based upon the investment performance of each investment in the participant's account. Allocations of the Company's discretionary additional contributions, if any, are based on the ratio of the participant's eligible compensation to total eligible compensation for the Plan year. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting:** Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company discretionary contributions is based on years of continuous service. A participant is 25 percent vested after one year of service is completed, and vests an additional 25 percent per year until full vesting after four years. Different vesting schedules may apply to account balances of participants due to prior Plan provisions as described in the Plan document.

**Payment of benefits:** Benefits are payable upon retirement at age 65, disability, death, or termination of employment. Hardship withdrawals and in-service withdrawals at age 59 1/2 are also permitted, subject to provisions described in the Plan document. Withdrawals from rollover contributions are permitted at any time. Benefits are payable in lump sum, installments and various annuity payments.

**Forfeited accounts:** At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$24,496 and \$5,200, respectively. These accounts will be used to reduce future Company contributions or to pay Plan expenses. During 2024, \$606,874 of forfeited nonvested accounts was used to reduce Company contributions and \$163,435 was used to pay Plan expenses related to the 2024 Plan year.

**Notes receivable from participants:** Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50 percent of their vested account balance. Loan terms range up to five years. The loans are secured by the balance in the participant's account and bear interest at a reasonable rate to that offered by lending institutions. Principal and interest are paid through payroll deductions.

**Administrative expenses:** Certain expenses of maintaining the Plan are paid by the Company. Transaction expenses, such as loan and distribution administration fees, are charged directly to the participant's account and are included in administrative expenses. Participants are also charged an asset based fee for recordkeeping, administrative and investment advisory services. These fees are included in administrative expenses.

#### 2. Significant accounting policies

**Basis of accounting:** The financial statements of the Plan are prepared under the accrual method of accounting.

**Investment valuation and income recognition:** Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes receivable from participants:** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent loans are reclassified as distributions based upon the terms of the Plan document.

**Contributions:** Participant contributions and the related Company discretionary matching contributions are recognized in the period the participant contribution is withheld from compensation. Company additional discretionary contributions, if any, are recognized in the period the related eligible compensation is paid to the participant.

**Payment of benefits:** Benefits are recorded when paid.

**Use of estimates:** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("US GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Subsequent events:** The Plan has evaluated subsequent events for disclosure in these financial statements through July 29, 2025, which is the date the financial statements were available to be issued.

**3. Certified information**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividend income for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Life Insurance Company ("Principal"), on behalf of itself and acting for Principal Global Investors Trust Company and Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, the insurance company and custodian, respectively, of the Plan.

**4. Fair value measurements**

The Plan reports its assets at fair value based on a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1. Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2. Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3. Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The fair value of the shares of mutual funds owned by the Plan is based on quoted net asset values on the last business day of the Plan year.

The fair value of the units of pooled separate accounts is based on the net asset value (“NAV”) on the last business day of the Plan year provided by the entity holding the accounts. The NAV is used as a practical expedient to estimate fair value and is determined by the insurance company and custodian based on the fair value of the underlying assets in the account, less the liabilities.

The fair value of the collective trust funds is based on the NAV on the last business day of the Plan year provided by the entity holding the trust funds. The NAV of the collective trust is used as a practical expedient to estimate fair value and is determined by the insurance company and custodian based on the fair value of underlying assets in the trust, less its liabilities.

Withdrawals from the collective trust funds of Great Gray Collective Investment Trust initiated by the Company require five business days notice for any withdrawals exceeding \$1,000,000. Additionally, withdrawals from the Great Gray Core Plus Bond Fund Class I1 and Great Gray Small Cap Value Fund II Class I1 initiated by the Company require five business days notice for any withdrawals exceeding 10 percent of the assets invested in the fund. There are no other withdrawal limits, redemption frequency limits or redemption notice periods. There were no unfunded commitments for these investments as of December 31, 2024 and 2023.

#### 5. Risks and uncertainties

The Plan provides for investments in various securities that are exposed to risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in future statements of net assets available for benefits.

- 6. Plan termination** Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.
- 7. Tax status** The Plan is a pre-approved defined contribution plan of Principal, which received an opinion letter on June 30, 2020, in which the Internal Revenue Service ("IRS") stated that the form of the plan document was acceptable under the applicable requirements of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.
- US GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
- 8. Party-in-interest transactions** Certain Plan investments are managed by affiliates of Principal. Principal is the insurance company, custodian and recordkeeper as defined by the Plan. Fees paid by the Plan to the investment advisors and Principal were \$214,276 for the year ended December 31, 2024. These transactions qualify as exempt party-in-interest transactions.
