## INDEPENDENT AUDITOR'S REPORT

To the Participants, Trustee and ESOP Advisory Committee

### **Opinion**

We have audited the accompanying financial statements of Braun Intertec ESOP Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of the Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the years ended, in accordance with accounting principles generally accepted in the United States of America.

### **Basis for Opinion**

Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audit.

### **Supplemental Schedule Required by ERISA**

Our audits were conducted for the purpose of forming an opinion on the financial statements as a whole. The supplemental schedule, Schedule 1, as of December 31, 2024 is presented for purpose of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of the Plan's management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedule is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**Note 1 DESCRIPTION OF THE PLAN**

The following brief description of the Braun Intertec ESOP Retirement Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for complete information.

**GENERAL**

The Plan is a defined contribution retirement plan whose purpose is to reward eligible employees for long and loyal service by providing them with retirement benefits most of which are through a beneficial interest in Braun Intertec Corporation and subsidiaries (collectively the Company), in order that the participants may share in the Company's growth and prosperity. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), and is administered by the Company.

Braun Intertec Corporation (the Company) established the Braun Intertec Stock Ownership Plan (the Plan) effective as of January 1, 1995. From 1995 through 1999, the Plan had only an employee stock ownership feature. Effective January 1, 2000, the net assets of the Braun Intertec Corporation Restated Retirement and Profit Sharing Plan (Retirement Plan) were merged into the Plan, and the Plan name was changed. As a result of this merger, the Plan had 401(k), Profit Sharing and employee stock ownership plan features (hereinafter separately referred to as 401(k), Profit Sharing, and Stock Bonus). The Plan's Stock Bonus feature was designed to be an employee stock ownership plan. These features were effective from 2000 through 2006.

Effective January 1, 2007, the Plan was amended and restated and substantially all of the non-Company stock assets of the Plan were transferred to a separate 401(k) and profit sharing defined contribution plan. Effective January 1, 2010 the Plan was again restated, which resulted in an increased payment term for certain Elective Account distributions. There were no other significant changes to the restated Plan document. Since 2007, the Plan operates, in relevant parts, as an employee stock ownership plan (ESOP), the ESOP is designed to comply with Section 4975 (e)(7) and the regulations thereunder of the Internal Revenue Code of 1986, as amended, and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). Effective January 1, 2014, the Plan was amended to make certain additional participants eligible for forfeiture and contribution allocations regardless of employment on the last day of the year. Effective January 1, 2016, the Plan was formally amended and restated to conform to currently enacted provisions of the IRC. The Plan is administered by the ESOP Advisory Committee, which is appointed by the Company's Board of Directors. The trust department of an independent third party bank is the Plan's trustee. Participants do not direct the investment of their accounts under the Plan.

Assets of the Plan are now held in two primary classifications: Directive Accounts, which include account balances representing the employee stock ownership (ESOP) feature of the Plan, and Elective Accounts, which include Company stock directed to the participants' accounts through the Plan's former Profit Sharing provisions, previous purchases of Company stock within the Plan's former 401(k) features, or one-time elections to transfer funds from the current 401(k) plan to invest in Company stock. During December 31, 2024, all contributions were deposited into Directive Accounts.

**ELIGIBILITY**

Employees of the Company are generally eligible to participate in the Plan after reaching age 18 with six months of service, providing they worked at least 500 hours during such Plan year. Participants who do not have at least 1,000 hours of service during such Plan year or are not employed on the last working day of a Plan year are generally not eligible for an allocation of Company contributions for such year.

**EMPLOYER CONTRIBUTIONS**

The Company has established an Employee Stock Ownership Trust (the Trust) to which discretionary contributions are made as determined by the Company's Board of Directors. Generally, participating employees are not permitted to make contributions to the Trust. Only eligible participants who are employed on the last day of the Plan year, seasonal employees, and employees on an authorized leave of absence are eligible to share in contributions for the year. An eligible employee's share of any discretionary contribution will be determined based on the proportion of the employee's compensation to the total compensation of all eligible employees and are allocated to the employees Directive Account. For the Plan years ended December 31, 2024 and 2023, the Company elected not to make a discretionary stock contribution to the Plan. The contributions for the Plan years ended December 31, 2024 and 2023 consisted of cash contributions by the Company.

**PAYMENT OF BENEFITS**

Distributions from the Plan will be made upon participant retirement, death (in which case, payment shall be made to his or her beneficiary or if none, his or her legal representatives), permanent disability, or termination of employment with the Company. When a participant withdraws from the Plan, the Plan is obligated to distribute the vested value of the participant's account, either in a lump-sum cash payment, installments over a certain period of time, or equivalent shares of stock (generally at the discretion of the Plan's administrator), subject to the distribution and other restrictions contained within the Plan documents. Any distribution in the form of stock shall be subject to an automatic and immediate put option giving the Company the right of first refusal. Certain mandatory distribution provisions may apply for small account balances of terminated employees. In-service distributions of participant Elective Accounts are allowed for participants reaching the age 59½ who are 100 percent vested in such Elective Accounts.

**ADMINISTRATIVE EXPENSES**

As provided in the Plan agreement, administrative expenses may be paid by either the Plan or by the Company. Currently, the Company pays a majority of the administrative expenses.

**VOTING RIGHTS**

Each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account and is notified by the Trustee prior to the time that such rights are to be exercised. The Trustee is not permitted to vote any allocated share for which instructions have not been given by a participant. The Trustee is required, however, to vote any unallocated shares on behalf of the collective best interests of Plan participants and beneficiaries.

**PARTICIPANT ACCOUNTS**

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited as of the last day of each Plan year with an allocation of the Company's contributions, plan earnings or losses, and forfeitures of terminated participants' non-vested accounts. Only those participants who are eligible employees of the Company as of the last day of the Plan year will receive an allocation. Allocations are based on a participant's eligible compensation, relative to total eligible compensation. Plan earnings are allocated to each participant's account based on the ratio of the participant's account balance.

**VESTING**

If a participant’s employment ends for any reason other than retirement, permanent disability, or death, he or she will vest in the balances in his or her account based on total years of service with the Company. Participants begin to vest at 5 percent after one year of service and are 100 percent vested after six years of service.

**PUT OPTION**

Under federal income tax regulations, the employer stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the current value of the stock. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

**DIVERSIFICATION – DIRECTIVE ACCOUNTS**

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company stock into investments which are more diversified. Participants between the ages of 55 to 59 with at least 10 years of participation in the Plan may elect to diversify up to 25 percent of the total shares of Company Stock ever deposited into the participant’s Directive Account, and upon attaining age 60, these qualified participants may elect to diversify up to 50 percent of total shares ever deposited in their Directive Account. Additionally, such shares may be distributed and immediately repurchased by the Company. Provisions allow the Company the option to use discretionary Plan contributions or other Plan investment assets to fund this obligation and redistribute the related shares to remaining participants within the Directive Accounts. The value of such diversification elections from the Directive Accounts was \$4,030,508 (12,722 shares) and \$3,887,805 (13,148 shares) in 2024 and 2023, respectively. In 2024 and 2023, none of the 12,722 and 13,148 shares, respectively, were redeemed and retired by the Company.

**DIVERSIFICATION – ELECTIVE ACCOUNTS**

Terms of the Plan provide an annual diversification opportunity for participants to individually elect to have the Company repurchase a portion of the shares held in their respective Elective Accounts at the stock’s then current fair value. Plan provisions also allow the Company an option to use discretionary plan contributions or other Plan investment assets to fund this obligation and redistribute the related shares to remaining participants within the Directive Accounts. In addition, participants whose employment has terminated have the right to liquidate the stock held in their Elective Account.

FORFEITURES

Forfeitures are created when participants terminate employment before becoming fully vested in the Plan. The non-vested portion remains in the individual participant account until after 5 consecutive one-year breaks in service, at which time the forfeited balance is allocated to active participants in the same manner as employer contributions. Forfeitures allocated to remaining participants were \$0 and 1,039 shares for the year ended December 31, 2024, and \$0 and 540 shares for the year ended December 31, 2023.

**Note 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

BASIS OF ACCOUNTING

The financial statements of the Plan are prepared on the accrual basis of accounting.

FINANCIAL STATEMENT PRESENTATION

The Plan presents the participant accounts separately, as either Directive Accounts or Elective Accounts for the respective assets and liabilities and changes therein. The Directive Accounts classification includes a further breakdown for the related assets and liabilities and changes therein as follows:

- Allocated – Includes the accounts of employees with vested rights in allocated stock.
- Unallocated – Includes stock not yet allocated to employees, which provides collateral on Plan notes payable, if applicable. The Plan's investment in Company stock is fully allocated.

USE OF ESTIMATES

The preparation of financial statements in accordance with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

INVESTMENT VALUATION AND INCOME RECOGNITION

The Plan's investments are reported at fair value. See Note 5 for a discussion of the fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Realized gains and losses from security transactions are reported on the average cost method. Net appreciation includes the Plan's gains and losses on investments bought and held during the year.

SUBSEQUENT EVENTS

Plan management has evaluated subsequent events through July 30, 2025, the date the financial statements were available to be issued.

**Note 3 ADMINISTRATION OF PLAN ASSETS**

The Company administers the Plan, and the trustee, who is appointed by the Company’s Board of Directors, invests and controls Plan assets. The Company’s Board of Directors also appoints an ESOP Advisory Committee, made up of Company employees, to direct the investment of trust assets by the trustee, to direct the trustee on voting the shares of Company stock, and to oversee the administration of the Plan on behalf of the Company. Copies of the Plan’s legal documents are available for inspection at the Company’s business office.

**Note 4 INVESTMENTS**

**Note 5 FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1- Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2- Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets,
- Quoted prices for identical or similar assets or liabilities in inactive markets,
- Inputs other than quoted prices that are observable for the asset or liability,
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3- Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Note 7    RISKS AND UNCERTAINTIES**

The Plan investments consist primarily of the Company's common stock, which is exposed to various risks, such as interest rate, market, and credit risks, as well as valuation assumptions based on earnings, cash flows, and other such techniques. Due to the level of risk associated with the investment in the common stock and to uncertainties inherent in estimates and assumptions, it is at least reasonably possible that changes in the value of the common stock will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

**Note 8    PLAN TERMINATION**

The Company reserves the right to terminate the Plan at any time, subject to Plan provisions. Upon termination of the Plan, the Braun Intertec Retirement Plan ESOP Advisory Committee directs the Trustee to pay all liabilities and expenses of the ESOP. Subsequently, the interest of each participant in the trust fund will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan terms and the IRC.

**Note 9    TAX STATUS**

The Plan has received a determination letter from the IRS dated August 26, 2016, stating that the Plan is qualified under the IRC and, therefore, the related trust is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan has been amended since receiving the determination letter. However, the Plan administrator believes that the Plan is currently designed, and being operated, in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken as significant uncertain position that more likely than not would not be sustained upon examination by applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
