**1. Description of Plan**

The following description of the Areté Associates (“Company”) 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering all employees of the Company who are 18 years of age or older, who are neither leased nor subject to a collective bargaining agreement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Investment Options**

Upon enrollment in the Plan, a participant may direct contributions to be invested in specified mutual funds or an investment contract.

**Contributions**

Participants may elect to contribute a portion of their compensation up to a maximum percentage, as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various mutual funds and an investment contract offered by the Plan. The Company contributes 5% of a participant's eligible compensation to the Plan.

**Participant Accounts**

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and, (b) Plan earnings (losses), and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately vested in their contributions and earnings on those contributions. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant who is hired prior to January 1, 2019 is 100% vested after two years of credited service. A participant who is hired on or after January 1, 2019 is 100% vested after four years of credited service. In addition, for terminations on account of death, disability, or normal retirement at age 65, 100% vesting is granted.

**Notes Receivable from Participants (Participant Loans)**

Participants may borrow from their accounts a minimum of \$500 up to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at rates ranging from 5.25% to 10.50%. Principal and interest is paid ratably through payroll deductions. Loans to participants are valued at the principal amounts outstanding.

**1. Description of Plan (continued)**

**Payment of Benefits**

On termination of service due to death, disability or retirement, a participant may elect to receive a lump-sum amount, periodic installments or a paid-up annuity contract equal to the value of the participant's vested balance. Benefits are recorded when paid.

**Forfeited Accounts**

Forfeitures of terminated participants' non-vested accounts are transferred to and maintained in a single Forfeiture Account, which is invested in interest-bearing deposits. This account is used to reduce future contributions from the plan sponsor. The Forfeiture Account balance as of December 31, 2023, was \$61,440. No forfeitures were used to offset contributions from the plan sponsor during the year ended December 31, 2024.

**2. Summary of Significant Accounting Policies**

**Basis of Accounting**

The financial statements of the Plan are prepared under the accrual basis of accounting and present the net assets available for benefits and the changes in net assets available for benefits.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan.

**Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

**Operating Expenses**

All significant expenses of maintaining the Plan are paid by the Company.

**Date of Management's Review**

The plan administrator has evaluated the impact of all subsequent events through July 29, 2025, which was the date the financial statements were available to be issued, and has determined that no subsequent events require recognition or disclosure in the financial statements.

**3. Tax Status**

The Plan adopted the T. Rowe Price Prototype plan effective January 1, 2022. The prototype plan documents have been approved by the Internal Revenue Service. The Plan has been amended since receiving the determination letter. However, the Plan administrator and the Company believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

**4. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**5. Certification of Assets**

T. Rowe Price Trust Company ("T. Rowe Price") serves as the trustee and custodian of the Plan's assets. In that capacity, T. Rowe Price holds the Plan's assets and executes investment transactions. The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulation for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA). As permitted under such election, the Plan administrator has obtained certifications from T. Rowe Price as of December 31, 2024 and 2023, and for the year ended December 31, 2024, that all investment information supplied to the Plan is complete and accurate. Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and interest, dividends and net appreciation/depreciation in fair value of investments for the year ended December 31, 2024, was obtained or derived from the certified information.

**6. Fair Value Measurements**

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in different fair value measurements at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments.

When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. No Level 3 inputs were available to the Plan, and Level 2 inputs were only used when Level 1 inputs were not available. The following table presents the Plan's assets measured at fair value on a recurring basis using quoted prices in active markets for identical assets (Level 1), significant other observable inputs (Level 2) and significant unobservable inputs (Level 3).

Gains and losses (realized and unrealized) included in changes in net assets available for benefits for the year ended December 31, 2024 are reported in net appreciation (depreciation) in fair value of investments.

**7. Investment Contract**

**Description**

The Plan's investments include the T. Rowe Price Stable Value Common Trust, which invests principally in guaranteed investment contracts (GICs), synthetic investment contracts (SICs), and other similar instruments which are intended to maintain a constant net asset value while permitting participant-initiated withdrawals.

Because the investment contract is fully benefit-responsive, contract value is the relevant measurement attribute.

The investment contract is presented on the face of the statements of net assets available for benefits as the Common Trust Fund and is reported at contract value in arriving at net assets available for benefits.

Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

**Operation**

Investment transactions are accounted for on the trade date. Income from investment contracts is recorded at the contract rate, which in the case of SICs is referred to as the crediting rate. For fully benefit responsive SICs, earnings on underlying assets are factored into the next computation of the crediting rate re-set.

These contracts have varying yields and maturity dates and are fully benefit responsive. They are stated at contract value which represents cost plus accrued income less redemptions. The fair value of the GICs has been estimated by discounting the related cash flows based on current yields of similar instruments with comparable durations. Individual assets of the SICs are valued at representative market prices. The fair value of the wrap contracts reflects the discounted present value of the difference between the current wrap contract cost and its replacement cost, based on issuer quotes.

**Limitations on Contract Value Transactions**

Certain events limit the Plan's ability to transact at contract value with the issuers of its investment contract. Such events include the following: (a) amendments to the plan documents, (b) changes to the plan's prohibition on competing investment options or deletion of equity wash provisions, or (c) termination or tax disqualification of the Plan or trust. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants are probable of occurring.

**Contract Value**

The contract value of the Common Trust Fund at December 31, 2024 and 2023, was \$9,472,572 and \$10,961,771 respectively.

**Issuer-Initiated Contract Termination**

Contract termination can result from certain breaches by the trust of its obligations, representations, or warranties with settlement at an amount which differs from contract value.

**Contract Withdrawal**

Pursuant to the declaration of trust, the Plan may withdraw from the trust with a twelve month advance written notice provided to the trustee.

**8. Party-in-Interest Transactions**

Certain Plan investments are shares of mutual funds managed by T. Rowe Price. T. Rowe Price Trust Company is the trustee of the Plan; therefore, T. Rowe Price is a party-in-interest.

Account transaction fees charged by T. Rowe Price are paid directly from Plan assets.

**9. Plan Termination**

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of the Employee Retirement Income Security Act. In the event of plan termination, participants would become 100% vested in their employer contributions.
