INDEPENDENT AUDITOR'S REPORT

To the Administrative Board of
Air Line Pilots Association, International Pilot Welfare Benefit Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Air Line Pilots Association, International Pilot Welfare Benefit Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits - modified cash basis as of October 31, 2024 and 2023, and the related statements of changes in net assets available for benefits - modified cash basis for the years then ended, and the related notes to the financial statements - modified cash basis.

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the financial statements section of our report. We are required to be independent of the Air Line Pilots Association, International Pilot Welfare Benefit Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter - Basis of Accounting

We draw attention to Note 2 to the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting, as described in Note 2 and for determining that the modified cash basis of accounting is an acceptable basis for preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Air Line Pilots Association, International Pilot Welfare Benefit Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the Air Line Pilots Association, International Pilot Welfare Benefit Plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they could reasonably be expected to influence the economic decision of users made on the basis of these financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Air Line Pilots Association, International Pilot Welfare Benefit Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Air Line Pilots Association, International Pilot Welfare Benefit Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of the modified cash basis of accounting.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter

Supplemental Schedules Required by ERISA

The supplemental schedules, schedule H, line 4i - schedule of assets (held at end of year) as of October 31, 2024, and schedule H, line 4j - schedule of reportable transactions for the year ended October 31, 2024, are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from, and relates directly to, the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agrees to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

1. PLAN DESCRIPTION

The following brief description of the Air Line Pilots Association, International Pilot Welfare Benefit Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for a complete description of the Plan’s provisions, copies of which may be obtained from the Air Line Pilots Association, International (“ALPA”).

General

The Plan was established November 1, 1995, by ALPA, to provide monthly, long-term disability benefits to eligible participants with medical problems resulting in the loss of the medical certificates issued to them by the Federal Aviation Administration, and who consequently can no longer operate aircraft. The Plan was subsequently amended to merge with other ALPA benefit plans: Lump Sum Loss of License Disability Plan, Air Line Pilots Association Group Term Life Insurance Plan, Air Line Pilots Association 10-year Level Term Life Insurance Plan, Air Line Pilots Association 20-Year Level Term Life Policy, and Air Line Pilots Association Accidental Death and Dismemberment Plan. Effective January 1, 2015, a dental insurance program was added, and effective November 1, 2015, new critical illness and accident insurance programs were added. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

Plan Administration

ALPA is responsible for oversight of the Plan. Substantially all Plan assets are held in the Air Line Pilots Association Welfare Benefit Trust, a Voluntary Employees’ Beneficiary Association (“VEBA”) and are held by Northern Trust Company (“Northern Trust”), the Trustee of the Plan.

Benefits

The Plan provides long-term disability benefits (ALPA National Disability Plan (Base) and ALPA National Disability Plan Plus (Extended) (collectively, “monthly loss of license”) and ALPA National Disability Lump Sum Plan (“lump sum loss of license”), life insurance (group term life, 10-year level term life and 20-year level term life), accidental death and dismemberment, dental, critical illness and accident benefits.

Insured Benefits

The Plan fully insures the National Disability Plan Plus (Extended), life insurance, accidental death and dismemberment, dental, critical illness and accident benefits. The Plan purchases annual insurance contracts for these insured benefits. Premiums are paid from the assets of the Plan.

Experience-Rated Contracts

Certain insurance contracts are subject to experience-rating adjustments. Experience ratings (calculated as the difference between premiums paid and the total of claims paid and fees charged by the insurance company) are determined by the insurance company in the following year and may result in a premium surplus or deficit.

Contributions

Participants in the monthly and lump sum loss of license disability programs contribute to the respective programs (via ALPA) in the amount determined annually by ALPA for each level of coverage. Participants in the following programs make contributions (via ALPA) in amounts determined annually by the insurer for each level of coverage: group term life, 10-year level term life, 20-year level term life, accidental death and dismemberment, dental, critical illness, and accident benefits.

Administrative Expenses

Administrative expenses incurred to market, maintain, and operate the Plan are paid by the Plan, as provided in the Plan document. A portion of these expenses are paid to ALPA, as provided in the Trust Agreement.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements have been prepared on the modified cash basis of accounting; a basis of accounting other than accounting principles generally accepted in the United States of America ("U.S. GAAP"). Contributions are recognized when cash is received rather than when earned and investment and administrative expenses are recognized when paid rather than when the obligation is incurred. Group term life, 10-year term life, 20-year term life and dental insurance contracts are experience-rated contracts and experience-rating adjustments resulting in a refund/dividend are recorded when received, and therefore, amounts due to the Plan at the end of the year are not recorded as a receivable from the insurance company. Interest income is recorded on the accrual basis, dividends are recorded on the ex-dividend date, changes in fair value of investments are recognized in the period they occur, and benefits are recognized when paid, which is consistent with U.S. GAAP. The financial statements are not intended to present the Plan's net assets available for benefits and the changes in its net assets available for benefits in conformity with U.S. GAAP.

Use of Estimates

The preparation of financial statements requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and benefit obligations, and the disclosure of contingencies, at the date of the financial statements, and changes therein during the reporting period. Actual results could differ from those estimates.

Payment of Benefits

Long-term disability benefits, other than the ALPA National Disability Plan Plus (Extended), are recorded when paid by the Plan and are included in payments to insurance carrier for disability benefits on the accompanying statements of changes in net assets available for benefits – modified cash basis.

Premiums paid by the Plan are recorded as payments to insurance carrier for other benefits on the accompanying statements of changes in net assets available for benefits – modified cash basis. Premiums paid by the Plan for the ALPA National Disability Plan Plus (Extended) insured benefit, are recorded as payments to insurance carrier for other benefits on the accompanying statements of changes in net assets available for benefits – modified cash basis.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and Trustee. Purchases and sales of investments are recorded on a trade-date basis. Net appreciation (depreciation) in fair value includes the Plan's realized and unrealized gains and losses on investments bought and sold as well as held during the year.

Premium Stabilization Reserve

The Plan is required to maintain a premium stabilization reserve with an insurance company, which can be drawn against to reduce future premium payments when the total of claims paid and other charges exceed premiums paid to the insurance company. The premium stabilization reserve has been included as an asset of the Plan until such amounts are used to pay premiums. The reserve is nonforfeitable should the insurance contract terminate.

Subsequent Events

In preparing these financial statements, management of the Plan has evaluated events and transactions that occurred after October 31, 2024, for potential recognition or disclosure in the financial statements. These events and transactions were evaluated through July 29, 2025, the date that the financial statements were available to be issued, and no items have come to the attention of management that would require disclosure or recognition in the financial statements.

3. BENEFIT OBLIGATIONS

Long-Term Disability Benefits

The Plan's long-term disability benefits are insured with policies written by Metropolitan Life Insurance Company ("MetLife"). For both the monthly and lump-sum loss of license coverage, the Plan has obtained aggregate stop-loss ("ASL") coverage to limit its exposure and will receive reimbursement from the insurance company for cumulative payments in excess of the Aggregate Attachment Point, which is determined annually. For the monthly loss of license plan, the maximum reimbursement under the ASL is \$2 million per contract year. Stop loss reimbursements received are netted with payments to insurance carrier for disability premiums on the statements of changes in net assets available for benefits - modified cash basis. All payments made to the insurance company are recorded as payments to insurance carrier for disability benefits on the statements of changes in net assets available for benefits - modified cash basis. During the years ended October 31, 2024 and 2023, respectively, the Plan received no stop loss reimbursements.

Monthly Loss of License

All claims for monthly loss of license benefits are subject to a 12-month waiting period, during which the participant must be continuously disabled. Benefit payments commence after the expiration of the waiting period. Once benefit payments commence, they continue during disability for a period ranging from 12 months to 48 months, based on the claimant's age at the date of disability and disability type. Extended benefits are also available that pay 50% of the monthly benefit from the end of the base plan benefits through age 65. Age graded premiums range from \$26.50 to \$3,774.66 annually and vary by selected benefit level of \$600 to \$4,800 of disability income per month. Monthly benefits are limited to \$1,800 for any pilot whose annual salary is less than \$50,000. Pilots pay full premiums, except apprentice pilots who opt-in to the Plan and then receive one year of loss of license benefits at the \$1,200 level without paying a premium. In the first year following their apprenticeship, apprentice pilots who have opted in to the Plan pay reduced premiums of 25% of the normal rate, and 50% of the normal rate in their second coverage year. The Plan funds the discounted portion of premiums for apprentice pilots and reactivated members receiving discounts. The present value of the obligation for reported and incurred but not reported ("IBNR") benefit claims during the 12-month waiting period and claims incurred but not reported is estimated by the Plan's consulting actuary, Milliman, Inc. ("Milliman") using an interest rate of 3% for the years ended October 31, 2024 and 2023. The obligation is adjusted for any projected recoveries or ASL refunds from MetLife.

At October 31, 2024 and 2023, the total present value for reported and IBNR benefit claims is \$12,755,000 and \$8,396,000, respectively, including Milliman's estimate of the Plus claim liability of \$838,000 and \$456,000, respectively. Milliman developed assumptions for the base claim liability which is comprised of open claims and pending and IBNR claims. The following summarizes the assumptions used in the October 31, 2024 and 2023 valuations.

Open Claims

Open claims are claims that are open and in pay status as of October 31, 2024 and 2023.

As each claim is reported and approved for payment, the Plan funds MetLife on a monthly basis as benefit payments become payable to participants. During the years ended October 31, 2024 and 2023, total payments to MetLife to fund claims payable to participants was \$5,893,893 and \$5,103,667, respectively, and is included in payments to insurance carrier for disability benefits on the statements of changes in net assets available for benefits – modified cash basis.

In 2024 and 2023, the liability of open claims is calculated using claim termination rates for all claims reported by MetLife as open as of October 31, 2024 and 2023, respectively, based on the following:

At October 31, 2024 and 2023, open claims included within the total present value for reported and IBNR benefit claims was approximately \$6,819,000 and \$5,276,000, respectively.

Pending and IBNR Claims

Pending claims are claims that are either within the waiting period or awaiting additional information. IBNR claims are those that have been incurred but have yet been reported.

In 2024 and 2023, pending claims was calculated by first calculating the estimated liability using the same method and assumptions as those used for open claims and then applying a factor of 95% and 95%, respectively, representing the actuary's assumption that 95% and 95%, respectively, of pending claims will ultimately be approved for payment. The liability for IBNR claims was calculated by first using the historical claim data provided by MetLife to calculate the proportion of claims that were unreported as of each month of the plan year. The total expected claim cost for each month is calculated as the monthly premium multiplied by the expected loss ratio of 161% and 76%, respectively. The expected loss ratio is based on historical plan experience. Loss ratios are equal to claim costs divided by total premiums. Claim costs, in turn, are equal to the present value of benefit payments made through October 31, 2024 and 2023, respectively, plus the present value of expected future payments after October 31, 2024 and 2023, respectively, for any claims still open as of that date.

The expected claim cost is multiplied by the proportion of claims that are assumed to be unreported each month. The result is then summed across the 12 months in the plan year to obtain the total liability for IBNR claims.

At October 31, 2024 and 2023, pending and IBNR claims included within the total present value for reported and IBNR benefit claims was approximately \$4,606,000 and \$2,664,000, respectively.

The foregoing assumptions are based on the presumption that the Plan will continue. If it were to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the benefit obligation.

Lump Sum Loss of License

The Plan provides disability income, in a lump sum payment, to any participating pilot who loses his or her license due to medical reasons. Disability must extend beyond a 12-month waiting period for the benefit to be payable. Participating pilots may choose from several optional lump sum benefit amounts, up to the lesser of \$150,000 or 2.5 times a pilot's annual salary and pay the full premium for that level of coverage. The present value of the obligation for reported and IBNR benefit claims during the 12-month waiting period or pending final decision and claims incurred but not reported is estimated by the Plan's consulting actuary, Milliman, using an interest rate of 3% for the years ended October 31, 2024 and 2023. The obligation is adjusted for any projected individual stop-loss limit reductions and ASL refunds from MetLife.

At October 31, 2024 and 2023, the total present value for reported and IBNR benefit claims is \$1,127,000 and \$810,000, respectively. Milliman developed assumptions for pending and IBNR claims. Pending claims capture obligations for claims that are currently in the waiting period or awaiting additional information, and IBNR claims capture obligations for claims where the disability has begun but has not yet been reported.

In 2024, the liability of pending and IBNR claims is calculated based on the premiums for the 2023 - 2024 plan year and the expected loss ratio. The total premiums, multiplied by the expected loss ratio, produces the expected claim costs for the 2023 - 2024 plan year.

In 2023, the liability of pending and IBNR claims is calculated based on the premiums for the 2022 - 2023 plan year and the expected loss ratio. The total premiums, multiplied by the expected loss ratio, produces the expected claim costs for the 2022 - 2023 plan year.

The foregoing assumptions are based on the presumption that the Plan will continue. If it were to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the benefit obligation.

Life Insurance Benefits

Group Term Life Insurance, 10-Year Level Term Life, and 20-Year Level Term Life

Group term life insurance, 10-year level term life and 20-year level term life programs are fully insured within one consolidated policy written by MetLife to pay claims under the Plan. The policy reflects a reduction in the participant contribution premium rates based on re-sloped rates for various age bands and is subject to experience-rating adjustments. Experience ratings (calculated as the difference between premiums paid and the total of claims paid and fees charged by the insurance company) are determined by MetLife in the following year and may result in a premium surplus or deficit.

The agreement with MetLife provides for the establishment of a Premium Stabilization Reserve ("PSR") which represents funds held by MetLife on behalf of the Plan to provide additional protection against the need to increase premium rates if claim experience should deteriorate beyond expected results.

Other

Accidental Death and Dismemberment

The Accidental Death and Dismemberment program was fully insured with a policy to pay claims under the Plan. The program was underwritten by MetLife.

Dental

The dental program was fully insured with a policy underwritten by MetLife Insurance Company for the period of January 1, 2024, to December 31, 2024. Prior to January 1, 2024, the dental program was fully insured with a policy underwritten by Anthem Blue Cross & Blue Shield.

Accident

The program was fully insured with a policy underwritten by ReliaStar Life Insurance Company to pay claims under the Plan.

Critical Illness

The critical illness program was fully insured with a policy underwritten by ReliaStar Life Insurance Company to pay claims under the Plan.

4. CERTIFICATION OF INVESTMENT INFORMATION

The following information included in the financial statements and supplemental schedules was obtained from data that has been prepared and certified to as complete and accurate by Northern Trust:

- Investments, accrued investment income, and due from and to broker for securities sold and purchased, as shown on the statements of net assets available for benefits - modified cash basis as of October 31, 2024 and 2023;
- Investment income and investment expenses, as shown on the statements of changes in net assets available for benefits - modified cash basis for the years ended October 31, 2024 and 2023;
- Schedule H, line 4i - schedule of assets (held at end of year); and
- Schedule H, line 4j - schedule of reportable transactions.

5. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices in active markets for identical assets or liabilities that the reporting entity has the ability to access.

Level 2 - Inputs to the valuation methodology are quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in markets that are not active or inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. For the years ended October 31, 2024 and 2023, there were no transfers in or out of Level 3.

Following is a description of the valuation methodologies used for the assets measured at fair value. There have been no changes in the methodologies used at October 31, 2024 and 2023:

Mutual Funds: Shares in mutual funds are presented at fair value based on quoted market prices.

Common/Collective Trusts and a Limited Partnership: Shares in common/collective trusts and ownership in partnerships/joint ventures that are valued based on the net asset value ("NAV") of the units of participation owned by the Plan at year-end as determined by the trustees of the common/collective trusts and limited partnerships based on the fair value of the underlying investments, less any liabilities, of the funds. The NAV is used as a practical expedient to estimate fair value.

The Plan invests in three limited partnerships. The first partnership's primary purpose is to provide investors with the ability to capitalize on perceived investment opportunities resulting from market dislocations. This limited partnership is valued daily and, except as otherwise noted in the limited partner agreement, no limited partner may withdraw from the partnership or make a demand for or receive paid-in-capital until the termination of the master fund of the partnership.

The second limited partnership seeks to generate an annualized 9-10% gross return through high-quality income-producing investments in desirable locations with favorable fundamentals and demographics in property types such as senior housing, medical building, student housing and other healthcare-related real estate investments. Investors may redeem all or any portion of their units quarterly by delivering 45-day written notice to this partnership. As of October 31, 2024, this partnership has been closed.

The third limited partnership was established for the purpose of holding infrastructure investments. The Fund uses derivative financial instruments such as foreign exchange forward contracts to hedge foreign exchange risk exposures. Investors can submit a request for redemption at any time. Redemption is at the discretion of the general partner.

As of October 31, 2024 and 2023, there are unfunded commitments of \$0 and \$0, respectively, in the limited partnerships.

6. TAX STATUS

As stated in its latest determination letter dated November 27, 1996, the Internal Revenue Service (the "IRS") recognized the trust, as then designed, as exempt from federal income taxation under Section 501(a) of the Internal Revenue Code (the "IRC"), described in Section 501(c)(9). The Plan and the VEBA trust are required to operate in conformity with the IRC in order to maintain the VEBA's tax-exempt status.

The Plan administrator is not aware of any course of action or series of events that has occurred that might adversely affect the VEBA's tax-exempt status. The Plan has been amended since the most recent exemption letter was issued; however, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Accordingly, no provision for income taxes is needed.

Management of the Plan evaluates tax positions taken and discloses a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Management has evaluated the tax positions taken by the Plan and concluded that as of October 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require disclosure of a liability in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods. In addition, there have been no tax related interest or penalties for the periods presented in these financial statements.

7. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported on the statements of net assets available for benefits - modified cash basis.

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, participant data and demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

8. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Northern Trust, the Trustee, as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions that are exempt from the prohibited transaction rules of ERISA.

Certain administrative costs relating to the Plan's operation are paid to ALPA for the services it provides to the Plan, such as billing and collecting premiums, verification of eligibility for coverage and submission of participants' applications for coverage to the insurer for processing and underwriting. For the years ended October 31, 2024 and 2023, the amounts reimbursed to ALPA for administrative and marketing services totaled \$632,078 and \$625,768, respectively.

9. PRIORITIES UPON TERMINATION OF PLAN

Although it has not expressed any intent to do so, ALPA has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, assets will be distributed to, or maintained on behalf of, Plan participants in accordance with the Plan document and applicable law. In no event will assets held by the Plan revert to ALPA upon termination of the Plan.
