Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Greylock 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Greylock 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Note 1 - Description of Plan

The following description of the Greylock 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan trust agreement for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan established effective January 1, 1994 and covers substantially all employees of the Greylock Federal Credit Union (the "Company") who meet certain eligibility requirements. The Plan was amended effective April 1, 2006 to be a safe harbor 401(k) plan. The Plan was further amended effective January 1, 2018 to allow for after-tax (Roth) contributions and include an automatic enrollment feature. Employees who are age twenty-one and have completed ninety days of service are automatically enrolled into the Plan and have pre-tax deferrals at 5% of their wages unless they opt out or opt for after-tax contributions. Deferral percentages are automatically increased 1% per year until 10% is being deferred. Employees may elect to have a different percentage withheld. Employees must be age twenty-one and have completed one year of service, as defined in the Plan, in order to share in the Company's matching contribution. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may elect to defer up to fifty percent (50%) of their compensation subject to Internal Revenue Code (IRC) limitations. Under the safe harbor election, the Company contributes an employer match to the Plan equal to 100% of the participant's elective deferrals up to 4% of compensation of the participant. In addition, the Company may make an additional discretionary contribution to the Plan. There were no such discretionary contributions for the years ended December 31, 2024 or 2023. All contributions are invested as the participant directs.

Participant Accounts

Each participant's account is credited with (a) the participant's contribution; (b) the Company's matching contribution; (c) Plan earnings; (d) forfeitures of terminated participants' nonvested accounts and (e) charged with an allocation of administration expenses. Allocations are based on participant compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Participant Loans

Participants may borrow from the Plan subject to certain limitations. Loan transactions are treated as a transfer to (from) the investment fund and from (to) the participant's loan account. Participants may borrow from their accounts up to a maximum equal to the lesser of \$50,000 or fifty percent (50%) of their vested account balance. Loans are for a period not exceeding five years (thirty years if for the purchase of a principal residence) and bear interest based on prevailing market rates. Principal and interest are paid ratably through payroll deductions. Interest rates on outstanding loans were 4.25% to 9.5% at December 31, 2024 and 2023. There were \$776,370 and \$721,173 in outstanding loans as of December 31, 2024 and 2023, respectively.

Vesting

Participants are immediately vested in their deferred contributions, the safe harbor employer match and all actual earnings thereon. Vesting in the Company's discretionary contribution (if any) is based on the following schedule:

Note 2 - Summaries of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value (except for fully benefit-responsive investment contracts which are reported at contract value). In accordance with the policy of stating investments at fair market value, net appreciation or depreciation for the year is reflected in the statement of changes in net assets available for benefits. The net appreciation (depreciation) in the fair value of its investments consists of realized gains or losses and unrealized appreciation (depreciation) on those investments. Shares of registered investment companies (mutual funds) are valued at quoted market prices which represent the net asset value of shares held by the Plan. Purchases and sales of securities are recorded on a trade-date basis. Interest and other investment income are recorded as earned on the accrual basis. Dividend income is recorded on the ex-dividend date.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest thereon. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document. Interest income from notes receivable from participants is recorded on the accrual basis.

Risks and Uncertainties

The Plan provides for various investment options in any combination of fixed income securities and mutual funds. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

Use of Estimates

The preparation of the Plan's financial statements in conformity with accounting principles generally accepted in the United States of America and DOL rules and regulations for reporting and disclosure under ERISA require the Plan Administrator to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Accordingly, actual results could differ from those estimates.

Administrative Expenses

The Company absorbs substantially all costs related to the operation of the Plan at no charge to the Plan. Certain administrative fees are paid by the Plan.

Forfeitures

As of the end of each Plan year, forfeitures which have become available during the Plan year shall be used to pay Plan expenses or reduce the safe harbor employer match. During the years ended December 31, 2024 and 2023, \$14,820 and \$-0-, respectively, of available forfeitures were used to reduce the employer contributions to the Plan.

Payment of Benefits and Withdrawals

Upon termination of service, a participant may elect to receive either a lump-sum amount equal to the value of his or her account, or installments over an agreed upon period of time. Participants may withdraw their voluntary contributions at any time. They may withdraw the vested portion of any company contributions subject to restrictions or penalties as defined in the Plan trust agreement. Benefits are recorded when paid.

Note 3 - **Fair Value Measurements**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, provides a definition of fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC Topic 820 are described as follows:

- Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access. The Plan has shares of registered investment companies (mutual funds) and pooled separate accounts which are considered Level 1 investments.
- Level 2:** Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability. The Plan has no Level 2 assets or liabilities.

- Level 3:** Inputs that are unobservable inputs for the asset or liability. The Plan has no Level 3 assets or liabilities.

The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are deemed to be actively traded. The pooled separate accounts invest mainly in mutual funds and domestic stocks that have observable level 1 quoted pricing inputs. The net asset value of the pooled separate accounts is not publicly quoted but is available to its investors when plan participants access their account values. The net asset value is the basis for current transactions and the funds can be redeemed for net asset value as of the measurement date, therefore, the trustee believes the accounts have a readily determinable fair value.

Investments Measured at Net Asset Value

The Plan invests in a common collective trust consisting of the Principal Stable Value Preferred Fund which is measured at fair value using the net asset value (NAV) per share as a practical expedient. The Fund is 100% invested in the Morely Stable Value Fund. The Morley Stable Value Fund invests in conventional, synthetic and separate account investment contracts issued by life insurance companies, banks and other financial institutions. The Fund prepares its financial statement consistent with the measurement principals of an investment company. This value represents the proportionate shares of the NAV of the Morley Stable Value Fund. Redemption restrictions and unfunded commitments, if any, are disclosed in the table below. Investments valued using NAV as a practical expedient are excluded from the fair value hierarchy.

Note 5 - Guaranteed Investment Contract with Insurance Company

In 2012, the Plan entered into a fully benefit-responsive guaranteed investment contract with Principal Life Insurance Company (Principal). Principal maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract.

The guaranteed investment contract is presented on the face of the statement of net assets available for benefits at contract value. Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023 was \$- and \$5,892,867, respectively. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reset on a semiannual basis and will never be less than the guaranteed minimum interest rate.

Certain events limit the Plan's ability to transact at contract value with Principal. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants are probable of occurring.

This investment contract was terminated during the year ended December 31, 2024 and replaced with the Principal Stable Value Preferred Fund.

Note 6 - **Tax Status**

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

Note 7 - **Related Party Transactions**

Plan investments are shares of mutual funds and a guaranteed investment contract managed by Principal. Principal serves as the custodian and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services amounted to \$13,954 and \$12,219 for the years ended December 31, 2024 and 2023, respectively.

In addition, Global Retirement Partners, LLC d/b/a BCG Retirement Consultants provided investment advisory services to the plan. During each of the years ended December 31, 2024 and 2023, this company received \$24,000 of indirect compensation from the Plan.

Note 8 - **Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

Note 9 - **Subsequent Events**

Effective January 1, 2025, the Plan was amended to reduce the eligible age for participation from 21 years to age to 18 years of age.

The Plan has evaluated subsequent events through July 1, 2025, the date on which the financial statements were available to be issued.
