As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL’s Rules and Regulations for Reporting and Disclosure under ERISA (“qualified institution”).

Management has obtained a certification from a qualified institution as of December 31, 2024, and for the year ended December 31, 2024, stating that the certified investment information, as described in note 3 to the financial statements, is complete and accurate.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

# **Notes to Financial Statements**

*(All amounts are in United States Dollars unless otherwise stated)*

## **NOTE 1: DESCRIPTION OF PLAN**

The following description of the TPI Defined Contribution Plan (“the Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

### *General*

The Plan is a defined contribution plan sponsored by Torrent Pharma, Inc. (“the Company/ Plan Sponsor/ Employer”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Plan’s assets are held in a trust administered by T. Rowe Price Trust Company (T. Rowe Price), the custodian and record-keeper.

Effective November 01, 2023, the Company adopted and restated the Plan document to appoint Reliance Trust Company (“Reliance”) as a trustee.

### *Eligibility*

All Employees are immediately eligible to participate in the Plan.

### *Contributions*

Participants may contribute any portion of their gross eligible compensation (as defined in the Plan) on a before-tax basis, limited to a maximum amount in any calendar year, as adjusted annually pursuant to Section 402(g) of the Internal Revenue Code (IRC) (\$23,000 and \$22,500 in the Plan years 2024, and 2023 respectively). These elective deferrals may be designated as either traditional (pre-tax) or Roth (after-tax) amounts; both types are presented as “Participant contributions” in the accompanying financial statements. Participants aged 50 and above who have contributed the maximum contributions for that year may make a catch-up contribution (\$7,500 for Plan years 2024 and 2023). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Company also makes a contribution to the Plan, known as the safe harbor contribution. The safe harbor contribution will be an amount equal to 3% of the participant’s eligible compensation, up to the Internal Revenue Service (“IRS”) limit of \$345,000 in 2024 and \$330,000 in 2023. The safe harbor contribution is calculated on base salary only and does not include bonuses, other company benefits, or other non-recurring items.

Effective January 01, 2024, the Company adopted and restated the Plan document and makes discretionary matching contributions of 100% of the participant's contributions up to 1.5% of the participant’s eligible compensation.

The Plan’s provisions state that the Company may also make an additional discretionary profit-sharing contribution. There were no discretionary profit-sharing contributions made during the Plan years ended 2024 and 2023.

### *Participant accounts*

Each participant’s account is credited with the participant’s contributions, employer safe harbor contributions, employer discretionary matching contributions, employer profit-sharing contributions, and an allocation of investment earnings or losses and expenses, if any. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

### *Vesting*

Participants are immediately vested in their contributions, employer safe harbor contributions, employer discretionary matching contributions, employer profit-sharing contributions, and actual earnings or losses thereon.

### *Notes receivable from participants*

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms cannot exceed five years unless the loan is for the purchase of the participant's principal residence, in which case it can be longer. The loans are collateralized by the balance in the participant's account and bear interest at the prime rate. Principal and interest are paid ratably through payroll deductions (at a frequency not less than quarterly).

### *Payment of benefits*

Benefits under the Plan are payable to participants or their beneficiaries upon termination of service, due to death, disability, retirement, or other reasons. Benefits are paid in a single lump-sum payment or in partial withdrawals or installments over a period of not more than the participant's assumed life expectancy.

## **NOTE 2: SUMMARY OF ACCOUNTING POLICIES**

### *Basis of accounting*

The financial statements of the Plan are prepared using the accrual method of accounting.

### *Use of estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates and assumptions used.

### *Investment valuation and income recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. For further discussion about the fair value of the Plan's investments. See note 4, fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### *Notes receivable from participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent loans are treated as distributions based on the terms of the Plan document.

### *Payment of benefits:*

Benefits to the participants are recorded when paid.

### *Administrative expenses:*

Administrative expenses are paid by the Plan or by the Company, as provided in the Plan document.

### *Forfeitures:*

On December 31, 2024, and December 31, 2023, forfeited nonvested accounts totalled \$969 and \$335, respectively. Forfeitures of terminated employees' non-vested accounts totalled \$605 in the years ended 2024 and \$41 in 2023, respectively. These accounts may be used to reduce employer contributions.

## **NOTE 3: INFORMATION CERTIFIED BY RELIANCE TRUST COMPANY ("TRUSTEE") (UNAUDITED)**

The following is a summary of the Plan's asset information as of December 31, 2024, and for the year ended December 31, 2024, included throughout the Plan's financial statements and supplemental schedules as of and for the year ended December 31, 2024, that was prepared by or derived from information provided by Reliance Trust Company, the trustee, and furnished to the Plan administrator. The Plan administrator has obtained certifications from the trustee that the information provided to the Plan administrator by the trustee related to the following Plan assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information that appears throughout the financial statements and supplemental schedules related to the following assets:

## **NOTE 4: FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024, and December 31, 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Shares of registered investment companies held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. The shares of registered investment companies held by the Plan are deemed to be actively traded.

### NOTE 6: RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain investments of the Plan are shares of mutual funds offered through T. Rowe Price RPS, Inc. (“T. Rowe Price”). T. Rowe Price is the custodian and record-keeper of the Plan. Effective November 01, 2023, the Company adopted and restated the plan document to appoint Reliance as a trustee. T. Rowe Price and Reliance qualifies as permitted parties-in-interest, as defined by ERISA, and these transactions qualify as parties-in-interest transactions.

Certain officers and employees of the Company who are participants in the Plan perform administrative services related to the operation, recordkeeping, and financial reporting of the Plan. No such officer or employee receives compensation from the Plan. Some of the Plan's expenses, including trustee, custodial, and certain recordkeeping fees, were paid by the Company, and personnel and facilities of the Company are used by the Plan at no charge.

### NOTE 8: INCOME TAX STATUS

During the years ended December 31, 2024, and December 31, 2023, the Plan has adopted a defined contribution non-standardized pre-approved profit-sharing plan and trust sponsored by T. Rowe Price (the Plan’s custodian and recordkeeper). The Plan has not obtained an opinion letter directly from the Internal Revenue Code (“IRC”), as it relies on IRS approval of the non-standardized pre-approved profit-sharing plan and trust being utilized. The IRS has determined and informed the non-standardized pre-approved profit-sharing plan and trust sponsor by an opinion letter dated June 30, 2020, that the pre-approved plan was designed in accordance with applicable sections of the IRC. The Plan Administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan Administrator believes the Plan was qualified, and the related trust was tax-exempt for the years ended December 31, 2024, and December 31, 2023.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, and December 31, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements.

### NOTE 9: PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

### NOTE 10: RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, markets, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.
