## Report of Independent Auditors

The Plan Administrator and Plan Participants  
Kraft Group Retirement and 401(k) Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Kraft Group Retirement and 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes (collectively referred to as the “financial statements”).

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the

# Kraft Group Retirement and 401(k) Plan

## Notes to Financial Statements

December 31, 2024

### **1. Description of the Plan**

The following brief description of the Kraft Group Retirement and 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan administered by Kraft Group LLC, the plan administrator and sponsor. Non-union employees of the employers who have adopted the Plan (each of such respective employers being the Employer and, collectively, the Company) become eligible to participate upon completing one year of service, as defined. Effective October 1, 2022, full-time employees become eligible on the date in which their employer becomes a Participating Employer with respect to the Plan or, if earlier, October 1, 2022. Part-time employees become eligible to participate upon completing one year of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended, (ERISA).

#### **Change in Trustee**

Effective December 1, 2024, the Plan's trust agreement was amended to reflect a change in the trustee and recordkeeper from Empower Trust Company (Empower) to Fidelity Management Trust Company (Fidelity). In order to facilitate this transition, participants were not able to enroll, direct or diversify investments to their accounts, or obtain a loan or distribution from the Plan during a transition blackout period which started from November 21, 2024, through December 20, 2024. During the transition to Fidelity, some of the investment options were transferred in kind and others were liquidated and repurchased to a different share-class of the same fund.

#### **Contributions**

Participants may contribute an amount up to 100%, subject to certain provisions, of their Plan compensation, as defined, for the contribution period. Participants may also make rollover contributions from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan. Participant contributions are recorded in the period during which the Company makes payroll deductions from the participant's earnings. Effective January 1, 2024, the Plan was amended to add an after-tax contribution and in-plan Roth conversion feature.

### Notes to Financial Statements (continued)

#### **1. Description of the Plan (continued)**

Effective January 1, 2013, the Plan was amended to be a safe-harbor plan under Sections 401(k)(12) and 401(m)(11) of the Internal Revenue Code (the Code). The Company matches elective deferrals at a rate of 100% of the first 3% of eligible compensation and 50% of the next 2% of eligible compensation, as defined by the Plan.

Participant and employer contributions are invested as directed by the participant, and are recorded on an accrual basis in the year to which they are related.

#### **Participant Accounts**

Each participant's account is credited with the participant's contribution and allocation of the Employer's contributions and Plan earnings, and is charged with an allocation of administrative expenses. Earnings are allocated by investment, based on the ratio of a participant's account invested in a particular fund to all participants' investments in that fund.

The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Participants are immediately vested in their own contributions, rollover contributions, and matching contributions, plus actual earnings thereon. Vesting in the Company's additional discretionary contribution portion of their accounts is based on years of service, as defined. A participant becomes 20% vested after two years of service, 40% after three years of service, 60% after four years of service, 80% after five years of service, and 100% vested after six years of service. Participants without at least one hour of service after December 31, 2006 vest in their discretionary contribution accounts under the terms of the Plan in effect as of December 31, 2006. The Company did not make any discretionary contributions in 2023 or 2024.

#### **Forfeitures**

Upon termination of employment, participants forfeit their non-vested balances. If a participant is rehired within a five-year period, the forfeited contributions are reinstated. Forfeited balances of terminated participants' non-vested accounts are used to reduce future Company contributions. \$1,307 and \$24,171 of forfeitures were used to reduce Employer contributions in 2024 and 2023, respectively. Unallocated forfeited balances as of December 31, 2024 and 2023 were \$49,624 and \$38,449, respectively.

#### **1. Description of the Plan (continued)**

##### **Benefit Payments**

On termination of service, and if certain distribution requirements are met, participants may elect to receive either a lump-sum amount equal to the value of the vested portion of their account, an installment distribution if attained age is 62 or greater, or a combination of these payment options. Distributions are subject to the applicable provisions of the Plan agreement. Benefit claims are recorded as expenses when they have been approved for payment and paid by the Plan.

In-service withdrawals are available in certain limited circumstances, as defined by the Plan. Hardship withdrawals are allowed for participants incurring an immediate and heavy financial need, as defined by the Plan.

##### **Notes Receivable from Participants**

Under the terms of the Plan, participants may borrow from their accounts up to the lesser of \$50,000, 50% of their vested account balance or 100% of the value in the participant's pre-tax, after-tax, and rollover accounts. Loans are calculated on a fully amortized basis. A loan is collateralized by the balance in the participant's account, and bears interest at a rate commensurate with market rates for similar loans, as defined.

##### **Administrative Expenses**

The Plan is responsible for payment of the plan administration expenses, including custodian expenses and fees; however, the Company may pay the Plan expenses directly. Plan administration expenses are allocated to plan participants pro rata to their account balance. Transaction charges (for loan and benefit payment transactions), if any, are paid by the Plan by reducing the balances of those participants initiating the transactions. Expenses that are paid by the Company are excluded from these financial statements.

##### **Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time, and to terminate the Plan subject to the provisions of ERISA. In the event of a Plan termination, participants will become 100% vested in their accounts.

## **2. Summary of Significant Accounting Policies**

### **Basis of Accounting**

The financial statements have been prepared on the accrual basis of accounting.

### **Payment of Benefits**

Benefits are recorded when paid.

### **Investment Valuation and Income Recognition**

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Note 4 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

### **Notes Receivable From Participants**

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance, plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded (Deemed Distributions). The balance of Deemed Distributions at December 31, 2024 and 2023 was \$183,353 and \$198,426, respectively.

### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires management to make estimates that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

#### 3. Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments held and notes receivable from participants at December 31, 2024 and 2023, and net appreciation/(depreciation) in fair value of investments, interest, dividends and interest income on notes receivable from participants for the years then ended, was obtained or derived from information provided to the plan administrator and certified as complete and accurate by the trustees of the Plan.

#### 4. Fair Value Measurements

The fair value framework establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The fair value hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described below:

- Level 1 – Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities.
- Level 2 – Inputs other than quoted prices in active markets for identical assets and liabilities that are observable either directly or indirectly for substantially the full term of the asset or liability. Level 2 inputs include the following:
  - Quoted prices for similar assets and liabilities in active markets
  - Quoted prices for identical or similar assets or liabilities in markets that are not active
  - Observable inputs other than quoted prices that are used in the valuation of the asset or liability (e.g., interest rate and yield curve quotes at commonly quoted intervals)
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means
- Level 3 – Unobservable inputs for the asset or liability (i.e., supported by little or no market activity). Level 3 inputs include management’s own assumptions about the assumptions that market participants would use in pricing the asset or liability (including assumptions about risk).

#### 4. Fair Value Measurements (continued)

The level in the fair value hierarchy within which the fair value measurement is classified is determined based on the lowest level of input that is significant to the fair value measurement in its entirety.

Following is a description of the valuation techniques and inputs used for each general type of asset measured at fair value:

Mutual funds are valued using quoted market prices in active markets. Common/collective trusts are valued based on published unit value.

#### 5. Income Tax Status

The Plan has received a determination letter from the Internal Revenue Service (IRS) dated July 18, 2013, stating that the Plan is qualified under Section 401(a) of the Code, and therefore, the related trust is exempt from taxation. Subsequent to this determination by the IRS, the Plan was amended and restated. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The plan administrator has indicated that it will take the necessary steps, if any, to bring the Plan's operations into compliance with the Code.

### Notes to Financial Statements (continued)

#### 5. Income Tax Status (continued)

Accounting principles generally accepted in the United States require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### 6. Risks and Uncertainties

The Plan and its participants invest in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits. The investment results for individual participants are dependent upon their investment allocation of their accounts.

#### 7. Related-Party Transactions

The Plan holds units of investment funds by Fidelity Management Trust Company, the trustee of the Plan, and held units of common/collective trust funds by Empower Trust Company, the former trustee of the Plan. These transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transactions rules under ERISA.
