Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Citizens National Bank 401(k) Plan (the "Plan") an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note (3) to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

(1) DESCRIPTION OF THE PLAN

The following description of the Citizens National Bank (the “Company”) 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a qualified, defined contribution plan covering all employees of the Company who have attained age 20 and have completed 1,000 hours of service. Employees may enroll in the Plan upon attaining the service requirements.

The Plan is a prototype plan sponsored by American Funds Distributors, Inc. Broker’s commissions associated with investment transactions and investment management fees are paid by the Plan. The Plan is regularly updated to comply with tax legislation. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Participant Contributions

Each year, participants are able to contribute a percentage of their pay to the Plan, up to the maximum allowable contribution, as defined in Federal legislation. Contributions may be made on a pre-tax basis as traditional 401(k) contributions or on an after-tax basis as Roth 401(k) contributions. This amount is then deposited in the participant’s account as a 401(k) contribution.

Participants may rollover amounts from other eligible retirement plans to the Plan. The amounts transferred shall be allocated to the participant’s rollover contribution account. Such amounts and any earnings or losses shall be fully vested at all times.

Matching Contribution

Each plan year or, if the Company so chooses, at the same time tax-deferred contributions are contributed or any other time as permitted by law and regulation, the employer will make a regular matching contribution to the participant’s account of 100% of the participant’s 401(k) contribution up to 3% of the participant’s compensation. Compensation earned before first becoming eligible to participate is excluded in determining the amount of the match.

Safe Harbor Nonelective Contributions

Each plan year, the Company will make a safe harbor nonelective contribution to the participant’s account equal to 3% of the participant’s compensation for the plan year. Eligibility to receive safe harbor nonelective contributions begins on the same date as eligibility for participant contributions. Any compensation participants earned during the plan year, but prior to the date on which they became eligible to receive safe harbor nonelective contributions, will be excluded when determining their safe harbor nonelective contribution. The Company will provide notice each year of its obligation to make safe harbor nonelective contributions to the participant’s account and of the other benefits provided under the Plan.

Participant Accounts

Each participant’s account is credited with (a) the participant’s contribution, (b) the Company’s contribution and (c) Plan earnings. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their contributions, the Company's matching contribution, and the safe harbor contribution plus the earnings thereon.

Investment Options

Upon enrollment in the Plan, a participant may direct employee and employer contributions in any of the investment options available to the Plan as advised by American Funds Distributors, Inc. Participants may change their allocation percentages at any time.

Payment of Benefits

Employees are eligible for retirement benefits upon reaching age 65 and are also eligible for benefits due to death or disability. Participants or their beneficiaries may elect a single lump sum payment of their entire vested account balance, or a portion of their vested account balance. Participants may make hardship withdrawals under prescribed circumstances, up to the value of their vested account balance. Withdrawals after the attainment of age 59 ½ can be made without penalty.

Forfeited Accounts

Plan contributions are fully vested and nonforfeitable when such plan contributions are made.

(2) SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using U.S. generally accepted accounting principles and the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. At December 31, 2024 and 2023, the Plan held no contracts that are considered fully benefit-responsive.

Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from these estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note (4) for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses incurred maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment-related expenses are included in net appreciation (depreciation) of fair value of investments.

Reclassifications

Certain reclassifications have been made to December 31, 2023 information to conform to the 2024 presentation.

Subsequent Events

Subsequent events have been evaluated through July 31, 2025, which is the date the financial statements were available to be issued.

(3) INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE

Capital Bank & Trust (the "Trustee") held the Plan's investment assets as of December 31, 2024 and 2023 and executed investment transactions during the year December 31, 2024. Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by the Plan's trustee.

(4) FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under *FASB ASC 820* are described as follows:

Level 1: Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2: Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as: a) quoted prices for similar assets or liabilities in active markets, b) quoted prices for identical or similar assets or liabilities in inactive markets, c) inputs other than quoted prices that are observable for the asset or liability, d) inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs that are unobservable for the asset or liability.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(5) RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Citizens National Bank, the plan sponsor, provides to the Plan certain accounting and administrative services for which no fees are charged. Additionally, Citizens National Bank paid certain consulting and advisory fees on-behalf of the Plan.

As of December 31, 2024, American Funds Distributors, Inc. (“American Funds”) and its affiliate Capital Bank & Trust are the Plan’s third party administrator and trustee, respectively. Therefore, transactions with American Funds qualify as party-in-interest transactions. The Plan paid fees of \$957 to American Funds and its affiliate during the year ending December 31, 2024.

(6) PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

(7) TAX STATUS

The Plan is a prototype plan offered by American Funds Distributors, Inc. American Funds Distributors, Inc. obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan administrator and the Plan’s tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believe that the Plan is qualified. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

(8) RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.

(9) PLAN AMENDMENT

Effective January 1, 2024, the Plan was amended to permit Roth 401(k) contributions pursuant to Section 604 of the SECURE 2.0 Act of 2022. This amendment allows participants to designate all or a portion of their elective deferrals as Roth contributions, which are made on an after-tax basis and may be withdrawn tax-free if certain conditions are met.
