For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

1. Plan Description:

The following description of Werner Affiliated Companies Employees Savings Trust (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. Certain prior year amounts have been reclassified to conform with current year presentation.

General

The Plan is a defined contribution plan with a 401(k) feature sponsored by Werner Construction Co., (the Company). The following affiliated companies have entered into a participation agreement to become participating employers in the Plan: Werner Construction, Inc., Deweese Sand & Gravel, Inc., Quality Red-D-Mix, Inc., W.C. Enterprises Inc., Werner Construction L.L.C. and DPL Enterprises, Inc. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

To be eligible for the Plan, employees must be 18 years of age and complete two months of service.

Contributions

Each eligible participant may elect to contribute 1% to 50% of their annual wages to the Plan provided they did not exceed the specific dollar limit determined by the Internal Revenue Service. In 2024 and 2023, the Company made matching contributions to the Plan equal to 100% of the first 3% and 50% of the next 2% of the employees' pre-tax contribution amount. The Company may also contribute an additional non-matching amount out of its current or accumulated profits, if any, as determined by the Company. In 2024 and 2023, the Company did not make a non-matching contribution.

Participant Accounts

Each participant's account is credited with the participant's contribution and an allocation of (a) the Company's contributions as described above, and (b) the Plan's earnings. Allocations are based on participant earnings or account balances as defined. Forfeitures of non-vested amounts are used to reduce future employer contributions. Total forfeitures for the period ending December 31, 2024 and 2023 were \$1,053 and \$1,038, respectively.

Vesting

Participants are immediately fully vested in their contributions. Participants become vested in the Company's contribution after the following years of service:

Contributions relating to the employer safe harbor match are immediately 100% vested.

Notes Receivable from Participants

The loan provisions of the Plan allow plan participants with a vested account balance to borrow up to a maximum equal to the lesser of 50% of their vested account or \$50,000.

Payment of Benefits

Payment of benefits can be made upon service or disability retirement, termination of the Plan, death, termination of employment or financial hardship. The participant or beneficiary will receive either a lump sum payment in cash equal to the value of the funds allocated to their account, part lump sum and part installments, or installments as defined in the Plan agreement.

Administrative Expenses

Administrative expenses include investment and related fees. Participants pay all loan fees.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time to terminate the Plan subject to the provisions of ERISA. In the event of the Plan's termination, the participants would receive benefits under the Plan based on their account balance accumulated to the termination of the Plan. Each participant or an eligible beneficiary would receive the funds to be distributed to them within a reasonable time after the termination of the Plan.

2. Summary of Significant Accounting Policies:

The following is a summary of the significant accounting policies followed in the preparation of these financial statements:

Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis and present the net assets available for benefits and changes in those net assets in accordance with accounting principles generally accepted in the United States of America.

Investments Valuations

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

The Plan presents in the statements of changes in net assets available for benefits the net appreciation (depreciation) in fair value of investments, which consists of the realized gains or losses and the unrealized appreciation (depreciation) on those investments.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities at December 31 and the reported amounts of additions to and deductions from net assets for the years ending December 31. Actual results could differ from those estimates.

Risks and Uncertainties

The plan provides for various investment options in any combination of certain registered investment companies. Investment securities are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

Date of Management's Review

Subsequent events were evaluated through July 30 2025, which is the date the financial statements were available to be issued.

3. Investments:

The Plan's investments were held in trust and administered by the trustee, Empower Retirement of Great-West Life & Annuity Insurance Company, for the years ended December 31, 2024 and 2023. All investment information disclosed in the accompanying financial statements and supplemental schedule was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by the trustee.

Information Prepared and Certified by Trustee

As permitted by Section 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under Employee Retirement Income Security Act of 1974, the Plan administrator has determined it is permissible in the circumstances to have the Plan's audits of financial statements performed in accordance with ERISA Section 103(a)(3)(C) and elected not to extend the audits to any statements or information certified by the trustee of the Plan. The financial statement elements, which have been certified by the trustee, are investments at fair value, investment income, net appreciation (depreciation) in fair value of investments, notes receivable from participants, and changes in plan assets.

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs were used only when Level 1 or Level 2 inputs were not available.

Level 1 Fair Value Measurements

Fair values are based on quoted prices (unadjusted) in active markets for identical assets that the Plan has the ability to access at the measurement date. The fair values of mutual funds are based on quoted market prices, when available.

Level 2 Fair Value Measurements

Fair values are based on inputs other than quoted prices included in Level 1 that are observable for valuing the asset or liability, either directly or indirectly. Observable inputs include quoted price for similar assets or liabilities in active or non-active markets. Level 2 inputs may also include insignificant adjustments to market observable inputs.

The fair value of the guaranteed portfolio fund which quoted market prices are not available are valued using quoted prices for similar assets in active or non-active markets.

Level 3 Fair Value Measurement

Fair values are based on unobservable inputs used for valuing the asset or liability. Unobservable inputs are those that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing the asset, based on the best information available in the circumstances. There were no Level 3 inputs.

There have been no changes in the methodologies used at December 31, 2024 and 2023.

Gains and losses (realized and unrealized) included in changes in net assets available for benefits for the years ended December 31, 2024 and 2023, are reported in net appreciation (depreciation) in fair value of investments.

5. Tax Status:

The Plan is a non-standardized prototype plan under Section 401(a) of the Internal Revenue Code. The Internal Revenue Service has determined and informed the Company by letter dated March 31, 2008, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to December 31, 2021.
