### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of **Sundowner Trailers, Inc. 401(k) Retirement Plan** (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**Other Matters – Supplemental Schedule Required by ERISA**

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

### **NOTE 1: DESCRIPTION OF THE PLAN**

The following description of the Sundowner Trailers, Inc. 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more comprehensive description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan for the benefit of employees of Sundowner Trailers, Inc. (the Employer), including Hourglass Transport, LLC, an affiliate of the Employer. The Plan is subject to the Department of Labor's reporting requirements under the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### **Eligibility**

Employees of the Employer who are not a member of a collective bargaining agreement, a leased employee, or a nonresident alien are eligible to participate in the Plan at the next entry date upon attaining age 21 and completion of six months of service. Entry dates are January 1, April 1, July 1, and October 1 each year.

#### **Contributions**

Each year, participants may contribute a portion of their pretax annual compensation, subject to certain limitations as defined by the Plan. Participants who have attained age fifty before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover contributions). The Employer may make discretionary matching contributions. For the year ended December 31, 2024, the Employer made matching contributions calculated at 50% of a participant's contributions up to 3% of the participant's compensation. Catch-up contributions are matched by the Employer. The Employer may also make discretionary nonelective contributions. The Employer made no additional nonelective contributions during the year ended December 31, 2024.

#### **Investment Options**

Upon enrollment in the Plan, participants may direct their contributions among the various investment options offered by the Plan.

#### **Participant Accounts**

Each participant's account is credited with the participant's salary deferral contributions, his or her share of the Employer's contributions, and Plan earnings and losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant contributions, compensation, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Participants are immediately vested in their salary deferral contributions, plus actual earnings thereon. The Employer's contributions vest at 20% after one year of service and are fully vested after five years of service. Participants are fully vested upon reaching 65 years of age, upon death, and upon disability.

### Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or fifty percent (50%) of their vested account balance reduced by the highest outstanding loan balance in their account during the prior twelve-month period. Participants may not have more than one loan outstanding at any time. Loans are secured by the balance in the participant's account and bear interest at rates which are determined by the Plan administrator and shall be reasonable and commensurate with the current commercial rates charged on similar loans by persons in the business of lending money under similar circumstances. Principal and interest are paid ratably over the term of the loan through payroll deductions. All loans are required to be repaid within 12-60 months unless the loan qualifies as a home loan, in which case the loan is required to be repaid within 61-180 months. The consequences of a loan default are outlined in the Plan documents.

### Payment of Benefits

Upon retirement, disability, death, or separation of service, a participant is entitled to receive a lump-sum amount or installment payments equal to the vested value of his or her account. Accounts under certain dollar amounts at the time of the participant's termination may automatically be distributed to the participant. The Plan also allows for in-service withdrawals to participants meeting certain age or hardship requirements.

### Forfeitures

Forfeitures can be used to reduce Employer contributions and to pay reasonable Plan expenses. During the year ended December 31, 2024, \$4,042 of forfeitures were used to reduce Employer contributions. Unallocated forfeitures amounted to \$8,757 and \$713 as of December 31, 2024 and 2023, respectively.

## **NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

### Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the trustee. See Note 4 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

### Payment of Benefits

Benefits are recorded when paid. There were no amounts allocated to withdrawing participants' accounts for distributions payable prior to December 31, 2024 and 2023, but not yet paid as of those dates.

### Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service are recorded as a liability with a corresponding reduction to contributions. There were no excess contributions for the Plan year 2024.

### Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Employer and are excluded from these financial statements. Certain activity based fees are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

### Expense Offset Arrangements

Fees incurred by the Plan for the investment management services or recordkeeping are included in net appreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment.

### ***NOTE 3: INFORMATION CERTIFIED BY INSURANCE COMPANY***

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, John Hancock Life Insurance Company (the insurance company) has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate.

- Investments, as shown in the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023,
- Net appreciation in fair value of investments as shown in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024, and
- The Schedule of Assets Held at End of Year as of December 31, 2024.

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

### **NOTE 4: FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board (FASB) Codification Topic *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under FASB Codification Topic *Fair Value Measurements and Disclosures* are described as:

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Pooled separate accounts:* Valued at the net asset value (NAV) of the units of the pooled separate account. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the account less liabilities. This practical expedient is not used when it is determined to be probable that the account will sell the investment for an amount different than reported NAV. Participant transactions (purchases and sales) may occur daily.

*Stable value fund:* The stable value fund (the Fund) is invested primarily in group annuity contracts, synthetic guaranteed investment contracts (GICs) and other contracts with stabilizing agreements. It is valued at the NAV of units of the Fund. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. However, the issuer reserves the right to delay any participant initiated withdrawals for up to thirty days if it determines that the immediate withdrawal may have an adverse impact on the Fund. For other types of withdrawals of the Fund, such as a full redemption, the issuer reserves the right to require a twelve month notification in order to ensure that the securities liquidations will be carried out in an orderly business manner.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### **NOTE 5: RELATED PARTY AND PARTIES-IN-INTEREST TRANSACTIONS**

The Plan investments are managed by John Hancock Life Insurance Company. As a result, these investments and the related investment transactions qualify as party-in-interest transactions.

The Plan incurs expenses related to general administration and record keeping. The Employer pays a portion of these and other Plan expenses. The Employer also performs certain administrative functions at no cost to the Plan. The Employer does not expect reimbursement for these expenses.

Some fees due to John Hancock are offset by revenue sharing from the Plan's investment options. To the extent that revenue sharing is insufficient to cover these fees, they will be deducted pro rata from the participants' account.

The Plan is charged fees and expenses through expense ratios charged to the Plan's various investment options. The investment expense ratios vary by fund and are reflected in the value of the investments held by the Plan. Investment related expenses are included in net appreciation in fair value of investments.

### **NOTE 6: PLAN TERMINATION**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants become fully vested in their accounts.

### **NOTE 7: TAX STATUS AND UNCERTAIN TAX POSITIONS**

The Plan adopted the Nova 401(k) Associates Non-Standardized Defined Contribution Pre-Approved Plan. Nova 401(k) Associates, Inc. obtained an opinion letter from the Internal Revenue Service dated June 30, 2020, which indicated that the form of the Plan is acceptable under section 401 of the Internal Revenue Code (IRC). Plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, management believes that the Plan is qualified and the related trust is tax-exempt. Accordingly, no provision for income taxes has been included in the Plan's financial statements.

The Plan accounts for uncertain tax positions in accordance with the provisions of the FASB Codification Topic *Income Taxes*. FASB Codification Topic *Income Taxes* clarifies the accounting for uncertainty in income taxes and requires the Plan to recognize in their financial statements the impact of a tax position taken or expected to be taken in a tax return, if that position is more likely than not to be sustained under audit, based on the technical merits of the position. The Plan administrator has assessed the tax positions taken by the Plan and determined that no positions exist that require adjustment or disclosure under the provisions of FASB Codification Topic *Income Taxes*.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **NOTE 8: RISKS AND UNCERTAINTIES**

The Plan's investments are exposed to various risks such as interest rate, market and credit risks. Certain investment options may invest in foreign securities. There are certain additional risks involved when investing in funds with underlying foreign securities that are not present with investments in domestic securities. These risks may involve foreign currency exchange rate fluctuations, adverse political and economic developments and the possible prevention of currency exchange due to foreign governmental laws or restrictions. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities could occur in the near term and that such changes could materially affect the participant account balances and the amounts reported in the Plan's financial statements.

### **NOTE 9: SUBSEQUENT EVENTS**

Plan management has evaluated subsequent events through July 29, 2025, the date that the financial statements were available to be issued.
