Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Luth Research, LLC 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of period ended December 12, 2024 (Date of Plan Merger) and year ended December 31, 2023, and the related statement of changes in net assets available for benefits for the period ended December 12, 2024 (Date of Plan Merger), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Luth Research, LLC 401(k) Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the period ended December 12, 2024 (Date of Plan Merger) and year ended December 31, 2023, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Emphasis of Matter - Plan Merger

As further discussed in Note 1 to the financial statements, management elected to merge the plan into the Mariner Select Retirement Plan, a Pooled Employer Plan effective December 12, 2024. As part of the transaction, all plan assets were effectively transferred into the Mariner Select Retirement Plan. Our opinion is not modified with respect to this matter.

Other Matter – Supplemental Information Required by ERISA

The supplemental information as of period ended December 12, 2024 (Date of Plan Merger) and for the period then ended is presented for purposes of additional analysis and is not a required part of the financial statements but are supplemental information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information

included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

NOTE 1 - DESCRIPTION OF PLAN

The following description of the Luth Research, LLC 401(k) Retirement Plan (Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

Plan Merger

Effective December 12, 2024, the Plan was merged into the Mariner Select Retirement Plan, a Pooled Employer Plan (PEP). Pursuant to the Sponsor's election to join the PEP, all Plan assets were transferred into the PEP as of that date. The merger of assets did not affect participant vesting, which remained unchanged.

General

The Plan covers employees of Luth Research, LLC (Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company is the Plan's Sponsor and serves as the Plan Administrator. The Plan Administrator is responsible for oversight of the Plan as well as determining and reviewing the appropriateness of the Plan's investment offerings, and investments performance.

The Plan is a defined contribution plan established under the provision of section 401(a) of the Internal Revenue Code (IRC), which includes a qualified cash or deferred arrangement as described in section 401(k) of the IRC. The Plan became effective on September 30, 1999 and was restated in its entirety effective January 1, 2021. The Company contracted with Voya Retirement Insurance and Annuity Company to serve as Custodian of the Plan's assets and to administer the Plan through FuturePlan by Ascensus through December 12, 2024 (Date of Plan Merger). The president of the Company is the Trustee of the Plan.

Eligibility

Generally, an employee is eligible to participate in the Plan upon attaining age 21. Plan entry dates are on the first day of the month coinciding with or following the date eligibility requirements are met.

Participant Contributions

The Plan provides for an automatic employee deferral contribution at the rate of 4% of pay. Participants may affirmatively elect a different percentage from 0% to 100% of their annual compensation into a pre-tax deferral account and/or an after-tax Roth account up to the maximum allowed by the IRS limitation. Unless an eligible employee affirmatively elects otherwise, automatically enrolled participants will have their deferral contributions increased 1% a year not to exceed 8% of compensation. Participants may also contribute amounts representing distributions (rollovers) from other qualified plans.

Employer Contributions

The Company may provide for a discretionary profit-sharing contribution; however, no such contribution was made or declared for the period presented.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contributions, (b) plan earnings, and (c) charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants

The Plan allows participants to borrow against their vested account balances. Loans may not be made for less than \$1,000 and may not exceed the lesser of \$50,000 or 50% of a participant's vested account balance. The interest rate for loans is based on prevailing interest rates as determined by the Plan Administrator. Principal and interest are paid ratably through monthly payroll deductions not to exceed five years unless the note proceeds were used for the purchase of a principal residence.

Investments

Participants direct the investment of all assets attributable to their account. Each participant designates the percentage of any one or more of their accounts that is to be invested in each of several authorized investment funds designated by the Plan's Trustee.

Payment of Benefits

On termination of service due to death, disability, retirement or termination of employment, a participant may elect to receive a lump-sum amount, installment payments or paid as a direct rollover to an individual retirement account (IRA) or to another employer's tax qualified plan. Active participants may withdraw any part of their account in a single sum in the event of undue financial hardship or attainment of age 59 1/2. If a terminated participant's account is \$5,000 or less, the Plan may distribute the account balance to an IRA account without prior approval of the participant.

Vesting

Participants are immediately 100% vested in their contributions plus actual earnings thereon. Vesting in the Company's matching and profit-sharing contribution, if any, is based on years of continuous service. A year of service is obtained upon completing 1,000 hours of service during a year.

Forfeited Accounts

Generally, a participant's unvested portion of the Company matching contributions is forfeited upon termination of employment. Forfeitures are maintained in a separate account and can be used to pay Plan expenses.

The balance in the forfeiture account was \$2,045 as of December 31, 2023. For the period ended December 12, 2024, no forfeitures were used to pay for Plan expenses. There were unallocated forfeitures of \$2,045 as of December 12, 2024 (Date of Plan Merger) and, as a result of the merger of the Plan into the PEP, unallocated forfeitures of \$2,045 were included in the balance transferred to the PEP on December 12, 2024 (Date of Plan Merger).

Administrative Expenses

Fees related to the administration of loans and distributions are deducted from participant accounts and are included in administrative expenses. General administrative expenses of the Plan are deducted on a pro rata basis, including plan audit fees.

Certain investment expenses of the Plan are paid by the Company and therefore, excluded from these financial statements.

Certain investment management fees and other charges paid to the Custodian are offset against fund performance in the net appreciation section of the Statement of Changes in Net Assets Available for Benefits and are not, therefore, separately reflected as administrative expenses.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting which is in accordance with accounting principles generally accepted in the United States of America (GAAP). Employee and employer contributions were recognized in the period that contributions are due.

Use of Estimates

The preparation of financial statements in conformity with GAAP requires the Plan Administrator to make estimates and assumptions that may affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policy utilizing information provided by the Plan Custodian. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the period and year.

Benefits to Participants

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant notes are reclassified as distributions based upon the terms of the Plan document. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2023, no allowance for credit losses has been recorded. As of December 12, 2024 (Date of Plan Merger), there was no note receivable balance. The Plan allowed participants to make loan payments until the Plan was transferred to the PEP.

NOTE 3 - FAIR VALUE MEASUREMENT

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under GAAP are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used as of period ended December 12, 2024 (Date of Plan Merger) and year ended December 31, 2023.

Pooled separate accounts: Valued by the insurance company at the separate account's unit valued held by the Plan. The underlying securities in pooled separated accounts are fixed income and equity security mutual funds that were listed on national securities exchanges and valued on the basis of closing prices.

The Plan entered into a contract to acquire the Voya Fixed Account guaranteed interest account with Voya Retirement Insurance and Annuity Company (VRIAC). The contract underlying these investment options are considered to be fully benefit responsive in accordance with ASC Topic 962, "Plan Accounting - Defined Contribution Pension Plans."

The Voya Fixed Account investment option is a market value separate account investment option with a general investment account guarantee that provides a stated rate of return and insulates participant accounts from daily fluctuations in the market. Under the terms of the Voya Fixed Account group annuity contract, participants may direct permitted withdrawals and/or transfer transactions of all or a portion of their balance in the Voya Fixed Account investment option at contract value. Contract value represents contributions plus credited interest less participant withdrawals and fees.

The crediting interest rates to participants for the Voya Fixed Account as of December 31, 2023 was 4.00%. The guaranteed minimum crediting interest rates for the contract for the period ended December 12, 2024 (Date of Plan Merger) and year ended December 31, 2023 was 4.00%. VRIAC makes this guarantee, and although VRIAC may credit a higher interest rate, the credited rate will not fall below the lifetime guaranteed minimum of 4.00%.

VRIAC's determination of credited interest rates reflects a number of factors, including mortality and expense risks, interest rate guarantees, the investment income earned on invested assets and the amortization of any capital gains and/or losses realized on the sale of invested assets. A market value adjustment may apply to amounts withdrawn at the request of the contract holder.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan) (2) changes to Plan's prohibition on competing investment options or deletion of equity wash provisions; or (3) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan merger did not limit the Plan's ability to transact at contract value up to date the Plan was transferred.

NOTE 5 - INFORMATION CERTIFIED BY THE PLAN'S CUSTODIAN

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Voya Retirement Insurance and Annuity Company (Voya), the Custodian of the Plan, has certified to the completeness and accuracy of:

- Investments and notes receivable from participants reflected on the accompanying Statements of Net Assets Available for Benefits as of December 12, 2024 (Date of Plan Merger) and December 31, 2023.
- Net appreciation in fair value of investments, dividends, interest, and interest income on notes receivable from participants reflected on the accompanying Statements of

NOTE 6 - PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Voya. Voya is the Custodian and Recordkeeper as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Plan administrative service providers and investment advisor fees are paid by the Plan and are therefore considered exempt party-in-interest transactions.

NOTE 7 - TAX STATUS

The IRS has informed the Plan sponsor by a letter dated June 30, 2020 for the prototype plan adopted by the Plan, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan provides for various investment options in any combination of investment securities offered by the Plan. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investments securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits and the Statement of Changes in Net Assets Available for Benefits.

NOTE 9 - SUBSEQUENT EVENTS

Management has evaluated the activity of the Plan through July 29, 2025, the date the financial statements were available to be issued, and has determined that no subsequent events have occurred that would require recognition or disclosure in the financial statements or the notes to the financial statements except as disclosed below.

During October 2024, the Company erroneously failed to remit certain employee deferrals and loan repayments to the Plan aggregating \$14,812. These deferrals and loan repayments are not included as receivables at December 12, 2024 as the Plan was fully transferred to the PEP. The Company computed the lost earnings on these 2024 deferrals and loan repayments and subsequently, in June 2025, remitted the deferrals and loan repayments of \$14,812 to the PEP and made a contribution for lost earnings of \$713.29 to the PEP.
