Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other matter – supplemental schedules required by ERISA

The supplemental schedule of assets (held at end of year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such supplementary information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures. These additional procedures included comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with US GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

NOTE A - PLAN DESCRIPTION

The following description of the J. F. Ahern Co. Profit Sharing and 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of J. F. Ahern Co. (Company) who have attained the age of 21 and have been credited with 30 days of service. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and subsequent legislation.

OneAmerica Retirement Services, LLC (OneAmerica) is the Plan record-keeper. Matrix Trust Company (Matrix) is the Plan's trustee.

Contributions

A portion of the Company's current or accumulated profits, as determined by the board of directors, may be contributed for the benefit of all employees eligible for the Plan. Such contributions for any fiscal year may not exceed the maximum allowable as a deduction to the Company under the provisions of the Internal Revenue Code (IRC). These profit-sharing contributions are allocated to the accounts of the participants based upon compensation. No profit-sharing contribution was made for the 2024 or 2023 Plan years.

Each participant may elect to make pretax and Roth contributions to the Plan, as defined in the Plan document. All new and current employees are automatically enrolled at 6% once eligibility is reached. The Plan also allows permissible withdrawal terms related to this automatic enrollment for a 90-day grace period, excluding all employees who were previously automatically enrolled. Participants can contribute up to \$23,000 for calendar year 2024 and \$22,500 for calendar year 2023, with participants who have attained the age of 50 before Plan year end being eligible to make a catch-up contribution of up to \$7,500 in 2024 and 2023. These deferrals are specifically allocated to the account of the individual participant. The maximum amount a participant may defer is up to 85% of plan compensation. Participants may also contribute amounts representing distributions from other qualified plans (rollover contributions). The Company may also make a discretionary matching contribution to the Plan. The maximum matching contribution is dependent upon the designated employee groups which are defined by the Plan document, which are based on hire date and annual salary.

Safe harbor matching contributions equal to 100% of a participant's salary deferrals up to 1% of such participant's compensation, plus 50% of salary deferrals that exceed 1% of salary deferrals, but do not exceed 6% of compensation will be made to the Plan. The Company still has the ability to make non-safe harbor matching contributions in addition to any safe harbor contributions.

Participant Accounts

Each participant's account is credited with the participant's contribution and an allocation of: (a) the Company's discretionary profit-sharing contribution; (b) the Company's safe harbor match, (c) the Company's discretionary matching contribution; and (d) Plan investment income (loss). Allocations are based on participant compensation or account balances, as defined in the Plan document. The Plan allows participants to invest their account balances between or among separate established investment funds within the trust. Participant accounts are also charged with an allocation of administrative expenses.

The Plan does not allow loans to be taken out by plan participants.

Vesting

Participants are fully vested in the matching contributions, employer contributions, and safe harbor contributions after two years of service.

Benefit Payments

Any benefits provided by the Plan are paid from the net assets available for benefits. The benefit to which a plan participant is entitled is the vested benefit that can be provided by the contributions and income thereon (including net realized and unrealized investment gains and losses) allocated to such participant's account. The method of distribution will be determined by an election made by the Plan participant. The participant can elect a lump-sum payment or partial payments. Participants experiencing financial hardship may withdraw a portion of this account balance as defined in the Plan.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$22,293 and \$127,423, respectively. These balances may be used to reduce Plan expenses, reduce future employer contributions, or allocate as additional employer contributions at the direction of the Plan Administrator. During 2024 and 2023, employer contributions were reduced by \$180,691 and \$0, respectively, from forfeited non-vested accounts.

NOTE B - SUMMARY OF ACCOUNTING POLICIES

The significant accounting policies which have been consistently applied in the preparation of the accompanying financial statements follow.

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Valuation of Investments and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note G for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis with corresponding gains and losses being reported under interest and dividend income. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments held during the year.

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Benefit Payments

Benefit payments to participants are recorded when paid.

Administrative Expenses

Certain plan administrative expenses are paid by the Plan to the extent they are not paid by the Plan sponsor. Such expenses are expensed when incurred.

NOTE C - TAX STATUS

The prototype defined contribution plan and trust adopted by the Plan obtained its latest approval letter on November 30, 2020, in which the Internal Revenue Service (IRS) stated the Plan and trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the approval letter, the Plan Administrator believes that the Plan is designed and is currently being operated in all material respects in compliance with the applicable requirements of the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE D - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right to discontinue its contributions at any time and terminate the Plan. In the event of plan termination, all amounts credited to the participants' accounts shall become 100% vested and all unallocated amounts shall be allocated to the accounts of all participants.

NOTE E - RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

A majority of the costs of administering the Plan are paid directly by the Company. These costs include administrative and audit fees and are insignificant to the total net assets of the Plan.

OneAmerica is the record keeper of the Plan during the Plan years ended December 31, 2024 and 2023; therefore, any transactions with OneAmerica during the applicable years qualify as party-in-interest transactions.

NOTE F - INFORMATION CERTIFIED BY TRUSTEE

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Matrix, the trustee as of December 31, 2024 and 2023, has certified that the following data included in the financial statements and supplemental schedule is complete and accurate:

- Cash and investments, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Interest and dividend income, and net appreciation in fair value of investments, as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

NOTE G - FAIR VALUE MEASUREMENTS

The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds - Valued at the net asset value (NAV) of shares held by the Plan at year end, as determined by reference to quoted market prices.

Collective trust fund - Valued at the NAV of units of a bank collective trust fund. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE H - RISKS AND UNCERTAINTIES

Fair Value Measurement

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE I - OPERATIONAL ERRORS

During the 2023 Plan year, operational errors occurred related to the untimely remittance of employee contributions; errors identified in 2023 were corrected in 2024. During the 2024 and 2023 Plan years, operational errors occurred related to the incorrect calculation of safe harbor matching contributions; these errors were identified and corrected in 2024. The Company has concluded that any financial statement impact as a result of these errors is immaterial.

NOTE J - SUBSEQUENT EVENTS

Subsequent events have been evaluated through July 29, 2025, which is the date the financial statements were available to be issued.

The Plan Administrator is not aware of any subsequent events, which would require recognition or disclosure in the financial statements.
