Notes to Financial Statements

Note 1 – Description of Plan

The following description of the DTSV, Inc. Health & Welfare Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete of the Plan's provisions.

General

The Plan and Trust were established on January 1, 2020 to provide health and other benefits to eligible employees of DTSV, Inc. (the Company) effective March 1, 2020. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Effective February 28, 2023, the Company has changed the trustee of the Plan to KeyBank National Association and has changed the recordkeeper to CBIZ Benefits & Insurance Services, Inc.

Eligibility and Vesting

Employees hired subsequent to March 1, 2020 and on the first of the month are eligible to participate in the Plan on the first day of the month following one month of continuous employment. Any employees hired subsequent to March 1, 2020 and on a date other than the first of the month will be covered on the first of the second following month of continuous employment.

All the eligible employees employed during the contract negotiation through March 1, 2020 were immediately eligible to receive benefits upon the transfer of the contract to the Company and were not required to meet the eligibility requirements.

Participants will receive coverage for any month in which they remain eligible for the Plan and for which the Plan management makes contributions to the Plan on their behalf. The participants' coverage will end at midnight on the last day of the month in which eligibility ceases. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

Contributions

For employees covered under the Service Contract Labor Standards and applicable associated Collective Bargaining Agreements, the Plan Sponsor contributes a maximum amount per employee based on a prevailing wage Health & Welfare amount of \$5.52 per hour paid to a maximum of 40 hours per week, and the Participant pays any cost of benefits exceed this maximum employer contribution. For all other employees, the Plan Sponsor contributes a percentage of the total cost of the insurance premiums with the employee contributing the balance of the cost through payroll deduction.

Benefits

The Plan also provides dental, vision, legal accidental death and dismemberment, supplemental accident and hospital indemnity, critical illness and life benefits for eligible participants and their beneficiaries. The Plan provides these benefits through various annual contracts with insurance companies. The Plan provides medical and prescription drug coverage through annual contracts with insurance companies. Premiums for these insured benefits are paid to the insurance company directly from the assets of the Plan.

Notes to Financial Statements

Prepaid Contributions

The prepaid contributions liability represent the initial deposit paid by the Plan sponsor and subsequent funding that exceeded their contracted obligation to the Plan. This liability will be used in subsequent years as a “premium holiday” based on available funds to pay benefits as they come due. The Plan sponsor is ultimately liable to fund any deficiency in the Plan’s obligations.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting

The Plan's financial statements are presented on the accrual basis of accounting in accordance with generally accepted accounting principles.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Concentrations of Credit Risk

The Plan maintains its demand deposits in commercial bank accounts which, at times, may exceed federally insured limits. The Plan has not experienced any losses in such accounts. Plan management does not believe the Plan is exposed to any significant credit risk on cash.

Contributions Receivable

Employer contributions due but not paid at year and period end are recorded as contributions receivable. There was no allowance for uncollectible accounts as of December 31, 2024 and 2023.

Payment of Benefits

Premiums paid by the Plan are recorded as premium payments in the accompanying statement of changes in benefit obligations and net assets available for benefits. Benefits are recorded when paid. Amounts due to claims processors that have yet to be reimbursed by the Plan are recorded as payable to claims administrators in the accompanying statement of changes in benefit obligations and net assets available for benefits.

Insurance Premiums Payable

Insurance premiums payable are based upon the actual premiums due for December 31, 2024 and 2023, but not paid by the Plan year-end.

Benefit Claims Incurred But Not Reported

The obligation for benefit claims incurred but not reported is an estimate for self-funded benefits incurred on or prior to December 31, 2024 and 2023, but reported to and paid by the Plan after year-end. The estimates were calculated using available claims experience data and projected future claims.

Administrative Expenses

All administrative expenses may be paid out of the Plan unless paid by the Company. During the year ended December 31, 2024, the Plan paid for substantially all administrative expenses, which consisted of administration fees, trustee fees, and other miscellaneous expenses.

Notes to Financial Statements

Income Taxes

The Trust established under the Plan to hold the Plan's assets has not applied for exemption from California or federal income taxes. The Plan is required to pay federal and state taxes on unrelated business income consists of the investment income earned on the excess of the net assets available for benefits over the required reserve balance allowable under the Internal Revenue Code. The Plan does not have any net taxable income for the year ended December 31, 2024, therefore, no tax liability is reflected in these financial statements.

Subsequent Events

Management of the Plan has evaluated subsequent events through July 30, 2025, which is also the date the financial statements were available to be issued. No subsequent events were noted during this evaluation that require recognition or disclosure in these financial statements.

Note 3 – Plan Termination

The Plan shall remain in existence from year-to-year unless written termination notice is given by Plan management or the Plan administrator to the other at least 60 days prior to the anniversary date of effective coverage under the Plan.

Although it has not expressed any intent to do so, the Company has the right under the Plan to modify the benefits provided to participants, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits or for on account of the participants. No assets of the Plan may revert to the Company or be used for purposes other than for the exclusive benefit of the Plan's participants, or the payment of reasonable administrative expenses of the Plan.

Note 4 – Income Tax Status

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examinations by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 5 – Excess Loss Coverage

The Plan's self-insured benefits expired on December 31, 2022, however the run-out liability goes through 2023. The Plan Maintained an insurance policy with Fidelity Select Life Insurance Company (FSLI) for the period from March 1, 2021 to February 28, 2022. The policies provide reimbursement to the Plan for claim amounts paid in excess of the monthly funding factor for each participant. There is no limit on the maximum eligible claim expense per covered person under the policy. FSLI has set a limit of \$1,000,000 as the maximum reimbursement amount during the policy coverage period. This limitation has been met. Therefore, any claims presented are the responsibility of the Plan and Plan Sponsor.

Note 6 – Risks and Uncertainties

The estimate for claims incurred but not reported is based on certain assumptions pertaining to claims lag and historical claims data. The liability recorded is the Plan's maximum exposure to the claims incurred but not reported. Should the Plan's claims be lower than the amount deposited into the funding factor account, the Plan may be entitled to the residual balance in the funding factor account. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.
