Notes to Financial Statements

Note 1: Description of Plan

The following description of the Kelley Trucking Inc. 401(k) Savings Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan became effective January 1, 1993, with approval of the Board of Directors of Kelley Trucking Inc. (the "Company") and restated effective January 1, 2024. The Plan is a defined contribution plan covering eligible employees of the Company that have completed at least one year of service during the eligibility computation period and are age twenty-one or older. Additionally, the Plan covers eligible employees who work at least 500 hours during each of three consecutive 12-month periods ("Long-Term, Part-Time Employees"). The Plan covers employees rendering services for the employer on contracts subject to the Davis-Bacon Act, Service Contract Act, or other Federal, State, or Municipal prevailing wage laws. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Company is the plan administrator and is responsible for oversight of the Plan and Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company ("Principal Trust Company") serves as the trustee and recordkeeper. Hunter Benefits serves as the Plan's third party administrator beginning December 31, 2023. Plan management determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Contributions

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan, on a pre-tax basis or through Roth contributions. Deferral contributions and Roth contributions shall not exceed certain limits set forth by the Internal Revenue Service (IRS). In addition to the annual contributions, participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). The Company makes prevailing wage contributions based on the the hourly contribution rate required under the applicable prevailing wage law. The Plan includes a safe-harbor provision that requires the Company to contribute 100% of the participant's elective deferrals that do not exceed 3% of the participant's compensation, but do not exceed 5% of the participant's compensation. Additional profit sharing amounts may also be contributed at the discretion of the Company. During the year ended December 31, 2024, the Company made safe harbor matching contributions of \$408,445, prevailing wage contributions of \$18,225, and no profit sharing contribution to the Plan.

Participant Accounts

Each participant's account is credited with the participant's contributions, Company matching contributions, and allocations of (a) the Company's profit sharing contribution, (b) plan earnings (losses), and (c) forfeitures of terminated participants' nonvested accounts. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Note 1: Description of Plan (Continued)

Vesting

Participant contributions, rollovers, qualified non-elective contributions, safe harbor matching contributions, and net earnings on these contributions are fully vested when made or earned. Discretionary Company contributions, if any, as well as all earnings on these contributions, vest as follows:

Participants are fully vested upon retirement, death, disability, or plan termination.

Notes Receivable From Participants

Participants are allowed two notes receivable at any time and may borrow from their fund accounts a minimum of \$1,000, up to 50% of the value of their account balance, or \$100,000, whichever is less. Note receivable terms range from one to five years, except for notes receivable used to purchase a primary residence, which can be in excess of five years at the discretion of the administrator. The loans are limited by no more than 50% of the balance in the participant's account and secured by the balance in the participant's account. The loans bear interest at 1% above the prime rate charged by the Federal Reserve Bank of New York. A loan will carry the same rate of interest throughout its term. As of December 31, 2024, interest rates on notes receivable from participants range from 5.25% to 10.50% per annum. Principal and interest are paid in equal installments through payroll deductions, personal checks from employees on leave, or cashier's checks for the full payoff of the notes receivable.

Payment of Benefits

On termination of service due to reasons other than death, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or installment payments. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. In addition, hardship distributions out of the participant's account are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 59 1/2.

Note 1: Description of Plan (Continued)

Investment Options

Upon enrollment in the Plan, a participant may direct his or her contributions in percentage increments into a series of common investment trusts, pooled separate accounts, mutual funds, and a guaranteed investment contract fund offered by the Plan. Participants may change their investment options at any time.

Forfeitures

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$-0- for both years. If available, forfeitures are used to reduce Company contributions or to pay administrative expenses of the Plan in accordance with the plan document. During the year ended December 31, 2024, the plan did not utilize any forfeitures to offset Company contributions or pay plan expenses.

SECURE 2.0 Act

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. Plan management will determine the option provisions to elect in the future.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Note 2: Summary of Significant Accounting Policies (Continued)

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts - "FBRICs"). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. The plan administrator determines the Plan's valuation policies utilizing information provided by the investment advisors, the custodian, and the third party administrator. See Note 4 for discussion of fair value measurements. FBRICs are reported at contract value, which is the amount participants would normally receive if they were to initiate permitted transactions under the terms of the Plan.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are allocated proportionately to plan participants based on their respective account balances and are included in net appreciation in fair value.

Subsequent Events

The Plan has evaluated subsequent events through July 24, 2025, which is the date the financial statements were available to be issued.

Note 3: Information Prepared and Certified by the Trustee

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal Trust Company, the Trustee of the Plan, has certified that the following unaudited data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments and notes receivable from participants, as shown in the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023.
- Interest and dividend income, net appreciation in fair value of investments, and interest income on notes receivable from participants as shown in the Statement of Changes in Net Assets Available for Benefits.
- All investment information included in the Supplemental Schedule - Form 5500 Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024.

This information has not been audited by the Plan's independent auditors.

Note 4: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level; Level 2 inputs consist of observable inputs other than quoted prices for identical assets in active markets (Level 1); and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled Separate Accounts: Each pooled separate account invests in assets solely in the shares or units of an underlying mutual fund, and the investment objective of each sub-account corresponds to the investment objective of the underlying fund. The value of each pooled separate account is determined using various inputs, such as the NAV of the shares of the underlying mutual fund held at year-end, adjusted for administrative expenses and other charges.

Note 4: Fair Value Measurements (Continued)

Common Collective Trusts: Valued at the NAV of units of the common collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months notification in order to ensure that the securities' liquidations will be carried out in an orderly business matter. There were no unfunded commitments.

Note 5: Guaranteed Investment Contract with Insurance Company

The Plan invests in a FBRIC with Principal Life Insurance Company ("Principal") in the form of a guaranteed investment contract (GIC) that invests in traditional investment contracts. Principal maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Principal is contractually obligated to repay the principal at a specified interest rate that is guaranteed to the Plan. The GIC is carried at contract value. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer but may not be less than 1.00%. Such interest rates are reviewed on a semi-annual basis for resetting.

Certain events limit the Plan's ability to transact at contract value with Principal including plan termination and other events as specified in the GIC. The plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants or the issuer are probable of occurring. The GIC does not permit Principal to terminate the agreement prior to the scheduled maturity date.

Note 6: Related-Party Transactions and Party-in-Interest Transactions

Certain plan investments are managed by Principal Trust Company. Principal Trust Company is the Plan Trustee and record keeper of the Plan and therefore transactions with Principal Trust Company qualify as party-in-interest transactions. Hunter Benefits served as the Plan's third party administrator. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments as they are paid through revenue sharing rather than a direct payment. The Plan made direct payments totaling \$96,657 which were not covered by revenue sharing. The Company pays directly any other fees related to the Plan's operations.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

Note 7: Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company contributions.

Note 8: Tax Status

The Plan utilizes a volume submitter plan, which obtained a favorable determination letter from the IRS dated June 30, 2020, stating that the volume submitter plan is qualified under the applicable sections of the Internal Revenue Code ("IRC").

Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified and the related trust is tax-exempt. Accordingly, no provision for income taxes has been included in the Plan's financial statements.

Note 9: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
