We have performed audits of the financial statements of NRC Health 401(k) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

### 1. Plan Description

---

The following description of the NRC Health 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### ***General***

The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established to provide retirement benefits for the employees of National Research Corporation (the Company).

Effective July 2024, the Company acquired Nobl, Inc. The acquired employees began participating in the Plan in the Company's payroll effective July 15, 2024 and will be eligible to participate in the Plan effective January 1, 2025.

Employees are eligible to make salary deferral contributions and receive Company discretionary matching contributions and Company discretionary profit sharing contributions after attaining age 21 and completing 30 days of service. Eligible employees may become participants on the first day of the month following the date on which entry requirements were fulfilled. Employees must be employed on the last day of the plan year or have had 501 hours of credited service within the Plan year in order to receive Company discretionary profit sharing contributions.

#### ***Contributions***

Participants may make voluntary salary deferral pre-tax and Roth after-tax contributions up to 75% of their eligible annual compensation up to the maximum dollar limits allowable by law. Participants are automatically enrolled with an initial 6% salary deferral contribution, unless they elect otherwise. All participant compensation deferrals for participants hired after August 1, 2018 are increased by 1% of eligible compensation up to 75% of eligible compensation. This increase will be applied as of the first period that begins after the period in which the initial deferral amount was withheld and will occur every anniversary date of the participant's date of hire. At any time, a participant can elect not to contribute or may increase or decrease their deferral rate within the Plan provisions. Participants may elect in-Plan Roth rollover transfers from vested contributions in a minimum amount of \$1,000. Participants may make no more than two transfers during the Plan year. Company discretionary matching contributions are based on the participant's elected deferral up to a maximum of 6% of eligible compensation. The Company has an additional discretionary matching contribution based solely on a participant benefit program that participants must specifically opt into. If a participant does not elect to contribute earnings from this program, the funds are not considered for this employer discretionary matching contribution. The Company may also make discretionary profit sharing contributions. Participants who are age 50 or older may make additional catch-up contributions. Contributions are subject to certain limitations.

### ***Participant Accounts***

Each participant's account is credited with the participant's contribution and allocations of a) the Company's discretionary matching contributions, b) the Company's discretionary profit sharing contributions and c) Plan earnings and losses, and is charged with an allocation of administrative expenses. The Company's discretionary matching contributions are allocated among participants based upon each participant's elected salary deferral. The Company's discretionary profit sharing contributions are allocated among participants based upon eligible compensation of participants. Plan earnings or losses are allocated on the basis of actual results of the investments directed by each participant. Investments are maintained in individual member accounts managed by John Hancock Trust Company LLC (John Hancock).

### ***Vesting***

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's discretionary matching and discretionary profit sharing contributions is based on years of continuous service. A participant is 20% vested after two years of credited service and vesting increases 20% per year until a participant is 100% vested after six years of credited service.

### ***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at rates at 2% above the Prime Rate (7.50% as of December 31, 2024 and 8.50% as of December 31, 2023). Principal and interest payments must be made through payroll deductions for active participants.

### ***Payment of Benefits***

Upon termination, retirement, disability, or death, the participant or beneficiary may receive lump-sum, partial or installment payments equal to the value of the vested funds allocated to the participant's account. In the event the participant does not make an election, distribution of payments up to \$7,000 (\$5,000 prior to January 1, 2024) will be directly rolled over to an individual retirement account designated by the plan administrator. The Plan also allows for in-service and hardship distributions (as defined by the Plan document). Benefit payments are recorded when paid.

### ***Forfeitures***

Upon a participant's termination of employment before normal retirement, disability or death, the portion of their Company discretionary contributions not then vested shall be forfeited. The forfeited portion of any participant's account will be used to pay Plan expenses, reduce Company discretionary contributions, or be re-allocated to participants. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$184,849 and \$104,303, respectively. During 2024 and 2023, \$90,719 and \$100,766 of forfeitures were used to pay Plan expenses, respectively.

### *Other*

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related solely to a specific participant may be charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

## 2. Summary of Significant Accounting Policies

---

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements is set forth below.

### *Basis of Presentation*

The accompanying financial statements have been prepared on the accrual basis of accounting and in conformity with accounting principles generally accepted in the United States of America.

### *Presentation of Participant-Directed Funds*

The Plan's presentation of participant-directed investments is in accordance with the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 962, *Plan Accounting – Defined Contribution Pension Plans*.

### *Use of Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

### *Investment Valuation and Income Recognition*

Investments, except for fully benefit-responsive investment contracts, are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company determines the Plan's valuation policies utilizing information provided by the investment advisors and custodian. See Note 4 for further discussion of fair value measurements.

Fully benefit-responsive investment contracts are reported at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Company invests in investment contracts through a guaranteed interest account.

Purchases and sales of securities are recorded on a trade-date basis. Investment income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### ***Deposits with Insurance Company***

The guaranteed interest account with an insurance company credits interest daily. The average yield for the contract was 3.05% and 2.80% during the years ended December 31, 2024 and 2023, respectively (see Note 5). The crediting interest rate is re-set on a quarterly basis.

### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Delinquent participant notes are reclassified as distributions based upon the terms of the Plan document.

### ***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### ***Subsequent Events***

Subsequent events are events or transactions that occur after the statement of net assets available for benefits date, but before the financial statements are available to be issued and may require potential recognition or disclosure in the financial statements. Management has considered such events or transactions through July 30, 2025, noting no items requiring disclosure.

## **3. Information Certified by John Hancock**

---

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by John Hancock, except for comparing such information certified by the custodian to information included in the Plan's financial statements and supplementary information.

#### 4. Fair Value Measurements

---

FASB ASC 820, *Fair Value Measurements and Disclosures*, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 5. Investment Contract with Insurance Company

---

The Plan entered into an investment contract with New York Life Insurance Company (New York Life). New York Life maintains the contributions in a guaranteed interest account. The account is credited with earnings on the underlying investments and charged for Plan withdrawals and administrative expenses charged by New York Life.

As the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by New York Life, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic developments. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

### 6. Tax Status

---

The Plan is qualified as a profit sharing plan under Section 401(a) of the Internal Revenue Code and is exempt from federal income taxation under Section 501(a) of the Internal Revenue Code.

The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authority. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

### 7. Related Party Transactions

---

Certain Plan investments are mutual funds and a guaranteed interest account managed by John Hancock and its affiliates/divisions, including New York Life. John Hancock is the custodian as defined by the Plan, and therefore these transactions qualify as party-in-interest transactions.
