### NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

#### NOTE A - DESCRIPTION OF PLAN

The following description of Winmark Corporation (the “Company” or “Plan Sponsor”) 401(k) Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

##### ***General***

The Plan is a defined contribution plan established to provide retirement benefits to substantially all employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). The Plan was most recently amended effective October 1, 2024. The policies below reflect all changes from amendments.

##### ***Plan Administration***

T. Rowe Price Retirement Plan Services (“T. Rowe Price”) is the administrator of the Plan. The Company retains Reliance Trust as trustee. T. Rowe Price manages, invests and distributes all assets of the Plan.

##### ***Eligibility***

Employees are eligible to participate in the Plan on the first of the month following date of hire as defined in the Plan for employees who have attained the age of 21. Certain non-resident aliens and union employees whose employment is governed by a collective bargaining agreement are not eligible to participate in the Plan.

##### ***Contributions***

Participants may direct the Company to make pretax contributions to the Plan on their behalf through payroll deductions of up to 100% of their pretax compensation, as defined in the Plan, up to the maximum amount allowed by the Internal Revenue Code (“IRC”). Participants satisfying certain criteria are permitted to make catch-up contributions, as stated in the Plan Agreement. Participants may also make rollover contributions to the plan.

The Company matches 50% of participant contributions up to 6% of participants’ pretax compensation. Participants are eligible to receive the Company match and a discretionary contribution after completing six months of service, as defined in the Plan Agreement. A discretionary contribution may also be contributed by the Company, subject to certain limitations. For the years ended December 31, 2024 and 2023, discretionary contributions of \$177,750 and \$162,800, respectively, were made to the Plan.

##### ***Participant Accounts***

Participants’ accounts are credited with the participant contributions (elective deferral, catch-up and rollover), company matching contributions, and an allocated share of the Company’s discretionary contribution and plan earnings and losses. Discretionary contributions are a set amount per eligible participant. The Company’s matching contributions are allocated to each participant’s account based on pretax contributions. Plan earnings are allocated based on participant account balances, as defined.

Participants’ accounts are also charged with benefit payments and an allocation of administrative expenses, if applicable. The benefit to which a participant is entitled is the benefit that can be provided from the participants’ vested account balance.

**December 31, 2024 and 2023**

***Vesting***

Participant deferral, catch-up and rollover contributions, including earnings, vest immediately, regardless of length of service.

Employer contributions vest based on years of service. A participant is vested at a rate of 20% after one year of service and 20% per year thereafter. A participant is 100% vested after five years of service. Additionally, employee account balances become fully vested and nonforfeitable upon attainment of age 65, total disability or death during the term of employment, or upon termination of the Plan.

***Forfeitures***

Forfeitures of terminated participants' nonvested accounts related to employer matching and employer discretionary contributions are credited against future employer matching account contributions and/or employer discretionary contributions. Forfeitures from matching and employer discretionary contributions may also be used to pay plan expenses. In 2024 and 2023, forfeitures of \$16,108 and \$8,537, respectively, were used to reduce employer matching contributions. As of December 31, 2024 and 2023, forfeiture balances of \$26,108 and \$9,342, respectively, are held in the Plan's forfeiture account as part of plan assets.

***Notes Receivable from Participants***

A participant may obtain a loan from their fund accounts for a minimum of \$1,000 up to the lesser of \$50,000 or 50% of their vested account balance. The note must be repaid with interest equal to prime plus 2% over a maximum of five years, unless the proceeds are used to purchase a principal residence in which case the loan term may be extended. Only one note may be outstanding to a borrower at any time. Interest rates were 5.75% to 10.00% at December 31, 2024 and 2023. Principal and interest are repaid ratably through payroll deductions for active participants.

***Rollover Contributions***

The provisions of the Plan allow participants who receive qualifying rollover distributions from benefit trusts of other employers to transfer such amounts to the Plan.

***Distribution of Benefits***

On termination of service due to death, total and permanent disability, termination or retirement, the distribution of benefits method depends on the vested account balance. The Company will disburse total vested balances of \$1,000 or less as one lump-sum payment as soon as administratively practicable after 90 days following termination. Similarly, if the total benefit payable to a beneficiary is less than or equal to \$1,000 it will be paid in a lump sum as soon as administratively practicable after 90 days following the participant's death. If participant vested balances are greater than \$1,000, the participant receives a distribution election form providing them the option to elect either lump-sum payment, rollover to a qualified plan or IRA, or a combination of lump-sum payment and rollover. In determining the vested balance for this purpose, rollover accounts will be disregarded.

***Plan Termination***

Although it has not expressed any intent to do so, the Plan Sponsor has the right to amend or terminate the Plan, subject to the provisions of ERISA. In the event of the Plan's termination, participants would become 100% vested and all assets of the Plan would be distributed to participants in accordance with the Plan Agreement.

***Investment Options***

The Plan allows participants to direct their investments and to make transfers between these accounts and funds daily.

**NOTE B - SIGNIFICANT ACCOUNTING POLICIES AND PROCEDURES**

A summary of the significant accounting policies for the Plan consistently applied in the preparation of the accompanying financial statements follows:

***Basis of Accounting***

The accompanying financial statements have been prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("US GAAP").

***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value measured at quoted market prices in an active market, except for the T. Rowe Price Stable Value Trust Fund which is valued at fair value of underlying instruments using the net asset value ("NAV") as a practical expedient.

Purchases and sales of securities are reflected on a settlement-date basis; as of December 31, 2024 and 2023, there were no unsettled transactions. Interest income is recognized when earned. Dividend income is recorded on the ex-dividend date.

***Net Appreciation (Depreciation) in Fair Value of Investments***

Net appreciation (depreciation) in the fair value of investments represents the net realized gains and losses and net unrealized appreciation or depreciation on investments. Realized gains or losses on investments are the differences between the proceeds received and either the cost of the investment sold, determined on an average cost basis, or the fair value at the end of the previous year, whichever is applicable. Net unrealized appreciation and depreciation is the change in the difference between fair value and the cost of investments or the fair value at the end of the previous valuation date, whichever is applicable.

***Administrative Expenses***

The Company has the discretion to pay plan expenses or allow the Plan to arrange payment. For the Plan year ended December 31, 2023, the Company paid for all Plan expenses, except for investment related fees, which are paid by plan participants. For the Plan year ended December 31, 2024, the Plan began paying for Advisor Services, which were \$11,667 during the year.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Delinquent notes are reclassified as distributions based upon the terms of the Plan Agreement.

***Benefits Paid to Participants***

Benefits paid to participants are recorded by the Plan when paid.

***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, credit and overall market volatility risks. Due to the level of risk associated with certain

investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

***Fair Value Measurements***

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") Topic 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds, collective investment trusts, and money market fund:* Valued at the NAV of shares held by the Plan at year-end based on quoted market prices.

*Stable Value Fund:* Valued at fair value of underlying instruments using NAV as practical expedient.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

***Use of Estimates***

US GAAP requires plan management to make estimates and assumptions that affect the reported amount of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
