### **Opinion**

We have audited the 2024 financial statements of NewFields Companies, LLC Group Health Benefit Plan (“the Plan”), which comprise the statements of net assets available for benefits and of benefit obligations as of December 31, 2024, and the related statement of changes in net assets available for benefits and changes in benefit obligations for the year ended December 31, 2024, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits and of benefit obligations of NewFields Companies, LLC Group Health Benefit Plan as of December 31, 2024, and the changes in net assets available for benefits and changes in benefit obligations for the year ended December 31, 2024, in accordance with accounting principles generally accepted in the United States of America.

### **Basis for Opinion for the 2024 Financial Statements**

We conducted our audit of the 2024 financial statements in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditor’s Responsibilities for the Audit of the 2024 Financial Statements section of our report. We are required to be independent of NewFields Companies, LLC Group Health Benefit Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

### **Emphasis-of-Matter**

As described in Note 9 to the financial statements, the NewFields Companies, LLC Group Health Benefit Plan became fully insured and fully funded as of January 1, 2025, and the Trust was subsequently terminated. Our opinion is not modified with respect to this matter.

### **Responsibility of Management for the 2024 Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America; this includes the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan’s

ability to continue as a going concern for one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditors' Responsibility for the Audit of the 2024 Financial Statements**

Our objectives are to obtain reasonable assurance about whether the 2024 financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. ## NOTES TO FINANCIAL STATEMENTS

### **NOTE 1: DESCRIPTION OF THE PLAN**

The following description of the NewFields Companies, LLC Group Health Benefit Plan (the “Plan”) provides general information regarding the Plan. Refer to Plan documents for a complete description of Plan provisions.

#### *General*

The Plan provides a self-funded high-deductible health plan (“HDHP”) and a preferred provider organization plan (“PPO”) covering substantially all eligible active employees and those eligible retirees who elect to continue coverage pursuant to the provisions of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan also offers insurance benefits for dental and vision care. The Plan is funded through a welfare trust established under Section 501(c)(9) named NewFields Companies, LLC Voluntary Employee Benefit Association Trust (“VEBA” or “Trust”).

On June 29, 2024, Plan management made the decision to begin funding the Plan from general assets of Newfields Companies, LLC (“Plan Sponsor”) and not through the Trust. After this date, the Plan has paid claims with the remaining VEBA funds until they were exhausted, and Plan bank overdrafts were paid through Plan Sponsor assets for the remainder of 2024; stop-loss reimbursements were made to the Plan Sponsor. All VEBA activity has been accrued to the financial statements as of December 31, 2024. All subsequent claims are paid through the general assets of the Plan Sponsor. On March 15, 2025 the Trust was terminated (see Note 9). Plan participants’ insurance coverages were unaffected during this transition and subsequent termination.

#### *Self-funded benefits*

Effective January 1, 2011, the Plan changed from a fully insured HDHP to a self-funded HDHP that includes stop-loss insurance for claims exceeding the limits in the policy. The HDHP provides health benefits including hospitalization, surgical, major medical, prescriptions and other related health services to active employees and retirees, and their eligible dependents and beneficiaries. As of January 1, 2023, the Plan began to offer a preferred provider organization plan (“PPO”) as an additional option for eligible participants in lieu of the HDHP. The Plan covers active employees who regularly work full-time (30 hours or more a week) and retirees who meet the minimum age and years of service requirements that elect to continue coverage and pay all premiums related to their coverage.

Health claims of active and retired participants and their beneficiaries and dependents are processed by a third-party administrator, but the responsibility for payments to participants and providers is retained by the Plan.

Employee payroll withholdings for health premiums are calculated in tiers based on ranges of authorized pay. Employer contributions are estimates to cover claims, expenses, and stop-loss insurance coverage. All deficits of the Plan are the responsibility of the Plan Sponsor as claims become payable.

#### *Fully insured benefits*

The Plan offers dental and vision insurance benefits through employee payroll deductions to pay premiums to an insurance company providing such benefits. The payment of these claims is the responsibility of the insurance company contracted to provide the coverage.

*Plan Spin-off*

Effective November 15, 2024, a participating division in the Plan Sponsor group ceased participation in the Plan and the affected employees were no longer eligible for continued plan benefits. The number of eligible participants in the Plan appropriately decreased by more than half.

*Contributions*

The Plan administrator at least annually establishes Plan Sponsor contributions and/or participant premiums that are held by the Trust for the NewFields Companies, LLC Group Health Benefits Plan. The premiums are expected to provide for the payment of benefits, stop-loss insurance premiums, administrative expenses, and to maintain an adequate reserve for the self-funded portion of the Plan.

Employees and retirees may pay specified amounts, determined periodically by the Plan, to extend coverage to eligible dependents.

*Plan changes and termination*

The Plan Sponsor has the right under the Plan to modify the benefits provided to the employees, and terminate the Plan, at any time, subject to the provisions of ERISA. The Trust provides, subject to the availability of funds from the Trust, for payment of covered expenses incurred prior to termination. Any remaining deficit is the responsibility of the Plan Sponsor.

**NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

*Basis of accounting*

The Plan prepares its financial statements on the accrual basis in accordance with accounting principles generally accepted in the United States of America (“US GAAP”). This basis includes in net assets of the Plan accrued revenue and contributions receivable, accrued administrative expenses and insurance premiums payable and benefit obligation for claims incurred but not reported, and claims reported but not paid.

*Estimates*

The preparation of financial statements in conformity with US GAAP requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results could differ from these estimates. It is at least reasonably possible that a significant change may occur in the near term for the estimates or health claims incurred but not reported and postretirement benefit obligations.

*Risks and uncertainties*

The actuarial present value of postretirement benefit obligations is reported based on certain assumptions pertaining to interest rates, health care costs inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term could change.

*Payment of benefits*

Funds for payment of health claims are paid into a trust from which allowable claims, based on the schedule of benefits, are paid. All funds received by the trust shall be applied toward payment of claims, insurance premiums, and reasonable expenses for administration of the Plan.

*Plan expenses*

All reasonable expenses incurred in administering the Plan that are not paid by the Plan Sponsor are paid by the Plan. All direct expenses are generally paid by the Plan.

*Claims payable and claims incurred but not reported*

A liability is reported for the estimated claims incurred but not reported or paid based on actual claims run-out after year end and the Plan's claims experience in prior years.

*Cash*

Cash consists of a deposit account at a major national bank. Historically, the Plan has not incurred any significant credit losses; however, from time to time the balance in the Plan's bank account exceeds \$250,000 Federal Deposit Insurance Corporation insurance limits.

*Cash Overdraft*

As of December 31, 2024, the Plan had a cash overdraft of \$207,798, which is presented as a liability in the Statements of Net Assets Available for Benefits and of Benefit Obligations. The overdraft resulted from the timing difference between the disbursement of participant benefit payments and the receipt of Plan Sponsor contributions. The Plan maintains a cash account with a financial institution that corrects temporary overdrafts with automatic transfers from the Plan Sponsor's general assets to facilitate timely benefit distributions. Plan management monitors cash flows regularly to ensure sufficient liquidity and to minimize the occurrence of overdrafts. The overdraft was fully resolved subsequent to year-end through the receipt of contributions and transfers from the Plan Sponsor's account.

**NOTE 3: BENEFIT OBLIGATIONS**

*Health claim obligations*

The Plan records obligations for claims incurred but not paid as of the date of the statement of net assets and benefit obligations. Health claim obligations are composed of reported but not paid claims ("RPNP") and incurred but not reported claims ("IBNR"). The Plan uses lag reporting based on when claims were received to identify these components. RPNP claims are received in the current year and paid in subsequent year, and IBNR are received and paid in the subsequent year. Health claim obligations are composed of:

*Postretirement benefit obligations*

The Plan provides post-retirement health benefits to eligible employees after retirement but before Medicare coverage eligibility at age 65. Eligible employees are those hired prior to 2001 and who retire from the Plan Sponsor after age 50.

The postretirement benefit obligation represents the total actuarial present value of those estimated future benefits that are attributed by the terms of the Plan to employees' service rendered to December 31, 2024 and 2023, reduced by the actuarial present value of contributions expected to be received in the future from current plan participants. Postretirement benefits include future benefits expected to be paid to or for current retired employees and active employees after their retirement and their respective beneficiaries and dependents. Prior to an active employee's full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributed to that employee's service rendered to the valuation date.

The actuarial present value of the expected postretirement benefit obligation is determined based on an actuarial calculation and is the amount that results from applying actuarial assumptions to historical claims cost data to estimate future annual incurred claims cost per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, disability, withdrawal, or retirement) between the valuation date the expected date of payment.

The foregoing assumptions are based on the presumption that the Plan will continue. If the Plan were to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the postretirement benefit obligation.

**NOTE 4: FEDERAL INCOME TAX STATUS**

The Trust established under the Plan to hold the Plan's assets received a favorable determination dated February 6, 2014 of its qualification under Section 501(c)(9) of the Internal Revenue Code and, accordingly, the Trust is exempt from income taxes on its net investment income. The Plan files form 5500 Annual Return/Report of Employee Benefit Plan and the Trust files Form 990 annually.

US GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would be sustained upon examination by a federal or state tax jurisdiction. The Plan administrator believes that as of December 31, 2024, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

**NOTE 5: TRANSACTIONS WITH PARTIES-IN-INTEREST**

The Plan does not consider benefits accrued or paid for participants as party-in-interest transactions. In order to operate the Plan, the Plan engaged various service providers, who qualify as parties-in-interest according to DOL regulations. Fees paid during the year for claims processing, auditing, and other professional services rendered by parties-in-interest were based on customary and reasonable rates for such services. The transactions entered into with these service providers are in the normal course of Plan operations and the service providers business lines.

**NOTE 6: STOP-LOSS INSURANCE**

The Plan maintains stop-loss insurance for annual claims exceeding \$90,000 in 2024 and 2023, per individual participant. In accordance with US GAAP, reimbursements and amounts due to the plan from the stop-loss insurance carrier are netted against claims paid in the 2024 financial statements as shown below:

**NOTE 8: RISKS AND UNCERTAINTIES**

COVID-19 effects continue to pose an uncertain threat to financial conditions within the overall marketplace; however, this threat has become a routine consideration of management.

**NOTE 9: SUBSEQUENT EVENTS**

The Plan management has evaluated subsequent events through July 31, 2025, which is the date the financial statements were available to be issued. No significant subsequent events were noted for recognition or disclosure, except for the following:

Effective January 1, 2025 the Plan became both fully insured and fully funded, with all 2025 plan financial activity occurring within Plan Sponsor bank account and not in the Trust. All VEBA Trust activity occurring in 2025 is for 2024 transactions that are accrued in the statements of net assets available for benefits and of benefit obligations as of December 31, 2024, and reflected in the related statement of changes in net assets available for benefits and changes in benefit obligations for the year ended December 31, 2024.

Effective March 15, 2025 the VEBA Trust was formally closed via Board Resolution from the Plan Sponsor. Effective April 1, 2025, the Company was purchased by an outside entity, and the responsibility of the Plan remained with the seller; ongoing coverage of employees under this Plan ceased on that date. The post-retirement portion of the plan ceased providing benefits effective May 31, 2025. All remaining liabilities of the Plan are the responsibility of the Plan Sponsor.


