### Report on the Audit of the Financial Statements

Hayward Lumber Co., Inc. 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). **NOTE 1 DESCRIPTION OF PLAN**

The following description of the Homer T. Hayward Lumber Co., Inc. 401(k) Profit Sharing Plan (the Plan) is for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan established on January 1, 1990 and is subject to the provisions of the Employee Retirement Income Security Act of 1974, (ERISA). The Plan provides benefits for all nonunion eligible employees of Homer T. Hayward Lumber Co., Inc. (the Company).

The Company is the Plan administrator and retains the services of third parties to assist in the administration of the Plan. Through December 31, 2024, the Plan's insurance company was Voya Retirement Insurance and Annuity Company (Voya) and the Plan's third-party administrator was Primark Benefits (Primark).

**Eligibility**

Except for excluded employees, all employees who have reached 21 years of age and completed 90 days of service are eligible to participate in the Plan and receive employer matching. Excluded employees include collectively bargained employees, nonresident aliens who do not receive United States source income from the Company, and leased employees. Eligible employees may enter the Plan on January 1 or July 1 during each Plan year. In January 2024, the Plan Sponsor acquired all the assets of a local lumber company along with approximately 32 employees. As a result, the Plan was amended effective February 1, 2024 to allow these employees to enter the Plan on the first day of the month following the effective date of the amendment. An employee may elect not to participate in the Plan.

**Employee Contributions**

Participants may elect to contribute up to 100% of their compensation subject to the maximum allowed under sections 415, 402(g) and 401(k) of the Internal Revenue Code (IRC). Participants are also permitted to deposit into the Plan distributions received from other plans (rollovers). A participant may revoke their deferral election (change the percentage contribution or amount to zero) at any time. A participant may elect to increase or decrease the percentage contribution or amount, on the first of every quarter, within defined limits upon notice to the Plan administrator.

**Employer Matching Contributions**

The Company may make a discretionary matching contribution equal to a discretionary percentage or as a flat dollar amount. For the years ended December 31, 2024 and 2023, the Company matched up to 25% of the first 4% of employee deferrals, calculated on a pay period basis. In addition, the Company may make a discretionary nonelective contribution to the Plan each year. Such discretionary nonelective Company contributions plus any forfeiture may be allocated to each participant who is eligible, each Plan year. The Company did not make discretionary nonelective contributions in 2024 and 2023.

**NOTE 1 DESCRIPTION OF PLAN (CONTINUED)**

**Participant Accounts**

Each participant's account is credited with the participant's contribution and Company contributions and allocations of Plan earnings. Allocations are based on participant compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Investment Options**

The Plan provides for investments to be directed by participants into a number of investment options issued by Voya Retirement Insurance and Annuity Company (insurance company). Some Plan investments are units of funds managed by the insurance company; therefore, these investments and all investment transactions are party-in-interest transactions. Earnings of each investment fund are allocated to participant's accounts in proportion to each participant's share of that fund.

**Vesting**

Participants' contributions, employer matching, and earnings thereon are 100% vested at all times. Discretionary nonelective amounts contributed by the Company vest based upon completed years of service over a six-year period at 20% per year from year two through year six.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested balance. Loan terms range from one to five years but may not exceed five years. The loans are secured by the balance in the participant's account and bear interest at the Prime Rate plus 2%. The interest rates in effect ranged from 5.25% to 10.50%. Principal and interest are paid ratably through payroll deduction each pay period.

**Payment of Benefits**

The Plan provides for the payment of benefits to the participant (or, if applicable, the beneficiary) at retirement, disability, death, financial hardship (as defined in the Plan), or termination of employment. Upon termination, the participants or beneficiaries may elect to leave their account balance in the Plan, receive partial lump sums or receive their total benefits in a lump sum amount equal to the value of the participant's vested interest in their account. Participants may also elect to rollover their account to another tax deferred account. The Plan allows for automatic lump sum distributions of participant vested account balances that do not exceed \$5,000. With the Plan administrator's approval, participants may withdraw all or part of their aggregate contributions in the event of financial hardship.

**Forfeited Accounts**

Forfeitures are retained in the Plan and will first be used to pay administrative expenses. Any remaining forfeitures are then used to reduce employer contributions. Forfeitures remaining in the Plan as of December 31, 2024 and 2023 were approximately \$2,495 and \$4,132, respectively. For the years ended December 31, 2024 and 2023, forfeited nonvested amounts used to pay Plan expenses totaled \$2,790 and \$-0-, respectively. For the years ended December 31, 2024 and 2023, employer contributions were not reduced by Plan forfeitures.

**Administrative Expenses**

Expenses to administer the Plan, if not paid by the sponsor, may be paid by the Plan. Separate fees for loan processing and certain investments as specified in the service agreement, are charged to individual participant's accounts.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The accompanying financial statements of the Plan have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America. Contributions from participants are recorded when withheld from the participant. Benefit payments to participants are recorded when paid.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

The investments in all of the funds, except the insurance contract account, are presented at fair value, based on the quoted market prices of the underlying securities within each fund as of December 31, 2024 and 2023. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants and the measurement date. The insurance contract account is fully benefit-responsive and is reported at contract value.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis and dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

**Fair Value Measurements**

The Plan performs fair value measurements in accordance with Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*. Refer to Note 3 for the fair value measurement disclosures associated with the Plan's investments.

**Net Appreciation in Fair Value of Investments**

The earnings, expenses, realized gains and losses, and unrealized appreciation in pooled separate accounts and other investments are recorded in the accompanying financial statements as net appreciation in fair value of investments.

**Notes Receivable with Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent notes receivable are recorded as distributions on the basis of the terms of the Plan document.

**Benefit Payments**

Benefits are recorded when paid.

**Excess Contributions Payable**

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the excess contributions, if any, to the applicable participants prior to the March 15 deadline.

**Subsequent Events**

The Plan administrator has evaluated subsequent events through July 18, 2025, the date the financial statements were available to be issued.

**NOTE 3 FAIR VALUE**

The Plan performs fair value measurements in accordance with ASC 820. ASC 820 defines fair value as the price that would be received from selling an asset in an orderly transaction between market participants at the measurement date. The accounting guidance for fair value measurement requires an entity to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. The standard establishes a fair value hierarchy based on the level of independent, objective evidence surrounding the inputs used to measure fair value. A financial instrument's categorization within the fair value hierarchy is based upon the lowest level of input that is significant to the fair value measurement.

The fair value hierarchy is as follows:

*Level 1* – Quoted prices in active markets for identical assets or liabilities;

*Level 2* – Inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices in active markets for similar assets or liabilities, quoted prices for identical or similar assets or liabilities in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities; or

*Level 3* – Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Pooled Separate Accounts* – Valued using the net asset value (NAV) of units, as determined by the insurance company. NAV is a readily determinable fair value and is basis for current transactions.

The fair value calculation may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Pooled separate accounts measured at fair value on a recurring basis totaling \$18,890,645 and \$17,099,577 as of December 31, 2024 and 2023, respectively, were all deemed to be Level 2 investments by the Plan management.

**NOTE 4 INSURANCE CONTRACT WITH INSURANCE COMPANY**

The Voya Fixed Account (the Insurance Contract) consists of a fully benefit-responsive insurance contract. Voya maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

**NOTE 4 INSURANCE CONTRACT WITH INSURANCE COMPANY (CONTINUED)**

Because the Insurance Contract is a fully benefit-responsive fund, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the Insurance Contract. Contract value, as reported to the Plan by Voya, represents contributions made under the Insurance Contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

As of December 31, 2024 and 2023, there were no reserves against the contract value for credit risks of the issuer. The interest rates are based upon a formula agreed with the issuer with the requirement that interest rates may not be less than 1%. Such interest rates are reviewed on a semi-annual basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exception from federal income taxes or any required prohibited transaction exemption under ERISA.

The Plan administrator does not believe that the occurrence of any such value contract event, which would limit the Plan's ability to transact at contract value with participants, is probable.

**NOTE 5 CERTIFIED INFORMATION**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The Plan's independent auditors did not perform any auditing procedures with respect to this information certified by Voya Retirement Insurance and Annuity Company, the insurance company, except for comparing such information to the related information included in the financial statements and the supplemental schedule.

The following information, included in the financial statements and supplemental schedule was provided and certified by the Plan's insurance company as complete and accurate:

- Investments as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments and interest income as shown in the statements of changes in net assets available for benefits for the years presented.
- Schedule of assets (held at end of year) as of December 31, 2024.

**NOTE 6 PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contribution account balances.

**NOTE 7 INCOME TAX STATUS**

The Plan has adopted a nonstandardized pre-approved profit sharing plan sponsored by Primark Benefits. The nonstandardized plan provider has received an advisory letter from the IRS as to the nonstandardized plan's qualified status. The nonstandardized plan advisory letter has been relied upon by the Plan. The Plan has been amended since the nonstandardized plan received the advisory letter. The Plan administrator believes that the Plan is designed and is being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8 PARTY-IN-INTEREST TRANSACTIONS**

Plan investments include units of funds managed by Voya. Voya is the insurance company as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

**NOTE 9 RISKS AND UNCERTAINTIES**

The Plan invests in various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 11 CONTRIBUTION TIMING**

The Company remitted employee 401(k) deferral contributions in a timely manner for all standard payroll runs during the year. However, a one-time payroll processed on the last day of the year for a single employee resulted in an inadvertent delay in remitting a \$667 deferral contribution, which was not submitted within the timeframe prescribed by the Department of Labor. The Company self-identified the issue, promptly remitted the contribution, and implemented enhanced procedures to prevent recurrence. Additionally, the Company reviewed detailed payroll records and confirmed that all other employee 401(k) deferral contributions for the year were made timely. This singular delayed remittance is listed in the attached Schedule H, Line 4a.
