## INDEPENDENT AUDITORS' REPORT

To the Retirement Committee of

**Cavco Industries, Inc. 401(k) Plan**

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of **Cavco Industries, Inc. 401(k) Plan** ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. ## NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

### (1) Description of the Plan

The following description of the *Cavco Industries, Inc. 401(k) Plan* (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

**A. General** – The Plan was established on April 1, 1999 and is a defined contribution plan, subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan provides for employee pre-tax, Roth and after-tax contributions, and discretionary matching employer contributions in accordance with Sections 401(k) and 401(m) of the Internal Revenue Code ("IRC"). Employees of Cavco Industries, Inc. (the "Company" or the "Plan sponsor") are eligible to participate in the Plan upon attaining the age of 18 and satisfying the service requirement of 3 months, with the exceptions of residents of Puerto Rico and collectively bargained employees. Employees may enter the Plan on the first day of the month following the date they satisfy the Plan's eligibility requirements.

Beginning in March 2024, the employees of Commodore Homes, LLC, a subsidiary of the Plan sponsor, were merged into the Plan. As a result, assets totaling \$21,292,783 were transferred from the Commodore Homes, LLC 401(k) Retirement Plan and Trust. Effective April 1, 2024, employees previously participating in the Commodore Homes, LLC 401(k) Retirement Plan and Trust became eligible to participate in the Plan.

**B. Plan administration** – The Plan is administered by the Company's Retirement Committee (the Committee). The Committee has the power to carry out the provisions of the Plan including the administration of the Plan, to determine the appropriateness of the Plan's investment offerings and monitor performance. Empower Trust Company, LLC is the directed trustee and has custody of the mutual fund assets and notes receivable from participants. Empower Annuity Insurance Company of America has custody of the guaranteed investment contract. Empower Retirement Plan Services LLC ("Empower") serves as the record keeper.

**C. Contributions** – Each year, participants may contribute a percentage of their pretax annual compensation up to the maximum amount allowed by law, as defined in the Plan. Contributions are subject to certain IRC limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan allows participants to designate contributions as after-tax contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers).

The Company may make a discretionary matching contribution. Eligible employees must have made a pre-tax contribution during the Plan year and be employed on the last day of the Plan year. After-tax and catch-up contributions are not eligible to be matched. For 2024, the match contribution was the lesser of 30% of the participant's deferral or 30% of 5% of a participant's compensation. The discretionary matching contribution for 2024 was paid in March 2025 and is recorded as employer contribution receivable on the statement of net assets available for benefits.

The Plan includes an auto-enrollment provision, whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation, with an automatic increase of 1% annually to a maximum rate of 8% and their contributions invested in an age-weighted fund until changed by the participant.

**D. Participant accounts** – Each participant's account is credited with the participant's contributions, the Plan sponsor's matching contributions, and allocations of the Plan earnings. Participant accounts are charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

(1) **Description of the Plan (continued)**

**E. Investments** – Participants direct the investment of their contributions into various investment options offered by the Plan. Participants may change their investment options daily.

**F. Vesting** – Participants are immediately vested in their contributions plus actual earnings thereon. The participant's vesting in the Plan sponsor's discretionary matching contributions, plus actual earnings thereon, is based on years of credited service. The vesting percentage is based on the following years of credited service:

**G. Distributions** – Participants may elect to receive a lump-sum amount equal to the value of their vested interest as defined in the Plan document upon retirement, termination of service, death, or disability. A terminated employee with a balance of less than \$1,000 may be automatically paid out by the Plan upon termination. Any terminated participants with a balance between \$1,000 and \$5,000 can still be automatically paid out if their balance is rolled into a qualified Individual Retirement Account. Distributions may be made at the participant's election prior to termination upon attainment of age 59 and a half or hardship as defined in the Plan document.

**H. Unallocated accounts** – Unallocated accounts include forfeited non-vested Plan sponsor contributions. At December 31, 2024 and 2023, unallocated accounts totaled \$86,722 and \$60,970, respectively. The accounts may be used to reduce future Plan sponsor matching contributions or to pay certain Plan administrative expenses. During the year ended December 31, 2024, approximately \$228,000 of unallocated non-vested accounts were used to reduce Plan sponsor matching contributions and approximately \$28,000 of unallocated non-vested accounts were used to pay Plan administrative expenses.

**I. Notes receivable from participants** – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years, unless the loan is used for the purchase of a primary residence in which case the term may be extended to fifteen years. Loans are secured by the balance in the participant's account and bear interest at the prime rate at the date the loan is made. Principal and interest are paid ratably through payroll deductions. A participant may have no more than two outstanding notes at any one time.

**J. Plan termination** – Although it has not expressed any intent to do so, the Plan sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan's termination, participants will become 100% vested in their accounts.

### (2) Significant accounting policies

The significant accounting policies followed by the Plan are as follows:

**Basis of accounting** – The Plan follows accounting principles generally accepted in the United States of America using the accrual basis of accounting in preparing its financial statements.

**Management’s use of estimates** – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

**Investment valuation and income recognition** – The Plan’s investments are stated at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan Sponsor determines the Plan’s valuation policies utilizing information provided by the investment advisors. See Note 4 for discussion of fair value measurements.

Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Purchases and sales of securities are recorded on a trade-date basis. Net appreciation of fair value of investments includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

**Administrative expenses** – The Plan permits the payment of administrative expenses to be made from Plan assets. These expenses may be paid using the Plan’s assets in the following methods: (1) allocated among the accounts of all participants, (2) from unallocated accounts (see Note 1), or from a specific participant account if the Plan incurs costs directly attributable to a particular participant in the Plan.

**Risks and uncertainties** – The Plan provides for investments in various fund options, which in turn invest in any combination of stocks, bonds and other investment securities. Investment securities are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in risk in the near term would materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

**Benefits paid to participants** – Benefits are recorded when paid.

**Notes receivable from participants** – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable are recorded as distributions based on the terms of the Plan document.

**Subsequent events** – The Plan’s management has evaluated subsequent events through July 31, 2025, which is the date the financial statements were available to be issued.

### (3) Party-in-interest transactions

Administrative fees paid to the recordkeeper and trustee by the Plan amounted to approximately \$437,000 for the year ended December 31, 2024. Amounts paid to other service providers totaled approximately \$22,000 for the year ended December 31, 2024. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

### (4) Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used should maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common collective trust:* Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily. This investment has no unfunded commitments as of December 31, 2024. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

### (5) Investment contract with insurance company

The Plan entered into a traditional fully benefit-responsive guaranteed investment contract (GIC) with Empower Annuity Insurance Company of America. Empower Annuity Insurance Company of America maintains the contributions in a general account, which is credited with the earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The GIC issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 0%. Such interest rates are reviewed on a quarterly basis for resetting. The GIC does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

Because the GIC is fully benefit-responsive, contract value is the relevant measure for the GIC, as this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value as reported to the Plan by Empower Annuity Insurance Company of America represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The contract value of the investment contract at December 31, 2024 and 2023 was \$8,181,821 and \$7,936,157, respectively.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include Plan termination with 75-day notice by either party. No events are probable of occurring that may limit the ability of the plan to transact at contract value with the contract issuer and that would limit the ability of the plan to transact at contract value with the participants.

### (6) Federal income tax status

The Plan uses a pre-approved plan document sponsored by Empower Trust Company, LLC, which received an opinion letter from the Internal Revenue Service ("IRS"), dated November 14, 2022, stating that the pre-approved document satisfies the applicable provisions of the IRC. The Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

### (7) Information certified by the trustees

The Plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Trust Company, LLC and Empower Annuity Insurance Company of America have certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments
- Notes receivable from participants
- Net appreciation in fair value of investments
- Interest and dividends
- Interest income on notes receivable from participants
- Schedule of assets (held at end of year)

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

**(9) Non-exempt transactions**

The DOL's regulations require defined contribution plans to remit participant contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets but not later than the 15<sup>th</sup> business day of the month following the month in which the participant contributions are withheld by the employer. For the year ended December 31, 2023, the Company failed to remit certain participant contributions to the Plan in a timely manner constituting a lending of such monies to the Company. As such, these transactions represented non-exempt transactions between the Company and the Plan as identified in Schedule H, Line 4(a), Schedule of Delinquent Participant Contributions. These participant contributions, totaling approximately \$2,000, were remitted to the Plan during the year ended December 31, 2024 along with correction for lost earnings on these contributions.
