NOTE 1. DESCRIPTION OF THE PLAN

The Plan was created to enable eligible permanent employees of Rainy Partners, L.L.C. (the "Company") and their beneficiaries to assist in meeting their retirement income requirements by providing a payroll-based savings program and to share in the Company's profits.

The following description of the Rainy Partners, L.L.C. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was established for participation on November 1, 2001 and restated in 2022, and has been amended from time to time since that date. It is a defined contribution plan covering all eligible employees of the Company. Employees covered by a collective bargaining agreement (e.g., a union agreement) and employees who are certain nonresident aliens with no earned income from sources within the United States are not eligible to participate in the Plan unless the agreement requires that the employees be eligible. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Eligibility

Under the provisions of the Plan, each employee shall be eligible to participate in the Plan upon being credited with at least three months of service and attaining the age of 21.

Contributions

Each year, participants may elect to contribute to the Plan through tax-deferred and ROTH salary deferrals up to 100% of their annual compensation, as defined by the Plan, up to a statutory maximum determined by the Internal Revenue Service ("IRS"). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans ("rollover"). Participants direct the investments of all contributions into various investment options offered by the Plan.

Company Matching Contributions

Each year, the Company makes a safe harbor matching contribution of 100% of the first 3% of base compensation that a participant contributes to the Plan and 50% of the next 2%. The Company may also elect to make additional non-safe harbor matching contributions and annual profit sharing contribution at its discretion. For the year ended December 31, 2024, the Company made matching contributions of \$271,421. The Company did not make any discretionary contributions for the year ended December 31, 2024.

Vesting

Participants are immediately vested in their contributions and the Company's safe harbor matching contributions plus actual earnings thereon. Vesting in the Company's non-safe harbor and profit sharing contribution portion of their accounts is based on years of service. A participant vests at a rate of 20% for each year and is 100% vested after five years of credited service.

Hardship Withdrawal

In certain situations, as defined in the Plan agreement and with approval of the Plan Administrator, participants may make hardship withdrawals.

Participant Accounts

All investment options are participant directed. Each participant's account is credited with the participant's contributions and allocations of the Company's contributions, and Plan earnings, and reduced for any Plan losses and administrative expenses. The benefit to which a participant is entitled is the benefit from the participant's vested account.

Notes Receivable from Participants

Participants may borrow from their accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms can be no longer than five years. However, at the Plan Administrator's discretion, for the purchase of a primary residence, loans can be longer. The loans are collateralized by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates in accordance with the Plan's provisions. Principal and interest are paid ratably through payroll deductions. Interest rates for notes receivable from participants outstanding at December 31, 2024 range from 5.25% to 10.50%.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in their account, or annual installments in accordance with the Plan's provisions. In the event that a participant dies before retirement, his or her beneficiary will receive the value of the participant's account balance in a lump-sum distribution, less the value of outstanding loans made to the participant.

Forfeitures

Forfeitures of Company contributions may be used to reduce any administrative expenses and Company matching contributions. At December 31, 2024 and 2023, forfeitures totaled \$105 and \$2, respectively. For the year ended December 31, 2024, there were no forfeitures used to reduced employer contributions or to pay plan expenses.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are being prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year and reinvested interest and dividends.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Notes receivable from participants are secured by the participant's account, therefore no allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Plan, unless otherwise paid by the Company. Fees related to the administration of participants' activities are charged directly to the participants' accounts and are included in administrative expenses. Investment related expenses are included in the net change in fair value of investments.

Payment of Benefits

Benefits are recorded when paid.

Concentration of Credit Risk

Financial instruments which potentially subject the Plan to concentrations of credit risk consist of deposits and securities held by a broker.

Subsequent Events

Subsequent events have been evaluated through July 11, 2025, which is the date the financial statements were available to be issued.

NOTE 3. FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 3 inputs for the periods presented.

Level 1 Fair Value Measurements

The fair value of registered investment companies is based on quoted net asset values of the shares as reported by the fund. The registered investment companies held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The registered investment companies held by the Plan are considered to be actively traded.

Level 2 Fair Value Measurements

The fair value of common/collective trusts is valued at the net asset value ("NAV") of units of a collective investment trust. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. Participant transactions may occur daily.

NOTE 4. INFORMATION PREPARED AND CERTIFIED BY CUSTODIAN

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Voya Retirement Insurance and Annuity Company has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate with respect to investments:

- Investments, at contract value
- Interest and dividend income
- Net earnings and appreciation in fair value of investments
- Schedule of assets (held at end of year)
- Notes receivable from participants

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

NOTE 5. INTEREST CONTRACT WITH INSURANCE COMPANY

The Plan entered into a traditional fully benefit-responsive guaranteed interest contract with Voya Retirement Insurance and Annuity Company ("Voya") starting January 1, 2018. The contracts totaled \$811,880 as of December 31, 2024, and \$455,124 as of December 31, 2023. Voya maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed interest contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer and is reviewed on a quarterly

basis for resetting. The guaranteed interest contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The contract meets the fully benefit-responsive interest contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive interest contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Voya, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

NOTE 6. TAX STATUS OF THE PLAN

The IRS has determined and informed the Company in a letter dated June 6, 2020, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the determination letter, the Plan Administrator and Sponsor's management believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and therefore believe the Plan is qualified and is tax-exempt.

NOTE 6. TAX STATUS OF THE PLAN - Continued

The Plan follows the provisions of ASC 740, *Income Taxes* of the FASB Accounting Standards Codification. The Plan believes it has no uncertain tax positions that qualify for either recognition or disclosure. As of December 31, 2024, due to statutes of limitations, the Plan is no longer subject to examination of its 5500 by the IRS for years prior to 2021.

NOTE 7. TERMINATION OF THE PLAN

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE 8. RISK AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, including interest rate, market and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

NOTE 9. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan investments consist of registered investment companies, common/collective trusts, and a fully benefit-responsive guaranteed interest contract managed by the Voya Retirement Insurance and Annuity Company. The Retirement Advantage ("TRA") provides administrative services to the Plan, and the Voya Retirement Insurance and Annuity Company is the Custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest. Fees paid by the Plan to TRA and the Custodian during the year ended December 31, 2024 was \$4,884. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 10. SEPERATED PARTICIPANTS

At December 31, 2024 and 2023, there were no amounts allocated to accounts of persons who had elected to withdraw from the Plan but have not yet been paid.
