**Note 1 - Plan Description**

The following description of the Children's University Medical Group Tax Deferred Annuity Plan (the Plan) is provided for general information purposes only. More complete information regarding the Plan's provisions may be found in the plan document.

**General** - The Plan is a defined contribution plan established by Children's University Medical Group (the Sponsor or CUMG) under the provisions of Section 403(b) of the Internal Revenue Code (the IRC), which includes a qualified cash or deferred arrangement, for the benefit of eligible employees of the Sponsor. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**Eligibility** - Employees are eligible to participate in the Plan upon date of hire.

**Plan Administration** - The Plan is administered by the Retirement and Benefits Committee, which includes certain employees of the Sponsor and University of Washington Physicians. Fidelity Management Trust Company (Fidelity) is the custodian for certain plan assets. Teachers Insurance and Annuity Association of America (TIAA) and College Retirement Equities Fund (CREF) and Voya Retirement Insurance and Annuity Company (Voya) are issuers of the Plan's annuity contracts.

**Contributions** - Participants may elect to defer up to 90% of their compensation as pre-tax or Roth contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). There are no employer contributions to the Plan.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

**Participant Accounts** - Each participant's account is credited with the participant's contributions and an allocation of plan earnings and losses. Allocations are based on a participant's earnings or account balance. Participant accounts are valued daily.

**Investment Options** - Participants direct the investment of their account into various investment options offered by the Plan. Effective July 1, 2013, all contributions are required to be directed to investment options held by Fidelity. Participants may also direct contributions toward a self-directed brokerage account window. Participants may change their investment elections and make transfers between investment options daily.

**Vesting** - Participants are immediately vested in all contributions to the Plan and earnings thereon.

**Benefit Payments** - Upon termination of service, incurring a disability, or retirement, a participant or beneficiary may elect to receive a lump-sum distribution, installment payments, or an annuity as allowed by the individual agreements governing the investment options selected by participants. Participants who have attained age 59 ½ may also elect to receive a distribution of all or any portion of their account balance prior to termination of employment (in-service withdrawal). The Plan allows for hardship withdrawals in accordance with the provisions specified in the plan document.

**Note 2 - Significant Accounting Policies**

**Basis of Accounting** - The accompanying financial statements are prepared using the accrual basis of accounting.

**Use of Estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amount of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition** - Investments are reported at fair value except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in fair value of investments represents the change in fair value of assets from one period to the next and realized gains and losses on investments.

**Payment of Benefits** - Benefits are recorded when paid.

**Investment Management and Administrative Expenses** - Several of the investment fund options are subject to investment and administrative fees based on a percentage of invested assets, as disclosed in the fund's prospectus. All such fees are charged directly against the fund's investment performance and, therefore, are not separately disclosed in the accompanying financial statements. Transaction based fees are charged directly to participant accounts. The Sponsor pays for administrative expenses not otherwise paid by the Plan.

**Subsequent Events** - The Plan's management has evaluated subsequent events through July 30, 2025, the date on which the Plan's financial statements were available to be issued.

**Note 3 - Fair Value Measurements**

U.S. GAAP provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1 - Unadjusted quoted prices available in active markets for identical assets or liabilities;

Level 2 - Inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices in active markets for similar assets or liabilities, quoted prices for identical or similar assets or liabilities in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities; or

Level 3 - Unobservable inputs that are significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual Funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-Directed Brokerage Accounts - These accounts primarily consist of mutual funds which are valued as previously described.

Variable Annuity Accounts - College Retirement Equities Fund (CREF) is a registered investment company and consists of eight accounts which fund variable annuity contracts issued by CREF. The fair values of accumulation units held in CREF accounts are based on each account's daily published NAV. NAV is based on the market value of its underlying securities determined by market quotations or prices obtained from independent pricing sources. The CREF Money Market Account is valued at amortized cost, which approximates fair value. Accumulation units in CREF accounts are available for transactions at the closing accumulation unit value on any day the New York Stock Exchange (NYSE) is open for business.

Pooled Separate Account - The TIAA Real Estate Account (REA) is a pooled separate account which funds variable annuity contracts issued by TIAA. The fair value of accumulation units held in the REA is published daily and based on market values of the underlying real estate properties determined by external appraisals, which are estimates of property values based on a professional's opinion. The REA may also hold real estate-related marketable securities which are valued using independent pricing sources. Accumulation units in the REA are available for transactions at the closing accumulation unit value on any day the NYSE is open for business. Transfers out of the REA are limited to one per calendar quarter. Pooled separate accounts also include investments held with Voya. Voya separate accounts are valued at the NAV provided by Voya. The NAV is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily.

**Note 4 - Fully Benefit-Responsive Investment Contracts**

The TIAA Traditional Annuity are fixed annuity contracts that are fully and unconditionally guaranteed by TIAA. The Plan holds benefit-responsive TIAA Traditional Annuities through the Supplemental Retirement Annuity (SRA) and Retirement Choice Plus (RCP) contract types. SRA and RCP contracts provide for full participant-directed liquidity and are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value is the aggregation of contributions, plus interest, less any withdrawals.

Sponsor initiated withdrawals from the RCP contract are allowed over a seven year period with a 1.5% surrender charge with 30 days advance written notice from the Sponsor. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with TIAA and that also would limit the ability of the Plan to transact at contract value with participants for the Plan's SRA and RCP contracts.

When participants choose to allocate a portion of their retirement savings to the TIAA Traditional Annuity during the accumulation phase of the contract, their contributions purchase a specific amount of lifetime income based on the contractual rate schedule in effect at the time the premium is paid. The participant's principal, plus a specified minimum rate of interest, is guaranteed by TIAA's claims-paying ability. The TIAA Traditional Annuity also provides the potential for additional interest if declared by TIAA's Board of Trustees. Additional interest, when declared, remains in effect for the declaration year, which begins each March 1 for accumulating annuities, and January 1 for lifetime payout annuities. Additional interest is not guaranteed for future years. Together, the guaranteed minimum and additional amounts make up the crediting interest rate.

The Plan also holds the Standard Stable Asset Fund which funds a group fixed annuity contract issued by The Standard Insurance Company (the Standard). The Standard maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The Standard is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by The Standard which will never be below 1.0% annually. The crediting rate is reviewed on a quarterly basis for resetting.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Therefore, the contract is considered to be fully benefit-responsive and is reported at contract value. Certain events might limit the ability of the Plan to transact at contract value with The Standard. Such events include termination of the contract, spin-offs, divestitures, layoffs, corporate relocation, partial or total plan termination, retirement incentive programs, and the liberalization of plan withdrawal or transfer rules. Upon occurrence of any of these events, a market value adjustment may apply. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with The Standard and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow The Standard to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include the Sponsor's failure to abide by state or federal law, failure to render performance necessary to comply with the terms of the contract, failure to maintain assets of at least \$25,000, plan disqualification, and failure to adopt the Plan in a reasonable period of time.

**Note 5 - Certified Investments**

Certain information in the accompanying financial statements and supplementary information related to investments held as of December 31, 2024 and 2023, and investment income or loss for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, TIAA, CREF, and VOYA Retirement Insurance and Annuity Company, qualified institutions. The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplementary information.

**Note 6 - Tax Status**

CUMG adopted a Fidelity Workplace Services LLC (Fidelity) 403(b) volume submitter plan document. Fidelity received an approval letter from the IRS dated August 7, 2017, which states that the form of the plan document satisfies the applicable provisions of Section 403(b) of the Internal Revenue Code (IRC). The Plan itself has not received a determination letter from the IRS; however, the Plan's management believes that the Plan is designed, and is currently being operated, in a manner that would not jeopardize the tax benefits associated with these arrangements. The Plan is subject to audits by the IRS; however, there are currently no audits for any tax periods in progress.

**Note 7 - Plan Termination**

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to terminate the Plan subject to the provisions of ERISA.

**Note 8 - Party-in-Interest Transactions**

Certain Plan investments are shares of mutual funds managed by affiliates of Fidelity and fixed and variable annuity contracts issued by TIAA and CREF. Transactions with such investments and fees paid by the Plan to Fidelity and its affiliates and TIAA and CREF, qualify as party-in-interest transactions. The Plan entered into a group annuity contract with Standard through the Standard Stable Asset Fund. Transactions with this investment and fees paid from the Plan to Standard qualify as party-in-interest transactions.

**Note 9 - Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events such as a pandemic or international conflict which could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
