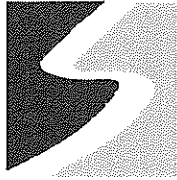

On behalf of our client, attached please find the 2024 Form 5500 for the Pirch, Inc. 401(k) Plan ("Plan"), Plan No. 001. The Employer Identification No. is 26-0565897.

There are several reasons why the independent qualified public accountant's report is not included with the 2024 Form 5500. Pirch, Inc. ceased operations on April 19, 2024. On April 19, 2024, the company and Plan Sponsor filed a voluntary petition under Chapter 7 of the Bankruptcy Code. My firm represents the Chapter 7 Trustee with respect to the Plan matters and termination.

Due to the company's bankruptcy, there are very little assets available to pay expenses other than secured creditors. The high cost of engaging an outside CPA firm to audit the Plan's financials for 2024 (approximately \$30,000), the unavailability of employees' personnel files which have not been provided to the Chapter 7 Trustee, combined with the bankruptcy of the Plan Sponsor, and the very limited remaining assets, compelled the Chapter 7 Trustee to initiate termination of the Plan under the supervision and at the direction of the Bankruptcy Trustee. The Plan Sponsor has very little tangible assets to pay costs for Plan termination. The Plan has distributed a substantial amount of its assets and is working closely with the Bankruptcy Trustee to expedite closure of the Plan.

Reasonable Cause Has Been Determined

Even assuming the records were available to permit an audit to be performed (which they are not), it will cost the Plan over \$30,000 to perform an audit for the 2024 Plan Year. The Plan's assets are not at risk as they are being supervised by a liquidating

trustee appointed by and answering to the Bankruptcy Court. In addition to the extra time that would be needed to complete the 2024 audit (further delaying the Plan's termination), any money needed to pay for the 2024 audit will have to be paid from the Plan's assets. Because the Plan termination will be supervised by the liquidating trustee, subject to the ongoing oversight of the Bankruptcy Court, and because the Plan's assets are invested in money market and similar investment accounts where they have been for at least the past three years and are now being liquidated to provide cash to accommodate distributions and necessary Plan legal and administrative expenses, there is reasonable cause to waive the requirement that an independent audit be performed for the 2024 Plan Year.
