NOTE A - DESCRIPTION OF PLAN

The following description of the eShipping LLC 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan, established January 1, 2011, is a defined contribution plan sponsored by eShipping LLC (the "Company" or "Plan Sponsor") for the benefit of substantially all eligible employees of the Company and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). The Company, the Plan administrator, is responsible for the oversight of the Plan. Effective January 1, 2022, the Plan changed its name from Engaged in Life, LLC 401(k) Plan to eShipping LLC 401(k) Plan.

Contributions

Each Plan year participants may elect to make pre-tax or Roth salary deferral contributions of 1% to 85% of eligible compensation, as defined in the Plan, not to exceed the maximum amount allowed by the Internal Revenue Code ("IRC"). Participants direct the investment of their contributions into various investment options offered by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions to the Plan.

Participants have the option to automatically escalate their contributions by 1% each year. Automatic escalation takes effect on the first payroll following the annual increase effective date that the employee elected when signing up for the Smart Save feature. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Company has elected to match 50% of participant contributions up to a maximum of 6% of eligible compensation. The percentage of elective deferrals to be matched is determined by the Company and is allocated to participants at each pay period throughout the year. The Company's contributions are subject to the maximum allowable under the IRC.

Participant Accounts

Each participant's account is credited or charged, as appropriate, with the participant's contributions and withdrawals, and allocations of Company contributions and Plan earnings and losses. Allocations are based on participant earnings or account balances, as defined. From time-to-time, Plan administrative costs including, but not limited to, legal, consulting, and accounting fees, may be paid by the Plan or the Plan Sponsor. If expenses are paid by the Plan, they may be allocated to participants' accounts. Administrative fees for certain services or transactions that a participant may request will be charged directly to the participant's account. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Eligibility

Participants must be 18 and employed at the Company to participate in the Plan. No minimum service period is required.

Vesting

Participants are immediately and fully vested in their voluntary contributions plus actual earnings thereon. Participants are vested in their Company contributions based on the following schedule:

The Company's contributions are also 100% vested on the date the participant should die, become fully disabled, or reach the retirement age of 65.

Notes Receivables from Participants

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum amount equal to the lesser of \$50,000 or 50% of their total vested account balance. Participants can only have one loan outstanding at any time. Participant loans are secured by the balance in the participant's account and bear interest based upon the prime rate as published in The Wall Street Journal on the 14th of each month, plus two percentage points, at the date of the execution of the loan. The interest rate is effective for any loans processed as of the 16th day of the month. Principal and interest is paid ratably through monthly payroll deductions. As of December 31, 2024 and 2023, interest rates for outstanding participant loans ranged from 10.50% to 5.25%, respectively.

Payment of Benefits

Upon termination of service for any reason (retirement, termination, disability, or death), a participant with a balance of \$5,000 or greater may choose to receive installment payments, request partial withdrawal, or defer receiving payments until age 72. In addition to these events, the Plan permits active participants to receive an in-service distribution from their accounts if they have an immediate and heavy financial need. If payments are deferred, the account balance will continue to be invested at the direction of the participant. For vested balances less than \$5,000, less any rollover contributions accounts, the Plan Sponsor can initiate payment of the full account balance. If the amount of the distribution is \$1,000 or greater, and no distribution election is made by the participant, the distribution will be directly rolled over to a traditional IRA. If any portion of the account balance is attributable to a Roth elective deferral or Roth rollover contribution account, it will be automatically rolled over into a Roth IRA. If either portion of the unelected balance is less than \$1,000, the distribution will be distributed to the participant in a lump sum. If a participant dies, the value of the account will be used to provide a death benefit to a beneficiary through either a distribution or a rollover of a lump sum to another qualified plan or IRA. Participants may withdraw all or part of their vested account balances once they reach the retirement age of 59½.

Forfeited Accounts

Forfeitures are used to reduce Company matching contributions or to pay expenses. Forfeitures used to reduce Company matching contributions must be applied for the Plan year in which the forfeiture occurs. Accordingly, for the year ended December 31, 2024, forfeitures used to reduce Company matching contributions totaled \$84,120. As of December 31, 2024 and 2023, there was no balance in the forfeiture account.

Plan Termination

Although it has not expressed any intent to do so, the Company reserves the right to terminate the Plan at any time, subject to Plan provisions and the provisions of ERISA. Upon termination of the Plan, the interest of each participant in the trust fund will be distributed to such participant or his or her beneficiary or, if none, his or her legal representative at the time prescribed by the Plan terms and the applicable provisions of the IRC. Furthermore, upon termination of the Plan, an affected participant's account balance shall be 100% vested.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements follows.

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for a discussion of fair value measurements.

Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year. Purchases and sales of securities are recorded on a trade-date basis (the date the order to buy or sell is executed). Interest is accrued as earned and dividend income is recorded on the ex-dividend date.

Notes Receivables from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments the participant's loan will be deemed to be in default, and the loan balance is reduced and a benefit payment is recorded. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the initiation of notes receivable from participants are charged directly to participants' accounts. Investment related expenses are included in net appreciation in fair value of investments. Investment related expenses include, but are not limited to all reasonable costs, charges and expenses incurred by Reliance Trust Company (the "Trustee") in connection with the administration of the trust and investments (including such reasonable compensation to the Trustee as may be agreed upon from time to time between the Plan Sponsor and the Trustee, including any costs for legal services incurred by the Trustee).

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and Uncertainties

The investments provided by the Plan are exposed to various risks, such as interest rate, credit, and overall market volatility. Because of the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' balances and amounts reported in the statements of net assets available for benefits.

Tax Status

The Internal Revenue Service ("IRS") issued an opinion letter dated October 10, 2020, stating that the form of prototype plan used by the Plan is acceptable under Section 401 of the IRC. Although the Plan has been amended since the opinion letter was issued, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and the Plan is exempt from federal income taxes.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Subsequent Events

The Plan has evaluated subsequent events through July 31, 2025, which is the date the financial statements were available to be issued.

NOTE C - INFORMATION CERTIFIED BY TRUSTEE

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Trustee of the Plan has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments at fair value and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net investment income and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024.

NOTE D - FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board Accounting Standard Codification 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value, which provides a fair value hierarchy that prioritizes inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are as follows:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The determination of where an asset or a liability falls in the hierarchy requires significant judgment. The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value:

Mutual funds - Valued based principally on quoted market prices of the underlying assets. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective trust - A stable value fund valued at the NAV of units of the collective trust. The NAV is calculated by the fund based on net assets, which includes fully benefit-responsive investment contracts at contract value. This NAV represents the Plan's fair value since this is the amount at which the Plan transacts with the fund and is used as a practical expedient to estimate fair value. The investment objective of the collective trust ("CT") fund held by the Plan is to seek the preservation of principal and to provide interest income under prevailing market conditions and rates, consistent with seeking to maintain required liquidity. The fund invests in numerous fixed income investments including, but not limited to, U.S. treasury securities, corporate bonds, mortgage backed securities, asset backed securities, and commercial mortgage backed securities.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different estimate of fair value at the reporting date. There has been no change in the methods applied to the assets to measure fair value during the year ended December 31, 2024.

The assets of the CT are maintained by Invesco Trust Company. A NAV per unit or unitization for each underlying investment option is maintained. Participant transactions in the underlying investment options are transacted at the applicable investment option's NAV per unit. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value daily and without notice to Invesco. Plan withdrawals from the CT fund, other than for benefit payments and participant transfers may be made by the Plan up to 12 months after notification is received. At December 31, 2024 and 2023, there were no other restrictions.
