## Independent Auditor's Report

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Gulf Coast Hotel Management Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ### Notes to Financial Statements

#### 1. Description of Plan

The following description of the Gulf Coast Hotel Management Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document or Summary Plan Description for a more complete description of the Plan's provisions, which are available from the Plan administrator.

**General** - The Plan is a defined contribution plan established effective January 1, 2017, and restated October 6, 2020. The Plan covers all employees, excluding non-resident alien employees and residents of Puerto Rico employees, of Gulf Coast Hotel Management, Inc. (the Company) who have completed one month of service and are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Company's principal members of management (Management) are responsible for oversight of the Plan. The Plan's management determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to Management. Reliance Trust Company is the trustee of the Plan and also serves as the Plan custodian.

**Contributions** - Each year, participants may contribute up to 90 percent of pretax annual compensation, as defined in the plan document, up to the maximum limits of the Internal Revenue Code (IRC). Participants also may designate all or a portion of their deferral contributions as after-tax contributions into a Roth account. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Company contributes a non-discretionary match of 25 percent of the first 6 percent of base compensation that a participant contributes to the Plan. Additional discretionary amounts may be contributed by the Company at the option of Management. For the years ended December 31, 2024 and 2023, respectively, there were no discretionary contributions to the Plan. Contributions are subject to certain IRC limitations.

**Participant investment account options** - Participants direct the investment of all their contributions into various investment options offered by the Plan and may change their investment options at any time. The Plan currently offers 23 mutual funds and 6 common/collective trusts as investment options for participants.

#### 1. Description of Plan (continued)

**Participant accounts** - Each participant's account is credited with the participant's contributions, Company matching contributions, allocations of the Company's discretionary contributions and an allocation of the Plan's earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting** - Participants' contributions and amounts rolled over or transferred into the Plan, plus actual earnings are 100% vested immediately.

Employer contributions not already fully vested when contributed are subject to the following vesting schedule:

**Payment of benefits** - On termination of service due to death, disability, or retirement, a participant (or beneficiary, if applicable) may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or installment payments as provided in the plan document. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. If a terminated participant's vested balance is less than or equal to \$5,000, the amount may be automatically distributed in the form of lump sum cash payment. In addition, the Plan allows for hardship distributions if certain criteria are met.

**Forfeited accounts** - As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$10 and \$10, respectively. These accounts can be used to reduce future employer contributions or to pay plan administrative expenses. During 2024 and 2023, employer contributions were reduced by \$9,452 and \$8,431, respectively, from forfeited nonvested accounts, in accordance with plan provisions.

#### 2. Summary of Accounting Policies

**Basis of accounting** - The financial statements of the Plan are prepared on the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America.

**Use of estimates** - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment valuation and income recognition** - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's administrator determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company, as applicable. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Unit values** - Individual participant accounts for the common collective trust funds are maintained on a unit value basis. Participants do not have beneficial ownership in the specific underlying securities or other assets in the funds but do have an interest therein represented by units valued daily. The funds earn dividends and interest which are automatically reinvested in additional units.

Generally, contributions to and withdrawals from the funds are converted to units by dividing the amounts of such transactions by the unit values as last determined, and the participants' accounts are charged or credited with the number of units properly attributable to each participant.

#### 2. Summary of Accounting Policies (continued)

**Excess contributions refundable** - Amounts refundable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability with a corresponding addition to benefits paid to participants. The Plan distributed 2023 excess contributions to the applicable participants prior to March 15, 2024. There were no excess contributions refundable as of December 31, 2024.

**Payment of benefits** - Benefits are recorded when paid. There were no benefits requested before year end that were not paid.

**Administrative expenses** - Certain administrative expenses of maintaining the Plan are paid by the Company and are not included in the statements of changes in net assets available for benefits. Fees related to the administration for payment of benefits are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments. For the years ended December 31, 2024 and 2023, plan expenses total \$3,640 and \$2,071, respectively.

**Subsequent events** - The Plan has evaluated subsequent events through the date of this report, which is the date the financial statements were available to be issued. No significant items were noted during this evaluation that would require disclosure in the financial statements or accompanying footnotes.

#### 3. Information Certified by Custodian

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Reliance Trust Company, the trustee and custodian of the Plan, has certified to the completeness and accuracy of all investments reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the supplemental Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity reported in the Statements of Changes in Net Assets Available for Benefits for the years ended December 31, 2024 and 2023.

The Plan's independent auditor did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

#### 4. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820, *Fair Value Measurement*, are described as follows:

Level 1 - Inputs to the valuation technique are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation technique include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

#### 4. Fair Value Measurements (continued)

Level 3 - Inputs to the valuation technique are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits. There have been no significant changes in the techniques used during the years ended December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded (Level 1).

*Common/Collective trusts:* Valued at the year-end NAV of units of each bank collective trust fund. The NAV, as provided by the trustee, is used as a practical expedient to estimating fair value. The NAV is based on the fair value of the underlying investments held by the respective fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

The preceding methods described may produce a fair value calculation that may not be indicative of the net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### 5. Common/Collective trusts

State Street Common/Collective Trusts - The Plan is invested in several State Street common/collective trusts. These include the State Street S&P MidCap Index Non-Lending Series Fund, State Street Russell SmallCap Index Securities Lending Series Fund, State Street U.S. Inflation Protected Bond Index Non-Lending Series Fund, State Street International Index Securities Lending Series Fund, and State Street S&P 500 Index Fund IX. The funds invest in securities and derivative instruments (equity investments, collective investment funds and fixed income investments) that are considered to be Level 1, Level 2, and Level 3 investments and valued at NAV each business day.

Invesco Stable Asset Trust - The Invesco Stable Asset Trust is a collective trust fund and considered to be a stable value fund. The purpose of this fund is to invest/reinvest collectively in assets of eligible entities. The fund does not invest directly in fully benefit-responsive contracts, rather it invests in the underlying assets (investment contracts) and enters in a "wrapper" contract issued by a third party.

The funds described above are all valued at NAV of the units of each individual collective trust. The NAV is calculated daily and net investment income and realized and unrealized gains and losses on investments are not distributed but rather reinvested and reflected in the NAV of the fund. The funds are valued at fair value and then adjusted by the issuer to contract value. Contract value represents contributions made to the funds, plus earnings, less participant withdrawals and is considered to be representative of fair value. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value however, certain events limit the ability of the Plan to transact at contract value with the issuer.

Such events include the following: (1) participant withdrawals based on advice or direction, (2) changes to the Plan which establish investment options or investment objectives so as to constitute or create competing funds, (3) Plan administrator establishes a new eligible plan or amends an existing eligible plan, and such plan covers participants in the participating Plan and offers a competing fund, or (4) participating Plan makes a withdrawal for any reason other than participant-directed withdrawals. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants are probable of occurring. Units of the funds are issued and redeemed at current net asset value.

(f) The objective of this fund is to seek an investment return that approximates as closely as practicable, before expenses, the performance of the TIPS Index over the long term, while providing participants the ability to purchase and redeem units on an "as of" basis.

#### **6. Related-Party and Party In Interest Transactions**

The Plan made direct payments to ADP, Inc. for recordkeeping services in the amount of \$3,640 and \$2,071 for the years ended December 31, 2024 and 2023, respectively, which were not covered by revenue sharing and are considered to be party-in-interest transactions under ERISA. These expenses are included in the accompanying statements of changes in net assets available for benefits as administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments and were paid to ADP Broker-Dealer. The Plan sponsor pays directly any other fees related to the Plan's operations.

#### **7. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

#### 8. Tax Status

The Plan adopted a pre-approved plan offered by ADP Retirement Services. The pre-approved plan received an IRS Opinion Letter dated October 6, 2020, that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code (IRC). The Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore believes that the Plan is qualified, and the related trust is tax exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress (2021 and after).

#### 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### 11. Other Matter

During 2023, it was noted that due to an interpretation difference in the Plan document, deferrals and matching contributions were not made or applied to holiday gift payments paid as part of the Plan sponsor's payroll.

For the Plan year ending December 31, 2023, Management estimated the employee deferrals and employer match amounts that possibly should have been remitted into the Plan to be \$103 and \$21, respectively. Due to the nature of these errors, Plan management was advised by the Plan recordkeeper that a correction is not necessary and they do not believe the amounts are material to the 2023 financial statements. Plan management made the necessary updates to the Plan sponsor's payroll system.
