Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibility for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Supplemental Schedule Required by ERISA

The supplemental Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024, is presented for the purpose of additional analysis and is not a required part of the financial statements but is required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

A. Description of Plan

The following description of the EAG Services, Inc. 401(k) Profit Sharing Plan & Trust (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. *General.* The Plan is a defined contribution plan covering substantially all employees, other than union, non-resident aliens, and leased employees, of EAG Services, Inc. (the Plan Sponsor). The Plan Sponsor is a member of a controlled group, which includes the following participating employers (collectively, the Employer or Company):

EAG Educational Services Incorporated
EAG One Source, Incorporated
EAG Operating Incorporated

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Committee is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings, and monitors investment performance.

2. *Eligibility.* Employees become eligible to participate in the Plan, for both employee and Employer matching contributions, upon attaining age 21. Entry date is the first day of the month coinciding with or next following eligibility requirement being met. Employees are eligible for Employer nonelective contributions upon attaining age 21 if they are employed on the last day of the Plan year.
3. *Contributions.* Each year, participants may contribute up to 90% percent of pre-tax or after-tax annual compensation, as defined in the Plan agreement. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan includes an automatic elective deferral provision of 3% of eligible compensation. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Employer may make a discretionary matching contribution to the Plan. Nonelective contributions may also be contributed at the option of the Employer. No such Employer contributions were made to the Plan for 2024. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

4. *Participant accounts.* Each participant's account is credited with the participant's contributions and Employer matching contributions, if any, as well as allocations of the Employer's nonelective contributions, if any, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

5. *Vesting.* Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Employer contributions portion of their accounts is based on years of continuous service. Employer contributions are vested using a three-year graded schedule. Separate rules apply in the event of disability or death of a participant.
6. *Notes receivable from participants.* Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate is set at 1% above the prime rate, as defined. Principal and interest is paid ratably through regular payroll deductions.
7. *Payment of benefits.* Upon termination of service due to death, disability, or retirement, a participant can receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, equal installments, or partial withdrawals. Distributions after termination of employment for reasons other than the above shall commence as soon as administratively feasible. Participant consent is required for account distributions over \$7,000. In addition, the Plan allows for hardship distributions if certain criteria are met.
8. *Forfeited accounts.* At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$22,542 and \$17,395, respectively. These accounts will be used to reduce future Employer contributions or Plan expenses. In 2024, no forfeitures were used to reduce Employer contributions or Plan expenses.

B. Summary of Accounting Policies

1. *Basis of accounting.* The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).
2. *Use of estimates.* The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.
3. *Investment valuation and income recognition.* Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Committee determines the Plan's valuation policies utilizing information provided by the trustee and investment advisors.

- Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes gains and losses on investments bought and sold as well as held during the year.
4. *Notes receivable from participants.* Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis.
 5. *Payment of benefits.* Benefits are recorded when paid.
 6. *Excess contributions payable.* The Plan is required to return contributions received during the Plan year in excess of the Internal Revenue Code (IRC) limits. These amounts have been recorded as liabilities on the statements of net assets available for benefits.
 7. *Expenses.* Certain expenses of maintaining the Plan are paid directly by the Employer and are excluded from these financial statements. Expenses related to notes receivable from participants and distributions are charged directly to the participant's account and are included in administrative expenses. Recordkeeping and administrative fees are charged directly to administrative expenses. Investment related expense are included in net appreciation/depreciation in fair value of investments.
 8. *Subsequent events.* The Plan has evaluated subsequent events through, July 30, 2025, the date the financial statements were available to be issued. Effective January 1, 2025, the Plan made a Safe Harbor election (calculated as 100% of the first 2% plus 50% up to 6% of participant deferred compensation). Safe harbor contributions are subject to a two-year cliff vesting schedule. The Plan's automatic elective deferral provision was increased to 6% of eligible compensation effective January 1, 2025. The Plan adopted super catch-up provisions under SECURE 2.0 effective January 1, 2025.

C. Certified Information

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company, LLC, the trustee, has certified that the following data included in the Plan's financial statements and supplemental schedule is complete and accurate.

D. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/Collective trust: Valued at NAV of the underlying investments of participant units held by the Plan as of the last trading day of the period, as reported by the managers of the trusts.

F. Party in Interest Transactions

Certain Plan investments were managed by the trustee, and therefore, these transactions qualify as party in interest transactions. Additionally, fees were paid to parties in interest for recordkeeping and administration during the year ended December 31, 2024.

G. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their entire account.

H. Tax Status

The Plan adopted a non-standardized defined contribution plan with CODA that has received an opinion letter dated October 6, 2020, in which the Internal Revenue Service stated that the non-standardized plan was in compliance with the applicable requirements of the IRC. The Plan Administrator believes that the Plan is designed and is being operated in compliance with the applicable requirements of the IRC.

GAAP requires Plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

I. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
