**NOTE 1 - PLAN DESCRIPTION**

The following description of Alcami Corporation 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

***General***

The Plan is a defined contribution plan covering all employees of Alcami Carolinas Corporation (the Plan Sponsor, Company or Employer). The Plan Administrator is responsible for oversight of the Plan. The 401(k) Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's Board of Trustees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

***Contributions***

Participants may contribute up to 75% of pretax annual compensation, as defined in the Plan. Participants are also permitted to contribute Roth after-tax deferrals to the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers). The Company will make safe harbor matching contributions equal to the sum of 100% of the amount of a participant's elective deferrals that do not exceed 3% of the participant's eligible compensation, plus 50% of the amount of the participant's elective deferrals between 3% and 5% of the participant's eligible compensation. The Company may make an additional matching contribution, at its discretion, in an amount not to exceed 4% of a participant's eligible compensation. The Company did not elect to contribute an additional discretionary matching contribution during 2024. The Company may also make discretionary profit-sharing contributions to the Plan. There were no discretionary profit-sharing contributions for the year ended December 31, 2024. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

***Investment Options***

Upon enrollment in the Plan, a participant may direct all contributions to selected investments as made available and determined by the Plan Administrator in 1% increments. Participants may change their investment options daily.

***Participant Accounts***

Each participant's account is credited with the participant's and Company's contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Participants are vested immediately in their contributions and in safe harbor matching contributions, plus actual earnings thereon. Participants are 100% vested in discretionary employer matching contributions after one year of service, and in any discretionary profit sharing contributions after six years of service.

***Payment of Benefits***

The Plan permits withdrawals when a participant terminates employment, reaches retirement age, or becomes disabled or deceased. In-service withdrawals are also permitted for certain financial hardships or when a participant attains age 59½. Benefits are payable in lump-sum payments with certain exceptions allowed. The age requirement for minimum distributions is 73.

#### ***Forfeitures***

Forfeitures are used to reduce future employer contributions or pay Plan expenses. Forfeited nonvested accounts totaled \$347 and \$0 at December 31, 2024 and 2023, respectively. During 2024, \$8,189 of forfeitures were used to reduce employer matching contributions.

#### ***Notes Receivable from Participants***

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000. Loan terms range up to five years or over a reasonable period of time for the purchase of a participant's primary residence, as established by the Plan Administrator at the time of the loan. The loans are collateralized by the vested balance in the participant's account and bear interest at a rate commensurate with the prime rate as published in the Wall Street Journal on the 14th day of each month, plus 1%. These rates range from 4.25% to 9.50% on loans outstanding at December 31, 2024, and mature through 2029. Principal and interest are paid ratably through bi-weekly payroll deductions.

### **NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

#### ***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting.

#### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires the Plan's management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

#### ***Investment Valuation and Income Recognition***

Investments are reported at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's 401(k) Investment Committee determines the Plan's valuation policies by utilizing information provided by the Trustee, Reliance Trust Company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investment securities are exposed to various risks, such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near-term and such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make the scheduled repayments and the Plan Administrator deems the participant to be in default, the participant's note receivable is reduced and a benefit payment is recorded based on the terms of the Plan.

***Payment of Benefits***

Benefits are recorded when paid.

***Administrative Expenses***

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Administrative expenses include fees related to the administration of notes receivable that are charged directly to the participant's account and certain record keeping fees paid by the Plan. Investment related expenses are included in net appreciation in fair value of investments.

**NOTE 3 - INFORMATION CERTIFIED BY RELIANCE TRUST COMPANY (TRUSTEE)**

The Plan Administrator has elected the method of annual reporting compliance permitted by 20 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**NOTE 4 - FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described below:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Registered investment companies (mutual fund):* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common collective trust:* Valued at the NAV of shares in each account held by the Plan at year end. The NAV is not a public-quoted price in an active market. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value.

To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another.

The Plan evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits.

#### NOTE 5 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Reliance Trust Company is the trustee of the Plan; therefore, transactions with the Trustee qualify as party-in-interest transactions. The Plan paid no fees to the trustee during the Plan year ended December 31, 2024. Automatic Data Processing Retirement Services is the record keeper of the Plan; therefore, transactions with the recordkeeper qualify as party-in-interest transactions. Fees paid by the Plan to the recordkeeper totaled \$135,637 for the year ended December 31, 2024. Morgan Stanley is the Registered Investment Advisor (Advisor) of the Plan; therefore, transactions with the Advisor qualify as party-in-interest transactions. Fees paid by the Plan to the Advisor totaled \$61,453 for the year ended December 31, 2024. The Company also paid certain administrative expenses of the Plan.

Notes receivable are due from participants. These transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

#### NOTE 6 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

#### NOTE 7 - TAX STATUS

Effective October 1, 2016, the Plan adopted a non-standardized form of a prototype plan sponsored by Automatic Data Processing Retirement Services. The prototype plan has received an opinion letter from the IRS as to the prototype plan's qualified status. The prototype plan opinion letter, dated October 6, 2020, has been relied upon by this Plan. The Plan has been amended since October 6, 2020; however, the Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken any significant uncertain tax positions that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdiction; however, there are currently no audits for any tax periods in progress.

**NOTE 8 - SUBSEQUENT EVENTS**

Effective January 1, 2025, the Plan changed trustees, transferring all participants balances to ADP Retirement Trust Services, LLC. Additionally, on January 1, 2025, the Plan was amended to include certain short term disability and paid paternity benefits as eligible compensation. Plan management has evaluated subsequent events occurring after December 31, 2024 through July 31, 2025, the date the financial statements were available to be issued and identified no other subsequent events that would require recognition or disclosure in the financial statements.
