We have conducted an ERISA Section 103(a)(3)(C) audit of the financial statements of MPI MGMT LLC d/b/a Olshan Properties 401(k) Plan (the "Plan") as of and for the year ended December 31, 2024 and have issued our report thereon dated July 30, 2025. Professional standards require that we advise you of the following information related to our audit.
