INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Bend Surgery Center, LLC Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Bend Surgery Center, LLC Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Opinion

1. Plan Description

The following description of Bend Surgery Center, LLC Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of Bend Surgery Center, LLC (the Employer) who have completed one hour of service during the first three months of employment. There is no minimum age requirement for participation in the Plan. The Plan's most recent restatement was effective October 1, 2022. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Contributions

Participants may contribute pre-tax and/or Roth after-tax earnings up to 90 percent of their eligible compensation. Participants may also contribute rollover amounts, representing distributions from other qualified plans. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Plan has an automatic enrollment provision. Participants becoming eligible are automatically enrolled to contribute 6 percent of their eligible compensation with the contribution rate being automatically increased by an additional 1 percent each year until the contribution rate reaches 12 percent of eligible compensation. Participants have the option to elect out of the automatic enrollment prior to the first contribution. Participants who are automatically enrolled can also opt out of the automatic annual contribution rate increases.

The Employer may make discretionary profit sharing contributions to participants allocated on an employee by employee basis in amounts determined by the Employer. Only those employees who have completed at least 12 consecutive months of service with 1,000 hours of service during the Plan year and are employed on the last day of the Plan year are eligible for profit sharing contributions. There are provisions in the Plan to permit eligibility for profit sharing contributions to participants whose death, disability, termination after normal retirement age or termination after early retirement occurs during the Plan year. The Plan made discretionary profit sharing contributions of \$548,980 and \$526,523 for the years ended December 31, 2024 and 2023, respectively, and applied \$32,888 and \$27,618, respectively, of available forfeitures toward the funding of the contributions.

Contributions are subject to certain limitations, including those set forth by the Internal Revenue Code.

Participant Accounts

Participants may direct the investment of their accounts into various mutual fund investment options offered through ADP Retirement Services. All accounts are fully participant-directed. Each participant's account is credited with the participant's contributions, the Employer's contributions, and plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, in accordance with the Plan's provisions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1. Plan Description, continued

Vesting

Participants are immediately vested in their elective contributions plus actual earnings thereon. Vesting in the Employer's contribution portion of their accounts is based on years of continuous service as defined in the Plan. A participant is 100 percent vested after 6 years of service with the Employer.

Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant (or their beneficiaries) may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. In-service withdrawals are allowed at age 59½ from all accounts that are fully vested. In addition, in-service distributions are permitted in the event of a hardship event, subject to certain conditions. Hardship distributions may be made from all accounts.

Notes Receivable from Participants

Participants may borrow a minimum of \$1,000 from their fund accounts or up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. Loans are permitted each year; however, only one loan may be outstanding at any point in time. The loans are secured by the balance in the participant's account and will bear a reasonable rate of interest. Principal and interest will be repaid ratably through monthly payroll deductions over a reasonable period of time, not to exceed five years. Loans for the purchase of a primary residence can be repaid over a period equal to the lesser of 30 years or the repayment period. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Forfeited Accounts

Forfeitures of terminated participants' non-vested portions of Employer contributions may be used to reduce subsequent Plan contributions or to fund administrative expenses. During the years ended December 31, 2024 and 2023, \$27,618 and \$10,038 from the forfeited non-vested accounts was used to reduce employer contributions, respectively. As of December 31, 2024 and 2023, the balance of unused forfeitures was \$28,127 and \$21,531, respectively, all of which was applied to reduce the subsequent funding of Employer profit sharing contributions.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Contributions

Participant contributions and the employer match and profit-sharing contributions are recorded in the year in which the participant contributions are withheld from compensation.

Investment Valuation and Income Recognition

Plan investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Investment income is recorded on the accrual basis. Net change in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Revenue Sharing

The Plan contains a revenue sharing expense offset arrangement where the Plan is credited a monthly amount based on a percentage of plan assets which is used to offset expenses. For the years ended December 31, 2024 and 2023, \$27,036 and \$22,098, respectively, was credited to the account and used to pay Plan expenses. There was no ending balance in the Plan's revenue sharing account as of December 31, 2024 and 2023.

Administrative Expenses

Certain administrative expenses such as loan fees and account maintenance fees for terminated employees are paid by the Plan from those affected participants' accounts. Other expenses such as professional fees may be paid by the Employer or the Plan, at the election of the Plan Administrator. Expenses paid by the Employer are excluded from these financial statements. Investment-related expenses, other than revenue-sharing credits paid directly to the Plan's financial advisor, are included in the net change in fair value of investments.

Recent Accounting Standard Adopted

On January 1, 2023, the Plan adopted Accounting Standards Update (ASU) 2016-13 Financial Instruments – Credit Losses (Topic 326): *Measurement of Credit Losses on Financial Instruments*, and all related amendments (ASC 326), which replaced the incurred loss methodology for recognizing credit losses with an expected loss methodology that is referred to as the current expected credit loss (CECL) methodology. CECL requires an estimate of lifetime expected credit losses to be recognized for financial assets based on historical experience, current conditions, and reasonable and supportable forecasts, and for the financial assets to be presented at the net amount expected to be collected on the statements of net assets available for benefits. The financial assets held by the Plan that are subject to ASC 326 are employer contributions receivable and participant contributions receivable. There was no impact to the financial statements as a result of adopting this standard.

3. Information Prepared and Certified by the Plan's Trustee

The Plan Administrator has elected the method of compliance as permitted by 29 CFR 2520.130-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. All investment information disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, notes receivable from participants and related interest income on notes receivable from participants, net change in fair value of investments, and dividend income for the years then ended, were obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Reliance Trust Company, the Plan's trustee. The Plan's independent auditor did not perform auditing procedures with respect to this information, except for comparing the information with the information included in the financial statements and supplemental schedule.

4. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Registered investment companies: Quoted market prices are used to value each fund based on the net asset value (NAV) of shares held by the Plan at year end. All mutual funds held by the Plan are open-end mutual funds that are registered with the SEC and are considered to be actively traded.

5. Tax Status

The Plan has adopted a prototype non-standard profit-sharing plan with CODA. ADP, LLC, the sponsor of the prototype, obtained its latest opinion letter dated October 6, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRS. Therefore, no provision for income taxes has been made in the financial statements.

5. Tax Status, continued

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination, based on the technical merits of the position. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

7. Related Party Transactions

Administrative fees paid directly to an affiliate of Reliance Trust Company, the trustee, for recordkeeping services were \$25,117 and \$25,137 for the years December 31, 2024 and 2023, respectively. These party in interest transactions are exempt from the prohibited transaction rules of ERISA.

8. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of full or partial Plan termination, affected participants would become 100 percent vested in their accounts.

9. Subsequent Events

Management evaluates events and transactions that occur after the statement of net assets available for benefits date as potential subsequent events. Management has performed this evaluation through the date of the independent auditor's report.
