Notes to Financial Statements

1 - Description of Plan

The following description of the Bright Industries, LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

A. General - The Plan became effective February 15, 2017 and is a defined contribution 401(k) plan covering all eligible employees of Bright Industries, LLC (the “Sponsor”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and is intended to be a qualified retirement plan under the Internal Revenue Code.

B. Contributions - Participants may voluntarily contribute to the Plan up to an annual maximum of 100% of eligible compensation, pursuant to a salary reduction arrangement. Total participant contributions in any calendar year are restricted to the applicable limit under Internal Revenue Code Section 402(g). The applicable limit for the plan year ended December 31, 2024 is \$23,000 with an additional \$7,500 catch-up provision for participants age fifty or older. The Plan allows for the Sponsor to make discretionary matching contributions equal to a uniform percentage of salary deferrals and additional discretionary profit-sharing contributions at the end of each plan year. The Sponsor matched an amount equal to 100 percent of each participant’s contribution up to 3 percent of the participant’s compensation. The participants direct the investment of the employee deferrals and the Sponsor discretionary matching contributions to the various investment options offered by the Plan.

C. Expenses of Administering the Plan - Administrative expenses recorded in the financial statements represent expenses that were absorbed by participants related to the administration of the Plan.

D. Participants' Accounts - Each participant's account is credited with the participant's contributions, the Sponsor's discretionary matching and discretionary profit-sharing contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific transactions, as defined within the plan agreement. The benefit to which a participant is entitled is the vested amount in the participant’s account.

E. Eligibility and Vesting - Employees of the Sponsor become eligible to participate in the Plan once they have attained the age of twenty-one and have completed thirty days of service.

Participants' contributions plus actual earnings thereon are 100% vested at all times. Vesting of Sponsor discretionary matching contributions plus earnings thereon is based upon six full years of credited service allowing for various severance periods as follows:

A participant is 100% vested upon termination by reason of retirement, death, or disability. Upon termination, any amount in which the participant is not vested shall be forfeited.

F. Notes Receivable from Participants - Participants may borrow from their accounts a minimum of \$1,000, and up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000. The loans bear interest at variable rates and are secured by the balances in the participants’ accounts. Principal and interest payments are redeposited in the participants’ accounts based on their current allocation elections within the Plan. Participants may have no more than one loan outstanding at one time.

1 - Description of Plan (continued)

G. Payment of Benefits - Upon termination of service or retirement, participants entitled to payment under the Plan will have the option of receiving a lump sum distribution equal to their vested account balance or rolling their distribution over to an IRA or other qualified retirement plan.

H. Forfeited Accounts - Forfeitures may be applied to reduce future Sponsor discretionary matching and discretionary profit-sharing contributions or to pay Plan expenses. As of December 31, 2024, forfeited non-vested accounts totaled \$6,319. During the year ended December 31, 2024, forfeited non-vested accounts in the amount of \$89,889 were used to reduce Sponsor discretionary matching contributions.

2 - Summary of Significant Accounting Policies

A. Basis of Presentation - The accompanying financial statements were prepared on the accrual basis of accounting. Therefore, revenues are recognized when earned, and expenses are recorded when the obligation is incurred.

B. Valuation of Investments - Investments are stated at fair value as determined and certified by Reliance Trust Company (the "Trustee"). Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date.

C. Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document. During the year ended December 31, 2024, there were \$14,848 in deemed distributions of notes receivable from participants.

D. Payment of Benefits - Benefits are recorded when paid. Corrective distributions generally represent the distribution of certain assets to employees in order for the Plan to comply with ERISA nondiscrimination rules. There were no corrective distributions for the year ended December 31, 2024.

E. Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

F. Subsequent Events - The Sponsor has evaluated subsequent events through July 23, 2025, the date the financial statements were available to be issued.

3 - Information Certified by the Trustee

The Sponsor elected the method of annual reporting compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Trustee of the Plan has certified that all of the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

Investments and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.

Net investment income and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

4 - Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan's termination, participants will become fully vested in their accounts.

5 - Income Tax Status

The Plan obtained its latest determination letter on March 31, 2014, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

6 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and amounts reported in the statements of net assets available for benefits.

7 - Fair Value Measurements

As required by the Fair Value Measurements topic of the Financial Accounting Standards Board *Accounting Standards Codification* ("FASB ASC"), all financial assets and liabilities are measured at fair value on a recurring basis. The topic establishes a framework for measuring fair value and enhances disclosure requirements for fair value measurements. The topic defines fair value as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The topic establishes market or observable inputs as the preferred sources of values, followed by assumptions based on hypothetical transactions in the absence of market inputs. The topic establishes a hierarchy for grouping these assets and liabilities, based on the significance level of the following inputs:

Level I - Quoted prices in active markets for identical assets or liabilities.

Level II - Quoted prices in active markets for similar assets and liabilities, quoted prices for identical or similar instruments in markets that are not active and model-derived valuations whose inputs are observable or whose significant drivers are observable.

Level III - Significant inputs to the valuation model are unobservable.

Interest in common/collective trusts consists of collective investment funds that are valued daily using models developed by the Plan's trustee. The units of these pooled funds are not traded on an exchange or over-the-counter.

Interest in registered investment companies includes money market and mutual funds that are valued using quoted prices on nationally recognized securities exchanges.

The preceding methods described may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

8 - Parties-in-Interest Transactions

The Plan pays fees for various administrative and custodial services provided during the year. Fees paid using Plan assets during the year ended December 31, 2024 for these services totaled \$27,724. These fees were based on customary and reasonable rates for such services.

The Sponsor provides certain accounting, administrative, and investment management services to the Plan for which no fees are charged and pays annual auditing fees on behalf of the Plan.
