## INDEPENDENT AUDITORS' REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Powur PBC 401(k) Plan, an employee benefit Plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Powur PBC 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section.

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. We are required to be independent of Powur PBC 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, which raise substantial doubt about Powur PBC 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

**Note 1. Description of the Plan**

The following description of Powur PBC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

**General:** The Plan was established on January 1, 2021, by Powur, PBC. The Plan is a defined-contribution Plan. The Plan is subject to the provisions of the Employee Retirement Security Act of 1974 (“ERISA”).

**Employee Contributions:** Employees (as defined by the Plan) of Powur, PBC (the “Plan Sponsor”) shall be eligible to become a participant in the Plan on the first of the month following their date of hire. Participants may elect to contribute a certain dollar amount of their eligible earnings on a pre-tax or Roth basis as allowed by the Internal Revenue Code (“IRC”). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers 23 investment options for participants. Eligible new hires are automatically enrolled for pre-tax contributions at a 3% deferral rate, with automatic annual 1% increases up to 10%, unless they elect otherwise. Employees are always fully vested in their contributions and earnings on investments.

**Employer Contributions:** The employer has a discretionary profit-sharing program and the amount of employer contributions each year are determined by the Plan Sponsor. During the year ended December 31, 2024, there were no employer contributions.

**Participant-Directed Investments:** If permitted, participants may direct the trustee as to the investment of all or a portion of their individual account balances in accordance with the Plan’s procedures. Participants may direct the trustee in writing to invest their accounts in specific assets, specific funds or other investments permitted under the Plan and the participant direction procedures. That portion of the account of any participant that is subject to investment direction of such participant will be considered a participant directed account.

**Participant Accounts:** Each participant’s account is credited with the participant’s contributions and allocation of Plan earnings and were charged with an allocation of administrative expenses prior to the Plan transfer noted above. Allocations are based on participant earnings or account balances, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Vesting:** An eligible employee is defined as one what satisfied the maximum age (21) and there are no services requirements and who is entitled to participate, will become a participant immediately after such requirements are satisfied. Participants are vested immediately in their contributions, plus actual earnings thereon.

Vesting in the employer’s contributions, if any, to participants’ accounts are based on the participants’ years of continuous services as set forth in the following table:

**Forfeitures:** If an employee terminates employment before full vesting, the nonvested portions of employer matching and discretionary contributions are used to reduce future employer contributions, added to any Employer discretionary contribution, allocate to all participants in the same proportion that each participant's compensation for the Plan year bears to the Compensation of all participants for such year or for Plan administration costs of the Plan Sponsor. As of December 31, 2024 and 2023, the Plan had no forfeited nonvested balance.

**Rollovers:** With the consent of the administrator, amounts may be transferred to this Plan from other tax qualified plan under §401 (a), provided the Plan from which such funds are transferred permits the transfer to be made and the transfer will not jeopardize the tax-exempt status of the Plan or trust or create adverse tax consequences for the employer.

**Notes Receivable from Participants:** The Plan allows for only one (1) outstanding loan at any point in time. Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the participant's vested account balance, per plan provisions. The maximum repayment period is 5 years, or the administrator may approve a longer term for purchase of a primary residence.

**Payment of Benefits:** Upon termination, death, disability, retirement or certain hardship cases, a participant will receive a lump-sum amount equal to the value of the participant's vested interest. Distributions will be made in cash. If the value of the participant's benefit derived from employer and employee contribution does not exceed \$5,000, then the administrator may only distribute such benefit in a lump-sum.

**Expenses:** Certain expenses such as loan fees and transaction costs are paid directly out of individual participant funds. All other expenses include any administrative fees, and audit fees are paid by the Company. Administrative expenses charged to the Plan are reflected in the accompanying statement of changes in net assets available for benefits.

**Note 2. Summary of Significant Accounting Policies**

**Basis of Accounting:** The financial statements of the Plan are prepared under the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America ("GAAP"). Under this method, revenue (i.e., interest, contributions, and appreciation on investments) is recognized when earned and certain expenses are recognized when incurred.

**Use of Estimates:** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires administrators to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Payment of Benefits:** Benefits are recorded when paid. There are no outstanding payments allocated to the accounts of persons who have elected to withdraw from the Plan as of December 31, 2024 and 2023.

**Notes Receivable from Participants:** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are recorded as distributions based on the terms of the Plan Document and are reported as taxable income to the participant regardless of whether the loan amount was provided from pre-tax or after-tax accounts. As of December 31, 2024, the loans are secured by the balance in the participant's account and bear interest rates between 3.25% and 9.50%, per annum.

**Investment Valuation and Income Recognition:** The investments in all the funds are presented at fair value, based on the quoted market prices of the underlying securities within each fund on December 31, 2024 and 2023. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Note 3. Plan Termination**

Although there has not been any expressed intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, no further contributions will be made to the Plan and all amounts credited to the accounts will continue to be 100% vested. Distributions will occur in a manner permitted by the Plan as soon as practicable.

**Note 4. Risk and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 5. Related Party and Party in Interest Transactions**

Certain plan investments include mutual funds managed by Reliance Trust Company (the "Trustee"). The Plan's third-party administrator is Automatic Data Processing, Inc ("ADP"). These transactions qualify as exempt party in interest transactions. Fees paid by the Plan for investment management services amounted to \$9,258 for the year ended December 31, 2024.

**Note 6. Information Certified by the Plan's Trustees (Unaudited)**

Information related to investments from participants are disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31 2024 and 2023 and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained or

derived from information supplied to the Plan administrator and certified as complete and accurate by the Trustees of the Plan.

**Note 7. Tax Status**

The Plan, as designed, is in compliance with the applicable requirements of the Internal Revenue Code. Accordingly, no provision for income taxes has been included in the Plan's financial statements.

The IRS has determined and informed the Plan Sponsor by a letter dated October 6, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles Generally Accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by tax jurisdictions, however, there are currently no audits for any periods in progress. All years from the inception of the Plan are open for examination.

**Note 8. Fair Value Measurements**

FASB ASC 820, Fair value measurement and disclosures, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

***Level 1:*** Quoted prices in active markets for identical assets or liabilities.

***Level 2:*** Inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities; quotes prices in markets that are not active; or other inputs that can be corroborated by observable market data for substantially the full term of the assets or liabilities.

***Level 3:*** Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

The asset or liability's fair value measurement level within the fair hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used on December 31, 2024.

*Mutual funds:* Valued at the net asset value (NAV) of shares held by the Plan at year-end.

*Collective investment trust:* Valued at their respective NAV as reported by such trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. The NAV is based on the fair value of the underlying investments held by the trust, with the exception of fully-benefit responsive investment contracts held by the trust which are valued at contract value, less liabilities.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
