## **INDEPENDENT AUDITORS' REPORT**

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Klick USA Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Klick USA Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### **Opinion**

### NOTES TO FINANCIAL STATEMENTS

AS OF DECEMBER 31, 2024 AND 2023 AND FOR THE YEAR ENDED DECEMBER 31, 2024

---

#### 1. PLAN DESCRIPTION

The following description of the Klick USA Inc. 401(k) Plan (the “Plan”) provides for general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

**General** – The Plan is a prototype, non-standardized 401(k) plan, sponsored by Klick USA Inc. (the “Company” or “Plan Sponsor”). The Plan is funded by employee and employer contributions and covers all employees of the Plan Sponsor upon date of hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

**Contributions** – Participants may make pre-tax contributions up to 90% of eligible compensation, as defined in the Plan, limited to the Internal Revenue Code (“IRC”) maximum. Additionally, participants age 50 or older can elect to make catch-up contributions limited to the amount imposed by law. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans in the form of rollover contributions. The Plan provides for employer matching contributions equal to 50% of the first 6% of the employee’s elective deferral.

**Vesting** – Participants are immediately 100% vested in their voluntary contributions and earnings thereon. Participants are 100% vested in the employer matching contributions and earnings thereon upon 2 years of service.

**Participant Accounts** – Individual accounts are maintained for each Plan participant. Participant accounts are increased by participant contributions, the participant’s share of Plan earnings, and employer matching contributions. Participant accounts are decreased by participant distributions and the participant’s share of Plan expenses and losses. The allocation of earnings and losses to participant accounts is based upon the value of an individual account in relation to the total assets of the Plan. Upon retirement or termination, a participant is entitled to the vested balance in his or her account.

**Notes Receivable from Participants** – Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The term of the note may not exceed five years (except for the purchase of a primary residence). The notes are secured by the balance in the participant’s account and bear interest at the prime rate plus 1.0%. Principal and interest is paid ratably through payroll deductions. Interest rates on loans range from 4.25% to 9.50% and mature through August 2032. The participants may only have one loan outstanding at any time.

**Payment of Benefits** – On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant’s vested interest in his or her account, or installments, provided that the participant’s vested account balance exceeds \$5,000. If the vested account balance is less than \$5,000, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Distributions will be made as soon as practical after a participant’s request. The Plan also allows for in-service withdrawals for employees who attain age 59½. Distributions are also permitted in the event of financial hardship, as defined by the Plan.

**Plan Termination** – Although it has not expressed any intent to do so, the Plan Sponsor has the right to terminate the Plan subject to the provisions of ERISA. In the event of termination, all participants shall become fully vested in their accounts at the date of such termination.

## 1. PLAN DESCRIPTION (continued)

**Administrative Expenses** – Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements.

**Forfeitures** – Participants not fully vested in employer contributions upon termination of employment forfeit their non-vested balances. Forfeitures may first be used to reduce administrative expenses and then may be used to reduce employer contributions. During 2024, \$48,441 of forfeitures were used to reduce employer contributions. At December 31, 2024 and 2023, there were \$8,038 and \$5,115 of forfeitures available, respectively.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting** – The accompanying financial statements have been prepared on the accrual basis of accounting.

**Investment Valuation and Income Recognition** – The Plan determines the fair value of assets and liabilities which are subject to reporting at fair value based on standards established within generally accepted accounting principles. These standards establish a hierarchy for the determination of fair value, as well as disclosure requirements relative to those assets and liabilities. The hierarchy identifies three levels of input. Level 1 inputs are generally quoted market prices for identical assets or liabilities, which are actively traded on an exchange. Level 2 inputs generally consist of market prices for identical assets which are not actively traded or market prices of similar assets or liabilities which are actively traded on an exchange. Level 3 inputs are referred to as unobservable inputs and consist primarily of information derived by management where Level 1 and Level 2 inputs are not available. These may include such things as present value of expected future cash flows or other valuation methodologies. Under the hierarchy, Level 1 inputs are the most preferred, followed by Level 2, and Level 3 are to be used only where neither Level 1 nor Level 2 inputs are available.

An investment's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investments measured at fair value as of December 31, 2024 and 2023:

**Mutual funds:** Mutual funds are valued based on quoted market prices, which represent the net asset values of the shares held by the Plan.

**Common collective trusts:** Valued based on the net asset values ("NAV") of the units held by the Plan at year-end, and generally have no redemption restrictions or unfunded capital commitments. The common collective trusts have been measured at fair value using the NAV practical expedient as of December 31, 2024 and 2023.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in different fair value measurements at the reporting date.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

The Plan presents in the statement of changes in net assets available for benefits the net appreciation in fair value of investments, which includes unrealized and realized gains and losses on investments that were held or sold during the year. Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividend income is recognized on the ex-dividend date.

*Notes Receivable from Participants* – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis.

*Payment of Benefits* – Benefit payments to participants are recorded when paid.

*Use of Estimates* – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of net assets at the date of the financial statements and the reported amounts of changes in net assets during the reporting period. Actual results could differ from those estimates.

*Risks and Uncertainties* – The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest, market and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

*Subsequent Events* – Management has evaluated the effects of all subsequent events through July 30, 2025, the date the financial statements were available to be issued, to determine if events or transactions occurring through that date require potential adjustment or disclosure in the financial statements.

## 3. FAIR VALUE MEASUREMENTS

The Plan uses fair value measurements to record fair value adjustments to certain assets and to determine fair value disclosures (as discussed in Note 2). The following table sets forth, by level within the fair value hierarchy, the Plan's assets that are measured at fair value, with the exception of the common collective trusts that are measured at fair value using the NAV practical expedient. The fair value of the common collective trusts are provided below to permit reconciliation of the fair value hierarchy to the amounts presented in the statements of net assets available for benefits:

#### 4. INCOME TAX STATUS

The Plan Sponsor has adopted ADP, LLC's Non-Standardized Pre-Approved Profit Sharing/Money Purchase Plan with Cash or Deferred Arrangement (the "Non-Standardized Plan"). The Non-Standardized Plan received an Opinion Letter from the Internal Revenue Service dated October 6, 2020, stating the form of the Plan is acceptable under Section 401 of the IRC for use by employers for the benefit of their employees. Accordingly, no provision has been made for Federal income taxes in the accompanying financial statements.
