We have performed audits of the financial statements of ACL Airshop, LLC 401(k) Profit Sharing Plan and Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

NOTE 1 - PLAN DESCRIPTION

The following description of ACL Airshop, LLC 401(k) Profit Sharing Plan and Trust (the “Plan”) provides only general information. Participants should refer to the Plan agreements for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering substantially all employees of ACL Airshop, LLC (the “Company”, or “Plan Administrator”), except those classified as a nonresident alien or covered by a collective bargaining agreement, who are age 18 or older and have completed the minimum service requirements.

The Plan Administrator is responsible for oversight of the Plan. The 401k Plan Committee determines the appropriateness of the Plan’s investment offerings, monitors investment performance and reports to the Company’s Board of Directors. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

Contributions

Participants are allowed to make elective pre-tax or Roth contributions to the Plan for up to 90% of their annual eligible Plan compensation, as defined in the Plan Agreement, subject to limitation under the Internal Revenue Code (“IRC”). Participants who have attained age 50 are eligible to make catch-up contributions subject to maximum limitation imposed by the IRC. Participants may also contribute amounts representing rollovers from other qualified retirement plans or individual retirement accounts.

The Plan includes a Safe Harbor matching contribution feature, in accordance with section 401(k)(12) of the IRC. Under the Safe Harbor provisions, the Company matched 100% of the first 3% and 50% of the next 2% of eligible compensation deferred. The Company may also make profit-sharing contributions at its discretion, annually. There were no discretionary profit-sharing contributions for the year ended December 31, 2024.

All participant and Company contributions are invested in accordance with participant directions.

Vesting

Participants are immediately vested in their contributions, including rollovers, plus actual earnings thereon. Participants are also immediately vested in their safe harbor matching contributions. Vesting in the Company’s profit-sharing contributions is 20% at two years of credited services and an additional 20% for each year thereafter, until the participant becomes 100% vested at six years of credited service.

Participant Accounts

Each participant’s account is credited with the participant’s contributions and the safe harbor matching contributions, as well as allocations of any discretionary Company profit-sharing contributions and Plan earnings/losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan and withdrawals, as applicable. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Payment of Benefits

The Plan permits withdrawals when a participant terminates employment, retires or becomes disabled or deceased. In-service withdrawals are also permitted when a participant attains age 59½. Benefits are payable as a lump-sum payment or via installment payments at the participant's election. Hardship withdrawals are also permitted. Once a participant reaches age 73, they are required to start withdrawing a minimum amount each year.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("US GAAP").

Use of Estimates

The preparation of financial statements in conformity with US GAAP requires the Plan's management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company's 401k Plan Committee determines the Plan's valuation policies utilizing information provided by Reliance Trust Company (the "Trustee") as of December 31, 2024 and 2023, respectively. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Administrative expenses includes administration of distributions fees that are charged directly to the participant's account. Investment-related expenses are included in net appreciation of fair value of investments.

NOTE 3 - INFORMATION CERTIFIED BY TRUSTEE

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Reliance Trust Company has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments, at fair value as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H, line 4(i) - schedule of assets (held at end of year) as of December 31, 2024.

NOTE 4 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the best level of input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023, respectively, from the prior year.

Registered investment companies: Valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. These funds held by the Plan are deemed to be actively traded.

Collective trust: Valued at net asset value (NAV) of units held as reported by investment managers based on the fair value of the underlying assets less liabilities. The NAV is used as the practical expedient to estimate fair value.

The Plan's investments include an investment in the Invesco Stable Asset Fund which is a collective trust fund in the Invesco Stable Asset Trust. The objective of the fund is to seek the preservation of principal and to provide interest income reasonably obtained under prevailing market conditions and rates, consistent with seeking to maintain required liquidity. The investments of the fund are primarily synthetic guaranteed investment contracts and short-term investment funds. The Plan has elected to use the NAV per share as a practical expedient to measure the fair value of its collective trust as of December 31, 2024 and 2023. Additionally, there were no unfunded commitments or redemption restrictions related to these investments as of December 31, 2024 and 2023.

NOTE 5 - PARTY-IN-INTEREST TRANSACTIONS

For the years ended December 2024 and 2023, ADP Retirement Services was the recordkeeper of the Plan; therefore, transactions with the recordkeeper qualify as party-in-interest transactions. Fees paid by the Plan to the recordkeeper totaled \$1,999 and \$1,403 for the year ended December 2024 and 2023, respectively.

The Company also paid certain administrative expenses on behalf of the Plan.

NOTE 6 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

NOTE 7 - TAX STATUS

Effective April 1, 2021, the Plan adopted a non-standardized form of a prototype plan sponsored by ADP Retirement Services. The prototype plan has received an opinion letter from the IRS as to the prototype plan's qualified status. The prototype plan opinion letter, dated October 6, 2020, has been relied upon by this Plan. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualified status. The Plan has been amended since October 6, 2020; however, the Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified and the related trust is tax-exempt.

US GAAP requires Plan Management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. As of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan provides for various investment options. These investments are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

NOTE 9 - SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through July 30, 2025, the date the financial statements were available to be issued and has determined there are no material subsequent events requiring recognition or disclosure in these financial statements.
