### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of The Glen Mills Schools Savings and Protection Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### 1. Description of Plan

The following description of The Glen Mills Schools Savings and Protection Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions, including definitions of key terms.

#### *General*

The Plan was adopted effective January 1, 1998 by The Glen Mills Schools (the Schools and Plan Sponsor) is the sponsor of the Plan. The Plan is a defined contribution plan covering substantially all employees of the Schools, as defined below. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

The Plan is a defined contribution plan covering substantially all employees of The Glen Mills Schools (the Schools and Plan Sponsor).

#### *Custodian and Administration of the Plan*

The Board of Directors of the Schools controls and manages the operation and administration of the Plan. The Plan utilizes Teachers Insurance and Annuity Association of America (TIAA) and College Retirement Equities Fund (CREF) and Reliance Trust Company, respectively, as its custodians and trustees. The Plan's recordkeeper is ADP Retirement Services for the investments held by Reliance Trust Company (ADP Retirement Services 401(k) Program). For investments held by TIAA and CREF, they are the custodian and recordkeeper (TIAA and CREF 401(k) Program). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### *Eligibility*

Salaried employees are eligible and commence participation immediately upon hire. Hourly employees are eligible upon completion of one year of service in which they are credited with 1,000 hours of service; participation commences on the first day of the month coincident with or next following the date on which the eligibility requirements are met.

Effective September 1, 2024, the plan was amended to allow part time employees who work 500 hours or more for two consecutive years to participate in the plan for all contributions upon the next plan entry date in accordance with the SECURE 2.0 Act.

#### *Contributions*

Participants may make pre-tax contributions of at least 2% of eligible compensation, as defined in the Plan document, not to exceed the maximum annual amount permitted under certain Internal Revenue Service (IRS) limitations. Participants are automatically enrolled with a 2% salary deferral unless they voluntarily elect not to participate in the Plan. Participants may change their deferral elections at any time, without limitation. Effective January 1, 2013, participants were no longer permitted to make contributions to accounts with TIAA or CREF.

The Plan Sponsor makes bi-weekly contributions on behalf of each eligible participant. The Plan Sponsor's contributions include a safe-harbor matching contribution of 4% of eligible compensation and an additional discretionary matching contribution, which qualifies as a safe-harbor contribution

up to an additional 2% of eligible contributions. The total amount of such contributions for each participant is equal to 100% of participant contributions up to 6% of eligible compensation for 2024.

### ***Participant Accounts***

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contributions, the Schools' safe-harbor matching contributions, discretionary matching contributions, and Plan earnings, and is charged with withdrawals and an allocation of Plan losses and administrative expenses. Allocations are based on participant earnings or account balances, as defined. Fund managers' fees are charged to participants' accounts as a reduction of the return earned on each investment option. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participants direct the investment of their account balances into various investment options offered by the Plan and may change their investment options at any time, subject to the terms of the funding vehicles. Participants may select from investment options available under the ADP Retirement Services 401(k) Program. Participants with existing balances may select from investment options available in the TIAA and CREF 401(k) Program. Plan investment gains and losses are allocated to participants' accounts on a daily basis according to the type of funding vehicle in which balances are invested.

### ***Vesting and Forfeitures***

Participants' deferral contributions, the Schools' safe-harbor and discretionary matching contributions and earnings thereon are fully and immediately 100% vested. As such, there are no forfeited nonvested amounts as of December 31, 2024 and 2023.

### ***Notes Receivable from Participants***

Loans are available to participants who invest through the ADP Retirement Services 401(k) Program, subject to certain limitations. Participants may obtain interest-bearing loans in the amount of the lesser of \$50,000 reduced by the highest outstanding loan balance to the participant during the preceding year, or 50% of the participant's vested account balance. Loan terms may extend to a period not to exceed five years, or for a reasonable period of time over five years for the purchase of a principal residence. The loans are secured by balances in the participants' accounts and bear interest at reasonable rates based on local prevailing rates for similar loans at the date the loan is issued. Principal and interest are paid ratably through bi-weekly payroll deductions.

### ***Payment of Benefits***

Participants (or their beneficiaries in the case of death during active employment) are entitled to 100% of the value of their participant accounts upon their retirement, death during active employment, or total disability. Participants may take in-service distributions upon attainment of age 59-1/2. Participants are also permitted to make hardship withdrawals in certain cases of immediate and heavy financial need. Effective January 1, 2024, in accordance with the SECURE 2.0 Act, the required minimum distribution age was increased from 72 to 73. The provision for small balance cashouts was also increased from \$5,000 to \$7,000 and applies only to participants who have not met the plan's retirement age. Participants who have met the retirement age are not subject to forced cashouts and may remain in the plan until they request

their distribution. Benefits may be paid through lump-sum distributions or installment payments based upon participants' elections and subject to the terms of the funding vehicles.

### **2. Summary of Accounting Policies**

#### ***Basis of Accounting***

The financial statements of the Plan are prepared in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) under the accrual basis of accounting.

#### ***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the custodians. See Note 5 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### ***Contributions***

Participant contributions and any related employer safe-harbor matching contributions and discretionary matching contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation.

#### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

#### ***Use of Estimates***

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

#### ***Administrative Expenses***

Certain administrative expenses of the Plan are paid by the Plan Sponsor and are excluded from these financial statements. Administrative fees, loan processing and distribution fees are paid by the participants.

Management fees and operating expenses charged to the Plan are deducted from investment income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return.

### ***Payment of Benefits***

Benefits are recorded when paid.

### **3. Plan Termination**

Although it has not expressed any intent to do so, the Schools have the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all participants would remain fully vested in the Schools' contributions.

### **4. Certified Investment Information**

The Plan Sponsor has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, TIAA and CREF and Reliance Trust Company, qualified institutions, have certified that the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income (loss) and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the Year Ended December 31, 2024.
- Investment amounts shown in Note 5.
- Investment information included in the supplemental Schedule H-Line 4i-Schedule of Assets (Held at End of Year) as of December 31, 2024, as shown on the ERISA-required supplemental schedule.

At the request of the Plan Administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information in the above-named financial statements and ERISA-required supplemental schedule.

### **5. Fair Value Measurements**

Accounting Standards Codification (ASC) 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*CREF Investments (Registered Investments Companies):* These separate accounts are registered investments offered through variable annuity contracts issued by CREF that invest principally in equity securities, fixed-income instruments, and short-term investments in accordance with each portfolio's investment objectives. Units held in the registered investments are valued at net asset value (NAV) and published daily on NASDAQ. The NAV is measured based on the fair value of the underlying investments held by the fund less its liabilities. The fair value of the underlying investments is determined using market quotations or prices obtained from independent pricing sources that may employ various pricing methods to value the investments, including matrix pricing. Money market account holdings are generally valued at amortized cost. On a daily basis, units in the registered investments are revalued to reflect performance of the underlying investments minus any fees and charges.

*TIAA Real Estate (Pooled Separate Account):* The value of the pooled separate account is determined at the close of each business day at unit value, which is based on the fair value of the underlying assets, which may consist of real estate properties, mutual funds, and securities. The unit value of the PSA is published on NASDAQ; however, the PSA is not publicly traded. The value of the underlying real estate properties is determined by an external appraisal on a periodic basis, which are estimates based on professional opinions. The value of the underlying investments in the registered investment companies and securities are based on the daily value of the underlying registered investment companies and securities on an open market. There are restrictions on the trading and withdrawals of funds from this investment; generally transfers out can be executed on

any business day but may be limited to once per calendar quarter. Other limited exceptions may also apply.

*TIAA Traditional Annuity Contract:* The non-fully benefit-responsive (NFBR) fixed annuity contract, composed entirely of the TIAA Traditional Annuity Contract, are reported at fair value. Fair value is determined using a discounted cash flow model. The TIAA Traditional Annuity Contracts are not available for sale or transfer on any security exchange. The fixed annuity contracts are subject to various restrictions. See Note 6.

*Common Trust Fund:* The fair value of the Plan's units in the collective trust fund (CTF) is valued at NAV, as provided by the trustee, Invesco Stable Asset Trust, of the CTF. NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the CTF less its liabilities. This practical expedient is not used when it is determined to be probable that the CTF will sell for an amount different than the reported NAV. The CTF provide for daily redemptions by the Plan at reported NAV with no advance notice. There are no unfunded commitments related to this investment. This investment is a direct filing entity.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following tables present information about the Plan's investments measured at fair value on a recurring basis as of December 31, 2024 and 2023, and indicate the fair value hierarchy of the valuation techniques utilized by the Plan to determine such value:

Significant increases or decreases in the above unobservable inputs in isolation would result in a significantly lower or higher fair value measurement for such assets.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period.

### 6. TIAA Traditional Annuity

As discussed in Note 5, fixed annuity contracts consist of investment options available to participants known as the TIAA Traditional Annuity Contracts (Annuity). Annuity contracts are established between the participants and Teachers Insurance and Annuity Association (TIAA), an insurance company registered in the State of New York. This investment option is offered in a variety of formats, including Group Retirement Annuities (GRA). The return of Annuity contributions plus interest to participants is subject to TIAA's claims-paying ability. Annuity accounts are credited with a guaranteed minimum rate of interest that is determined annually. Participants may also earn interest in addition to the guaranteed rate at the discretion of TIAA. Such discretionary interest, if any, is declared by TIAA on a year-by-year basis and remains in effect for the subsequent 12-month "declaration year."

Contributions to the Annuity accounts are grouped by TIAA into "vintages" comprising premiums received over defined time periods of one or more contiguous calendar months. The interest crediting rate for each vintage is determined, in part, by the net investment earnings rate of the TIAA assets supporting that vintage, minus a charge for administrative expenses and an amount set

aside for contingency reserves. Crediting rates are also determined by the performance of investments contained in TIAA's general account.

GRA accounts allow lump-sum withdrawals after 120 days after termination with a 2.5% surrender charge. All other GRA withdrawals may be withdrawn over ten annual installments. GRAs are not considered to be fully benefit-responsive investment contracts as defined by ASC 962, because this provision is considered to restrict participants' "reasonable access" to their contract balances.

### **7. Parties-In-Interest and Related-Party Transactions**

Plan investments include investment contracts, a pooled separate account and registered investment companies that are managed by TIAA and CREF, the custodians of the Plan. The Plan also holds notes receivable from participants. These transactions qualify as party-in-interest transactions and are exempt from the prohibited transaction rules.

### **8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **9. Plan Termination**

Although it has not expressed any intention to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event that the Plan is terminated, participants would remain 100% vested in their accounts.

### **10. Tax Status**

The Plan was restated as of June 1, 2022, and is operating under a Non-Standardized Defined Contribution Pre-Approved Plan sponsored by Automatic Data Processing (ADP). The IRS has determined and informed ADP by letter dated October 6, 2020 that the Plan is designed in accordance with the applicable sections of the IRC. The Plan Administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **11. Subsequent Events**

The Plan Administrator has evaluated subsequent events through July 30, 2025 the date the financials were available to be issued. The Plan Administrator is not aware of any subsequent events which would require recognition or disclosure in these financial statements.
