NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Amerisafe, Inc. (“Company”) 401(k) Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan for the benefit of eligible employees, which covers substantially all of the employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act (ERISA). To become a participant, an employee must have obtained 18 years of age and must have completed two months of service with the Company.

Contributions and Funding Policy

Each year, participants may contribute up to 60% of pretax annual compensation, as defined in the Plan. However, the total deferrals in any taxable year may not exceed a dollar limit that is set by law. The limit for 2024 and 2023 is \$23,000 and \$22,500, respectively. Participants who have attained age 50 or older before the end of the Plan year are eligible to make catch-up contributions up to \$7,500 for calendar years 2024 and 2023. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans but will not become a participant in the Plan until the eligibility and entry date requirements are met. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers mutual funds and common/collective trusts through Reliance Trust Company as investment options for participants. The employer makes a non-discretionary matching contribution equal to 50% of the employee’s contribution subject to a maximum of 6% of them employee’s eligible compensation contributed to the Plan. The employer may also make a discretionary match each year that would be allocated to participants prorate based on their deferrals during the year.

Participant Accounts

Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s contribution and, (b) Plan earnings (losses), and charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the employer’s contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after five years of credited service. The vesting schedule is as follows:

Regardless of the vesting schedule above, a participant will become fully vested upon total and permanent disability.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000, reduced by the excess, if any, of the highest outstanding balance of loans from the Plan during the one-year period ending on the day before the loan is made or 50% of their vested account, whichever is less. The loans are secured by the balance in the participant's account. Interest rates will equal to 2% above the prime rate. Principal and interest are paid ratably through semi-monthly payroll deductions.

Payment of Benefits

Payment of benefits generally will not begin until participants reach their Normal Retirement Age at 65 (even if employment has not terminated). In such event, a distribution will be made, at their election, as soon as administratively feasible. If they remain employed past their Normal Retirement Age, they may generally defer the receipt of benefits until they actually terminate employment. In such event, benefit payments will begin as soon as feasible at their request, but generally not later than age 70 1/2.

If a participant's vested account balance exceeds \$5,000, on termination of service, disability or after reaching a normal retirement age, a participant must consent to their benefit distribution. The participant will receive an amount equal to the value of their vested interest in their account in the form of a single lump-sum payment, a rollover to a qualified plan; or if elected, a joint and survivor annuity. If a participant's vested balance does not exceed \$5,000, their vested account balance may only be distributed in a single lump-sum payment or rollover to an eligible retirement plan.

Forfeited Accounts

Forfeitures of non-vested accounts totaled \$127,725 and \$46,718 for the years ended December 31, 2024 and 2023, respectively. Forfeitures are used first to pay administrative expenses of the Plan and any remainder can be used to offset employer contributions. Employer contributions were reduced by \$17,805 and \$10,471 from forfeited non-vested accounts in 2024 and 2023, respectively. The balances of the Plan's forfeiture account as of December 31, 2024 and 2023 were \$108,394 and \$80,678, respectively.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A brief summary of the significant accounting and reporting policies followed by the Plan in the preparation of its financial statements is presented below.

Basis of Accounting

The financial statements of the Plan are prepared on the modified cash basis of accounting, which is a comprehensive method of accounting other than generally accepted accounting principles. Employer and Employee contributions are recognized when received. Employee benefits and refunds of contributions are expensed when paid.

Use of Estimates

The preparation of financial statements in accordance with modified cash basis of accounting requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - (Continued)

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Reliance Trust Company has provided fair values as of December 31, 2024 and 2023. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is accounted for as it is paid. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participants' accounts and are included in administrative expenses when incurred. Delinquent participant loans are reclassified as a benefit payment to the participant based on the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Fees for administration of the plan are paid from the forfeitures account and the plan sponsor is responsible for any fees in excess of the amount available in the forfeitures account. Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Investment related expenses are included in net appreciation (depreciation) in fair value of investments. Fees charged by the trustee for certain transactions initiated by the participants, such as loan withdrawals and benefit payments, are included in administrative fees and charged directly to the participant's account.

SECURE Act 2.0

On December 29, 2022, the Consolidated Appropriations Act of 2023 was signed into law, which includes the package of retirement provisions referred to as "SECURE 2.0." These provisions continue the themes and reforms that began with the 2019 SECURE Act, focusing on getting more participants into the retirement system and finding ways for them to accumulate more assets. These changes have various effective dates starting in 2023 and forward. Since the provisions include both required and optional elements, the Plan administrator will determine the optional provisions to elect.

NOTE 3 - FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Financial Accounting Standards Board (FASB) Codification No. 820-10, Fair Value Measurements, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under FASB Codification No. 820-10 are described as follows:

Level 1

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2

Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement. The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission (“SEC”). These funds are required to publish their daily net asset value (“NAV”): and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/collective trusts: Valued at NAV of units of the collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the NAV. Participant transactions (purchase and sales) may occur daily.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Gains and losses (realized and unrealized) included in changes in net assets available for benefits for the years ended December 31, 2024 and 2023, result entirely from investments in mutual funds and are reported as net appreciation (depreciation) in fair value of investments.

The Plan’s policy is to recognize transfers between level 1 and level 2 and into and out of level 3 as of the date of the event or change in circumstance that caused the transfer. For the years ended December 31, 2024 and 2023, there were no significant transfers between levels 1 and 2 and no transfers into or out of level 3.

NOTE 4 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE 5 - TAX STATUS

The Internal Revenue Service (“IRS”) has determined and informed the Plan by a determination letter on October 6, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (“IRC”). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan’s tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

NOTE 5 - TAX STATUS – (Continued)

The modified-cash basis of accounting requires the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon termination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for a period beyond three years from the filings of those returns.

NOTE 6 – RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS

Certain Plan investments are shares of mutual funds managed by Reliance Trust Company. Reliance Trust Company is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services amounted to \$74,936 for 2024 and \$71,348 for 2023. All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 7 - RISK AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 8 – INFORMATION CERTIFIED BY THE CUSTODIAN OF THE PLAN

Reliance Trust Company, as custodian of the Plan, holds all of the Plan's investment assets and executes transactions therein. Financial information relating to the assets is included in the accompanying financial statements and is based on information provided by the custodian. The plan administrator has instructed us not to examine the information certified as complete and accurate by the trustee/custodian. The trustee/custodian's certificate applies to substantially all Plan assets and transactions for the dates presented.
