### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Oxford Financial Group, Ltd. Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended and the related notes to the financial statements.

## Notes to Financial Statements

---

### 1. Description of the Plan

The following description of the Oxford Financial Group, Ltd. Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### *General*

The Plan is a defined contribution plan available to all employees of Oxford Financial Group, Ltd. (the Company). The Plan was originally adopted effective February 1, 1981. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

#### *Eligibility*

All employees are eligible to participate in the Plan immediately upon hire. To receive the profit-sharing contributions, an employee is eligible after one year of service and must be employed at the end of the year.

#### *Contributions*

Participants may contribute the maximum percentage allowable, subject to certain limitations, to the extent such percentage does not result in their contributions exceeding the annual dollar limits established by law. Participants may also contribute amounts representing eligible rollover contributions from other qualified plans. The Plan also allows for catch-up contributions for those aged 50 and over during the Plan year, subject to certain limitations. Participants can elect to make Roth contributions on an after-tax basis.

The Company may elect to make discretionary matching and profit-sharing contributions to the Plan. For the years ended December 31, 2024 and 2023, the Company matched 50% of the first 7% of an eligible employee's contributions. No profit-sharing contributions were made in 2024 or 2023.

#### *Participant Accounts*

Each participant's account is credited with the participant's contributions and Company contributions, if any, as well as allocations of Plan forfeitures, earnings or losses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account. Participants may direct the investment of their account balances into various investment options offered by the Plan. Currently, the Plan offers various investment options for participants.

#### *Vesting*

Participants are vested immediately in their elective deferral and actual earnings thereon. Vesting in the discretionary matching and profit-sharing contributions and actual earnings thereon is based on years of continuous service. Participants begin vesting after one year of continuous service at a rate of 25% per year and become 100% vested after four years of credited service.

Participants may, under certain circumstances as defined in the Plan document, borrow up to the lesser of \$50,000 or 50% of their vested account balance. The minimum note is \$1,000, and participants may only have one note outstanding at any time. The notes are secured by the balance in the participant's account and bear interest at the prevailing rate charged by other lenders for similar notes. Interest rates on notes receivable range from 4.25% to 9.50% at December 31, 2024. The notes are repaid ratably through payroll deductions over a period of five years or less, unless for the purchase of a principal residence, in which case the note terms may exceed five years.

### ***Payment of Benefits***

On termination of service due to death, disability, separation, or retirement (age 65), a participant (or a participant's beneficiary in the event of death) may elect to receive a lump-sum amount equal to the value of the participant's interest in his or her account. In-service distributions upon attainment of age 59½ are allowed from all types of contributions. Hardship withdrawals of participant deferral contributions are allowed under certain conditions to meet a financial hardship.

### ***Expenses***

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and payment of benefits are charged directly to the participant's account and are included in administrative expenses. Total administrative expenses, net of revenue credits for the years ended December 31, 2024 and 2023 were approximately \$(9,800) and \$2,200, respectively. Investment-related expenses are included in net appreciation in fair value of investments.

### ***Revenue Credits***

The Plan's service agreement with the trustee provides for a revenue credit arrangement, whereby the trustee allocates quarterly deposits into the accounts of eligible participants in accordance with the Plan provisions. Unallocated revenue credits at December 31, 2024 and 2023 are \$5,091 and \$2,335, respectively. During 2024 and 2023, the Plan received credits of approximately \$48,000 and \$38,000, respectively, which was used to pay administrative expenses. Administrative expenses are presented net of revenue credits in the statement of changes in net assets available for benefits.

### ***Forfeited Accounts***

At December 31, 2024 and 2023, forfeited non-vested accounts totaled approximately \$44,900 and \$36,900, respectively. These accounts may be used to pay administrative expenses of the Plan, used to offset employer contributions or reallocated to participant accounts. During 2024 and 2023, forfeited non-vested accounts of approximately \$34,800 and \$66,700, respectively, were reallocated to participant accounts.

## **2. Summary of Significant Accounting Policies**

### ***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting.

### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

### ***Investment Valuation and Income Recognition***

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset (an exit price) in the principal or most advantageous market for the asset in an orderly transaction between market participants on the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold during the year, as well as those held as of year-end. Dividends are recorded on the ex-dividend date. Interest income is recorded on an accrual basis.

### ***Notes Receivable from Participants***

Participant loans are classified as notes receivable from participants and are measured at the unpaid principal balances plus unpaid interest. Defaulted loans, if any, are reclassified as distributions based upon the terms of the Plan document.

### ***Payment of Benefits***

Benefits are recorded when paid.

### ***Contributions Receivable***

Participant contributions and any related employer matching contributions are recognized in the period during which the Company makes the respective payroll deductions from the participant's compensation. Profit-sharing contributions, if any, are recorded in the relevant period in accordance with the terms in the Plan document.

### ***Risks and Uncertainties***

The Plan utilizes various investment instruments, which are exposed to various risks, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible changes in their values could occur in the near term and such changes could materially affect participant's account balances and the amounts reported in the financial statements.

### ***Subsequent Events***

Subsequent events have been evaluated by management through July 18, 2025, the date these financial statements were available to be issued.

### 3. Investments

Inputs to valuation techniques refer to the assumptions that market participants would use in pricing the asset. The Plan utilizes a fair value hierarchy for valuation inputs that gives the highest priority to quoted prices in active markets for identical assets (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The three levels of the fair value hierarchy are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets.

*Level 2* - Inputs to the valuation methodology include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in inactive markets, and other inputs that are observable, or can be corroborated by observable market data.

*Level 3* - Inputs to the valuation methodology are both significant to the fair value measurement and unobservable.

The following valuation methodologies were used to measure the fair value of the Plan's investments. There have been no substantial changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds* - These assets are valued at the daily closing price, as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at the price. The mutual funds held by the Plan are deemed to be actively traded.

*Common Collective Trusts (CCTs)* - The fair value of participation units held in the Morley Stable Value Fund and the Principal Diversified Real Asset Collective Investment Trust are based on NAV, which is obtained based on information reported by the trustee of the common collective trusts and is used as a practical expedient. The NAV is based on the fair value of the underlying investments held by the CCT less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Withdrawals from the Morley Stable Value Fund for benefit payments and participant transfers to noncompeting options are made to Plan participants promptly upon request but in all cases within 30 days after written notification has been received. All Plan sponsor-directed full or partial withdrawals are subject to a 12-month advance written notice requirement, though the Morley Stable Value Fund may waive this requirement at its discretion. There are no unfunded commitments related to these CCTs.

The Plan's valuation methods may result in a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Although Plan management believes the valuation methods are appropriate and consistent with those participating in the market, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## 4. Certified Investment Information

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by the trustee, Fidelity Management Trust Company (Fidelity), a qualified institution.

## 5. Related Party and Party-in-Interest Transactions

Certain Plan investments are mutual funds managed by Fidelity. Fidelity is the trustee, as defined by the Plan, and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments. Notes receivable from participants also qualify as party-in-interest transactions.

## 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of a Plan termination, participants would become fully vested in any employer contributions.

## 7. Income Tax Status

The Plan adopted the Fidelity Management & Research Company pre-approved defined contribution plan. The pre-approved defined contribution plan received an opinion letter, dated June 30, 2020, in which the Internal Revenue Service (IRS) stated that the Plan, as designed, was in compliance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes the Plan is designed, and is

currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and tax-exempt.

Accounting principles generally accepted in the United States of America require the Plan's management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there currently are no audits for any tax periods in progress.
