### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

**Note 1. Description of Plan**

The following description of the Ben Mynatt Family of Dealerships 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

**General**

The Plan is a defined contribution plan covering all eligible employees of the Ben Mynatt Family of Dealerships (the “Company”) who have three months of service and are twenty-one years of age or older. Principal Life Insurance Company and Principal Trust Company (“Principal”) serve as the custodian of the Plan (“Custodian”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

**Contributions**

Participants are eligible to contribute up to 50% of compensation, as defined in the plan document. Upon becoming eligible, participants are automatically enrolled with a deferral of 6% unless they elect not to participate or elect to defer a different percentage. This amount is also increased by 1% on January 1 each year, unless otherwise elected, until the rate reaches 10%. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans and certain individual retirement accounts.

The Company may, at its discretion, make matching contributions and additional profit-sharing contributions as determined annually. For the year ended December 31, 2024, the Company elected to make a matching contribution of 10% of each participant’s deferrals. Contributions are subject to certain limitations.

**Investment Options**

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan offers a variety of pooled separate accounts, a mutual fund, and a non-benefit-responsive guaranteed interest account as investment options.

**Participant Accounts**

Each participant’s account is credited with the participant’s contributions and allocations of the Company’s contributions and plan earnings, and charged with benefit payments, transaction fees related to notes receivable from participants and distributions, plan losses, and allocations of administrative expenses. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Participants are vested in the Company’s contribution portion of their accounts plus actual earnings thereon based on the following years of service as follows:

***Notes Receivable from Participants***

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. All notes bear interest based on the rates available for similar loans from commercial lending institutions. The interest rate in the Plan's note portfolio ranged from 5.25% to 10.50% at December 31, 2024. Note terms are limited to 5 years. The term may be extended for the purchase of a primary residence. Notes are secured by the balance in the participant's account. Principal and interest are paid ratably through payroll deductions.

***Payment of Benefits***

On termination of service, death, disability, or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either lump-sum amount or various installment and annuity options as provided by the Plan. Amounts contributed on a before-tax basis may only be withdrawn upon demonstration of financial hardship, disability, or after the participant reaches the age of 59 ½.

***Forfeited Accounts***

At December 31, 2024 and 2023, forfeited non-vested accounts were not material. Forfeitures are used to reduce administrative expenses or future employer contributions. During 2024, \$2,243 of forfeitures were used to reduce the Plan's administrative expenses and \$0 of forfeitures were used to reduce employer contributions.

**Note 2. Significant Accounting Policies**

***Basis of Accounting***

The financial statements of the Plan are prepared under the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").

***Use of Estimates***

The preparation of financial statements in conformity with GAAP requires plan management to make estimates and assumptions that affect the certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates and assumptions.

***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. The net appreciation in fair value of investments includes gains and losses on investments bought and sold as well as held during the year.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Delinquent participant notes are reclassified as distributions based upon the terms of the plan document.

***Benefit Payments***

Benefit payments are recorded upon distribution.

***Administrative Expenses***

The Plan's administrative expenses are paid by either the Plan or the Company, as provided by the plan document. Certain administrative functions are performed by employees of the Company. No such employee receives compensation from the Plan. Expenses relating to specific participant transactions (notes receivable from participants and distributions) are charged directly to the participant's account.

***Subsequent Events***

The Plan has evaluated subsequent events through July 31, 2025, the date the financial statements were available to be issued.

***Unaudited Investment Information Certified by Custodian***

The accompanying financial statements include the following unaudited information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, which was obtained from data prepared and certified to be complete and accurate by the Plan's custodian:

**Note 3. Fair Value Measurements**

Fair value as defined under GAAP is an exit price, representing the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

GAAP establishes a three-tier fair value hierarchy, which prioritizes the inputs used in measuring fair value. These tiers include:

- Level 1** Observable inputs such as quoted prices in active markets.
- Level 2** Inputs other than quoted prices in active markets that are either directly or indirectly observable.
- Level 3** Unobservable inputs about which little or no market data exists, therefore requiring an entity to develop its own assumptions.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurements. The Plan's assessment of the significance of a particular input to the fair value measurement requires judgement and may affect the valuation of assets and liabilities and their placement within the fair value hierarchy.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

***Pooled Separate Accounts***

The fair value of the pooled separate accounts is based on quoted prices in active markets for similar assets. The investments have readily determinable fair values, that the plan has the ability to access at the measurement date, based on the Net Asset Value (the "NAV") which is determined by the fair value of the underlying securities. ASU-2018-09, Amendments to Subtopic 962-325, *Plan Accounting-Defined Contribution Pension Plans-Investments-Other* provides clarification in determining if investments meet the

NAV practical expedient requirements. Based on this update, the Company has classified the pooled separate accounts within Level 1 of the valuation hierarchy to better reflect the fact that these assets have a readily determinable fair value.

**Mutual Fund**

The mutual fund is a publicly traded investment and is valued daily at the closing price reported on the active market on which the fund is traded.

**Non-Benefit-Responsive Guaranteed Interest Account**

Due to significant unobservable inputs included in the valuation model for the guaranteed interest account, the resulting fair value of this account is classified as Level 3. The fair value of the guaranteed interest account is calculated by Principal by adjusting the contract value to reflect current market interest rates only to the extent such market rates exceed crediting rates. Disclosure of unobservable inputs to fair value measurement has not been included for the guaranteed interest account because quantitative unobservable inputs are not developed by the Plan when measuring fair value and have not been made available to the Plan by Principal.

Level 3 assets measured at fair value on a recurring basis for the year ended December 31, 2024 included purchases of a guaranteed investment account for \$52,916. There were no issuances and no transfers in and out of Level 3 assets for the year ended December 31, 2024.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 4. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

**Note 5. Tax Status**

The Plan has not obtained a determination letter from the Internal Revenue Service (“IRS”) stating that the Plan was in compliance with the applicable requirements of the Internal Revenue Code (“IRC”). The Plan is relying on the IRS approval of the non-standardized prototype plan that it is utilizing. The IRS has determined and informed the prototype document sponsor by a letter dated March 31, 2014 that the prototype plan document was designed in accordance with applicable sections of the IRC. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the plan administrator believes that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 6. Exempt Party-In-Interest Transactions**

Certain Plan investments are managed by Principal, the custodian of the Plan and, therefore, qualify as exempt party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund. Fees paid to Principal by the Plan for recordkeeping amounted to \$29,162 for the year ended December 31, 2024.

**Note 7. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
