### NOTES TO FINANCIAL STATEMENTS

#### **NOTE A. DESCRIPTION OF THE PLAN**

The following description of the VIESSMAN GROUP EMPLOYEES 401(K) & PROFIT SHARING PLAN is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution profit sharing plan with 401(k) features. It is subject to the provisions of the Employee Retirement Income Security Act (ERISA).

#### **Entities**

The Plan consists of participants from Cliff Viessman, Inc., Dawson Truck Parts, Inc., Dayton Tank Wash, Inc., and Jacobson Transport, Inc., employers under common control.

#### **Plan Amendments**

There were no plan amendments during the year ended December 31, 2024.

#### **Eligibility**

Eligible employees of the Plan Sponsor may participate after reaching the age of 18 and completing one year or 1,000 hours of service. Employees will begin participation in the Plan on January 1st, April 1st, July 1st and October 1st following the date the eligibility requirements are met.

#### **Contributions - Matching**

Each year, participants may contribute up to 100% of their pretax annual compensation, as defined in the Plan, subject to Internal Revenue Service (IRS) limitations. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The employers may make matching contributions equal to a discretionary percentage to be determined by the employers. The employers have made matching contributions of \$339,570 and \$356,600 for the years ended December 31, 2024 and 2023, respectively.

## VISSMAN GROUP EMPLOYEES 401(K) & PROFIT SHARING PLAN

### NOTES TO FINANCIAL STATEMENTS

#### **NOTE A. DESCRIPTION OF THE PLAN (Continued)**

##### Contributions – Profit Sharing

The Company may make a discretionary contribution each Plan year. Contributions are allocated based on participants' eligible compensation plus excess compensation. Excess compensation is any amount over 80% of the FICA taxable wage base. Discretionary contributions in the amount of \$379,827 and \$416,501 were made for the years ended December 31, 2024 and 2023, respectively.

##### Participant Accounts

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contributions, the employers' matching contributions, the employers' discretionary profit sharing contributions, Plan earnings, and forfeitures of terminated participants' non-vested accounts and charged with an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### Investments

Participants direct the investment of their contributions, the employer's matching contributions and the employer's profit sharing contributions into any of the 39 different investment funds.

##### Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Participants will be 100% vested in their discretionary matching contributions and discretionary profit sharing contributions on a sliding scale of vesting over six years from the date of their hire or at the time of death, disability, or retirement, provided the person has reached normal retirement age.

##### Payment of Benefits

If employment terminates for reasons other than death, disability or normal retirement, participants are entitled to receive only the vested percentage of their account balance. If the account balance does not exceed \$1,000, a distribution will be made regardless of whether the participant consents to receive it. Account balances between \$1,000 and \$5,000 will be automatically rolled into an IRA with American Funds. Hardship distributions are allowed for qualifying needs and are only allowed from accounts which are 100% vested.

### NOTES TO FINANCIAL STATEMENTS

#### **NOTE A. DESCRIPTION OF THE PLAN (Continued)**

##### Forfeitures

Forfeited non-vested accounts are used to reduce the Company's matching contributions and discretionary profit sharing contributions in accordance with the provisions of the Plan. The balances of forfeited non-vested accounts at December 31, 2024 and 2023 were \$49,063 and \$27,454, respectively. The balance of the forfeiture account is kept in the US Government Money Market. In 2024 and 2023, the Company's contribution of \$0 and \$26,537 was paid with forfeitures, respectively.

##### Significant Costs

The employer absorbs some costs for plan administration.

#### **NOTE B. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

##### Basis of Accounting

The accompanying financial statements and supplemental schedule of the Plan were prepared in accordance with accounting principles generally accepted in the United States of America.

##### Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect amounts reported on the financial statements and accompanying notes. Accordingly, actual results could differ from those estimates.

##### Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risks associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

#### **NOTE B. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)**

##### Investment Valuation and Income Recognition

The Plan's investments are stated at fair value, except for the Federated Capital Preservation Fund valued at contract value, as disclosed in Note F. The Federated Capital Preservation Fund is a fully benefit responsive investment contract. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

As described in Financial Accounting Standards Board Staff Position, FSP AAG INV-1 and SOP 94-4-1, *Reporting of Fully Benefit-Responsive Investment Contracts Held by Certain Investment Companies Subject to the AICPA Investment Company Guide and Defined-Contribution Health and Welfare and Pension Plans (the FSP)*, investment contracts held by a defined-contribution plan are required to be reported at fair value. However, contract value is the relevant measure attributable for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded as received.

##### Payment of Benefits

Benefits are recorded when requested by the participant.

##### Administrative Expenses

Plan administration costs were paid out of Plan assets and are allocated among the accounts of all participants in the Plan.

##### Service Provider Credit

Investment options held by the Plan may make payments to the Service Provider which is recorded in other income. These payments are made pursuant to subtransfer agency arrangements, selling group agreements and fund distribution agreements. Certain payments from the investment options held by the Plan are payable to the Service Provider and are used as a credit to offset Service Provider fees otherwise payable by the Plan.

#### **NOTE B. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)**

##### Compensation Recapture

The compensation recapture is 12(b)(1) revenue sharing that the investment advisor normally receives. 12(b)(1) fees are used for the cost of the sale, or distribution of investments. The fee is deducted from the assets of the investment and thus is charged directly to the participants invested in the fund. The fee is ordinarily paid to a broker-dealer as part of the distribution of the investments. The compensation recapture allows the plan to revenue share with this fee and can be used to subsidize recordkeeping costs.

##### Excess Contributions Payable

The Plan is required to return contributions received during the Plan year in excess of the Code's limits.

##### Tax Positions Interest and Penalty

Interest recognized on underpayment of income taxes is recorded to interest expense. Penalties recognized on tax positions are recorded to income tax expense. During the years ended December 31, 2024 and 2023, there were no underpayment interest or penalties to recognize.

#### **NOTE C. INCOME TAX STATUS**

The IRS has determined and informed the Plan sponsor by a letter dated March 31, 2014, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC).

Although the Plan has been amended since receiving the opinion letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

#### **NOTE D. CERTIFICATION BY THE TRUSTEE**

The plan administrator obtained and agreed to certifications as to the completeness and accuracy of investment assets aggregating \$17,888,853 and \$16,460,876 as of December 31, 2024 and 2023, respectively, and the related net investment income, including the net appreciation in fair value of such assets, of \$2,219,213 and \$2,350,688 for the years ended December 31, 2024 and 2023, respectively. Such amounts and all related financial data are included in the accompanying financial statements and supplemental schedule of the Plan based on such certifications from the Trustee (Capital Bank and Trust Company) as being complete and accurate.

#### **NOTE E. FAIR VALUE MEASUREMENTS**

FASB ASC 820 establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of fair value hierarchy under FASB ASC 820 are described below:

#### **NOTE F. INVESTMENT CONTRACT WITH INSURANCE COMPANY**

The Capital Preservation Fund is a collective investment fund that invests in a diversified portfolio of fully benefit-responsive stable value products such as investment contracts issued by insurance companies, banks, and other financial institutions. The Capital Preservation Fund utilizes collateralized GIC contracts, which are high quality fixed income securities wrapped by an insurance company, bank or financial institution. The wrap contract provides benefit-responsive withdrawals and book value accounting, while the underlying collateral provides improved credit quality to the fund and reduced exposure to any single industry.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Contract value represents contributions made to the fund, plus earnings, less participant withdrawals. The crediting interest rates are reviewed monthly and quarterly.

The Federated Hermes Capital Preservation Fund is a synthetic GIC, also known as a wrap contract, which is a contract issued by an insurance company or other financial institution, designed to provide a contract value "wrapper" around a portfolio of bonds or other fixed income securities that are owned by the Fund. The assets underlying the wrap contracts are units of fixed income collective investment trusts (Capital Preservation Fund Managed Portfolio I, II, III and IV). The wrap contracts are obligated to provide an interest rate not less than zero. These contracts provide that realized and unrealized gains and losses on the underlying assets are not reflected immediately in the net assets of the Fund, but rather are amortized, over the duration of the underlying assets, through adjustments to the future interest crediting rate.

The issuer guarantees that all qualified participant withdrawals will occur at contract value.

#### *Variables that Impact Future Crediting Rates*

The key factors that influence future interest crediting rates for a synthetic GIC include:

- The level of market interest rates;
- The amount and timing of participant contributions, transfers, and withdrawals into/out of the GIC;
- The investment returns generated by the fixed-income securities underlying the GIC; and
- The duration of the fixed-income securities underlying the GIC.

#### **NOTE F. INVESTMENT CONTRACT WITH INSURANCE COMPANY (Continued)**

The Capital Preservation Fund requires a twelve month redemption notice period for Plan Sponsor initiated events. A waiver may be granted to the twelve month redemption period. No notice is required for bona fide benefit payments, participant directed exchanges, participant loans, or payment of trustee fees.

#### *Events that Could Adversely Impact the Contract Value*

The Capital Preservation Fund cannot guarantee its ability to maintain its objective stable value as changes in current laws, regulations, or accounting practices could adversely impact the Fund.

#### **NOTE G. PARTY-IN-INTEREST TRANSACTIONS**

Transactions resulting in Plan assets being transferred to or used by a related party are prohibited under ERISA unless a specific exemption applies. The Trustee is a party-in-interest as a result of providing trustee services to the Plan and investment of Plan assets in its investment funds. However, such transactions are exempt under Section 408(b)(8) and are not prohibited by ERISA.

#### **NOTE H. PLAN TERMINATION**

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in the Company's contributions.
