1. DESCRIPTION OF THE PLAN

The following description of the Paymentus Group, Inc. 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan, which was established effective January 1, 2013, is a contributory, defined contribution plan available to all employees of Paymentus Group, Inc. (the Sponsor) with the exception of nonresident aliens. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Administration

USI Consulting Group, Inc. (USI) is the recordkeeper for the Plan. Charles Schwab Trust Bank (Charles Schwab) is the custodian of the Plan. The Standard Life Insurance Company (The Standard) is the custodian of the stable value fund. The custodians held the assets of the Plan in accordance with the provisions of their contracts with the Sponsor. The Plan administrator determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Eligibility

There is no age or service requirement to make elective deferrals to the Plan. To become eligible to receive Sponsor contributions, an employee must be 21 years of age and complete three consecutive months of service to be eligible to receive Sponsor matching contributions and complete one year of service to be eligible to receive a discretionary profit-sharing contribution. Participants can enter the Plan on the first day of the month after meeting eligibility requirements.

Contributions

Each year, participants may contribute up to 100% of annual compensation, as defined in the Plan, not to exceed certain Internal Revenue Code (IRC) limits. Participants may designate all or a portion of their salary deferral as Roth elective deferrals. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan contains an automatic enrollment feature. All newly hired participants on or after January 1, 2022, will automatically be enrolled in the Plan at a 2% pretax contribution rate unless the participant affirmatively elects a different percentage. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Sponsor may make a discretionary matching contribution equal to a uniform percentage of salary deferrals. Each year, the Sponsor will determine the amount of the discretionary percentage. During the year ended December 31, 2024, the Sponsor made a discretionary contribution of 50% of the participants' deferrals, not to exceed 5% of participants total eligible compensation, determined on a payroll-by-payroll basis. The Plan also allows the Sponsor to make a discretionary profit-sharing contribution to eligible employees. The discretionary profit-sharing contribution is allocated to participants in the same ratio as each participant's

compensation bears to the total of such compensation of all participants. The Sponsor did not make a discretionary profit-sharing contribution for the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions, allocations of the Sponsor's discretionary matching and discretionary profit-sharing contribution and Plan earnings. Participant accounts are charged with withdrawals, Plan losses and an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings (losses), account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary and rollover contributions and earnings thereon. Participants are vested in Sponsor profit-sharing contributions and related earnings as follows:

0 to 1 year	0%
2 years	20%
3 years	40%
4 years	60%
5 years	80%
6 years	100%

Participants are vested in Sponsor discretionary matching contributions and related earnings as follows:

1 year	50%
2 years	100%

Participants become 100% vested upon death or total and permanent disability.

Notes Receivable from Participants

Participants may borrow a minimum of \$1,000 up to the lesser of \$50,000 or 50% of their vested account balance. The maximum term of the borrowing is five years unless it is for the purchase of a principal residence, in which case the Plan administrator may permit a longer repayment term. A participant's note shall immediately become due and payable if such participant terminates employment for any reason or fails to make a principal and/or interest payment as provided in the note agreement. The notes are secured by the balance in the participant's account and bear a reasonable rate of interest, as determined by the Plan administrator. Principal and interest are repaid ratably through payroll deductions.

Payment of Benefits

Upon termination of service due to death, disability, retirement (age 65) or separation from service, a participant, or their beneficiary, may receive their vested balance in either a single lump-sum distribution or a direct rollover into a qualified retirement plan or individual retirement account, or defer receiving payments until age 72. Terminated participants with a vested balance less than \$5,000 that have not elected payment will be cashed out. In-service distributions are

available upon reaching age 59½, for financial hardships, as defined by the Plan, and from rollovers or pretax and or after-tax accounts.

Forfeitures

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$46,503 and \$31,583, respectively. Forfeited accounts will be used to reduce future Sponsor contributions or to pay Plan expenses. In 2024, the Plan utilized \$32,638 to pay Plan expenses.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, with the exception of the group annuity contract which is valued at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by the custodians. See Note 4 for discussion of fair value measurements.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally will receive if they were to initiate permitted transactions under the terms of the Plan. See Note 5.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make repayments and the Plan administrator deems the note receivable to be in default, the participant loan balance is reclassified as a benefit payment based upon terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Sponsor. Expenses that are paid by the Sponsor are excluded from these financial statements. Fees related to distribution, loan origination and administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events

Management has evaluated subsequent events through July 31, 2025, which is the date the financial statements were available to be issued and has determined that there are no subsequent events that require disclosure under Financial Accounting Standards Board (FASB), Accounting Standards Codification (ASC), Topic 855, *Subsequent Events*.

3. INFORMATION CERTIFIED BY THE CUSTODIANS

Certain information related to investments disclosed in the accompanying financial statements and the ERISA-required supplemental schedule, including investments held as of December 31, 2024 and 2023, net appreciation in fair value of investments, and interest and dividend income for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Charles Schwab and The Standard.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820, *Fair Value Measurement*, are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual funds and money market fund: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds and money market fund held by the Plan are deemed to be actively traded.

5. GROUP ANNUITY CONTRACT WITH INSURANCE COMPANY

The Plan holds a Stable Asset Fund (the Fund) which is a group annuity product issued by The Standard. The Fund provides direct guarantee of principal and accumulated interest. Interest is credited on a single "portfolio rate" method. Interest crediting rates are stated on an annual effective basis declared shortly (usually one week) before each quarter and are locked-in and guaranteed not to change for the quarter. The contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts since this is the amount

received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value for the fund represents amounts contributed or transferred to the Fund less any withdrawals or transfers out, plus all accrued interest. The Fund is backed by The Standard's general account. The underlying general account portfolio is a broadly diversified, investment-grade, fixed income portfolio. There are no reserves against the contract value for credit risk of the contract issuer as of December 31, 2024 and 2023.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive contracts is dependent on The Standard's ability to meet its financial obligations. The Standard's ability to meet its contractual obligations may be affected by future economic and regulatory requirements.

Certain events could limit the ability of the Plan to transact at contract value, including but not limited to, premature termination of the contract by the Plan. This would cause a one-time adjustment to the aggregate contract value, resulting in a fair value different from the contract value; however, the Plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value are probable of occurring.

6. PARTY-IN-INTEREST TRANSACTIONS

During 2024 and 2023, the Plan invested in a group annuity contract managed by The Standard. The Standard receives amounts from fees charged within these investment accounts. Fees incurred by the Plan for investment management services are included in net appreciation in fair value of investments. Fees for Plan administration and recordkeeping services were paid to the recordkeeper. These transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

8. TAX STATUS

The Sponsor adopted a defined contribution preapproved prototype plan document sponsored by USI which received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, indicating that the prototype plan is designed in accordance with the applicable sections of the IRC. The Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is tax-exempt as of the financial statement date. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
