Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Highline Warren LLC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Highline Warren LLC 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 9 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. NOTES TO THE FINANCIAL STATEMENTS

December 31, 2024 and 2023

NOTE 1 – DESCRIPTION OF THE PLAN

The following brief description of the Highline Warren LLC 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

General

The Highline Warren LLC 401(k) Plan is a 401(k) defined contribution plan covering all employees of Highline Warren LLC (the “Company”), except for union employees subject to collective bargaining agreements, leased employees, and independent contractors. The Plan is subject to the provisions of the Employment Retirement Income Security Act of 1974 (ERISA). The Plan was adopted as of May 1, 2016. Employees become eligible to participate in the Plan after completing six months of service and attaining age eighteen. The Plan assets are held by Empower Annuity Insurance Company as the custodian.

Effective October 1, 2021, the Warren Distributions, Inc. 401(k) Retirement Plan was merged into the Plan as a result of an acquisition.

Investment Options

Upon enrollment in the Plan, a participant may direct employee contributions in increments of 1% with a 1% minimum per fund in a variety of mutual funds and a group annuity contract. Participants may change their investment options and transfer previously contributed amounts between funds at any time. Investment realized gains (losses) and unrealized appreciation (depreciation) in investment fair value are measured and recorded by participant account.

Contributions

Participants may elect to contribute up to 100% of their annual compensation, as defined by the Plan, subject to Internal Revenue Code limitations. Voluntary participant contributions may be made as tax-deferred or Roth (non-tax deferred) contributions. Participants who have reached age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Company matches 50% of participant’s contributions up to 6% of the participant’s compensation, as defined by the Plan.

Participant’s Accounts

Each participant’s account is credited with an allocation of the Company’s contribution and Plan earnings as well as any contributions made by the participant. Allocations are based on participant account balances, as defined in the Plan agreement. The benefit to which a participant is entitled is the vested benefit that can be provided from the participant’s account. Account investments are participant-directed with diversified investment options from which to choose.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. A participant may only have one loan outstanding at any time. The loans are secured by the balance in the participant’s account and bear interest rate at 1% above the prime rate. Principal and interest are paid ratably through payroll deductions.

Vesting

A participant has a fully vested interest in his or her deferral contributions and rollover accounts plus actual earnings at all times. Vesting in the Company contributions portion of their accounts is based on years of service as follows:

There is a specialized vesting schedule for participants transferred from the South/Win, Ltd. 401(k) Plan, Service Champ, Inc. 401(k) Profit Sharing Plan, and Warren Distribution, Inc. 401(k) Plan, to the Highline Aftermarket Acquisition, LLC 401(k) Plan. Matching and Non-Elective contributions transferred to the Plan will be subject to a 3-year cliff vesting schedule. Prior safe harbor contributions transferred are 100% vested. Matching contributions made on or after July 9, 2018 to participants transferred from the Service Champ, Inc. 401(k) Profit Sharing Plan will be subject to the following vesting schedule:

Payment of Benefits

On retirement, death, disability, or termination of service, a participant may elect to receive his or her plan benefits equal to the value of the participant's vested interest in his or her account in a lump-sum distribution, installments, or maintain invested funds in the Plan if the balance is greater than \$5,000. Annuities are allowed only for transferred assets. Withdrawals by a participant while employed are limited to those requested due to events of financial hardship as defined by the plan document or upon attainment of age 59 1/2.

Forfeited Accounts

Forfeited amounts may be used to pay plan expenses or to reduce future employer contributions. At December 31, 2024 and 2023, forfeitures totaled \$61,719 and \$77,677 respectively. For the year ended December 31, 2024, forfeitures used to pay plan expenses and reduce employer contributions totaled \$179,508.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Recordkeeping and other administrative expenses may be charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments. Additional fees are charged to participants based on their usage of certain plan features.

Excess Contributions

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The plan distributed the 2024 excess contributions to the applicable participants prior to March 15, 2025.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The financial statements of the Plan are prepared using the accrual basis of accounting.

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

The Plan's investments are stated at fair market value as defined by generally accepted accounting principles. See Note 3 for disclosure related to fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as deemed loan distributions. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Contributions receivable is recorded at the estimated net realizable value. An allowance for credit losses is recorded based upon management's estimate of expected credit losses, determined by using subsequent collections. Management has determined that an allowance for credit losses is not considered necessary as of December 31, 2024 and 2023.

The Plan presents in the statement of changes in net assets available for benefits the net appreciation (depreciation) in the fair value of its investments which consists of realized gains or (losses) and the unrealized appreciation (depreciation) on investments.

Benefits are recorded when paid.

Date of Management's Review

The Plan sponsor has evaluated its December 31, 2024 financial statements for subsequent events through July 23, 2025, the date the financial statements were available to be issued. The Plan sponsor is not aware of any subsequent events which would require recognition or disclosure in the financial statements.

NOTE 3 – FAIR VALUE MEASUREMENTS

Generally accepted accounting principles established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under generally accepted accounting principles are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund.

Group annuity contract: Valued at contract value which approximates fair value.

Collective trust funds: Valued based on the underlying investment held by the Plan at year end.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4 – PLAN TERMINATION

Although it has not expressed intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all amounts credited to participant accounts will become 100 percent vested in their accounts and Plan assets will be used solely to provide benefits for participants. The net assets of the Plan are to be distributed in accordance with the Plan document in a uniform and nondiscriminatory manner.

NOTE 5 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amount reported in the statements of net assets available for benefits.

NOTE 6 – FEDERAL INCOME TAX STATUS

The Internal Revenue Service issued an opinion letter dated November 30, 2020 stating that the Non-Standardized Pre-Approved Profit Sharing/Money Purchase Plan with CODA, which the Plan adopted, qualifies under Section 401(a) of the Internal Revenue Code (IRC). The Company has not applied for a determination letter from the IRC regarding the qualification of the Plan as it applied to the Company; however, the Plan administrator believes that the Plan is currently designed and being operated in compliance with requirements of the IRC. Therefore, they believe that the Plan should qualify for tax-exempt status as of the financial statement date. The plan administrator believes that the Plan has not generated any taxable income and no federal or state income tax returns have been filed. Federal and state taxing authorities could request an examination of the financial records of the Plan to ascertain if any such taxable income exists, but no such examination has occurred or is pending.

NOTE 7 – RELATED PARTY TRANSACTIONS AND PARTIES-IN-INTEREST TRANSACTIONS

Certain plan investments are issued and managed by Empower Annuity Insurance Company of America (“Empower”). Empower is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. In addition, certain Plan expenses paid directly by the plan sponsor also qualify as party-in-interest transactions. These transactions are exempt from the prohibited transaction provision of ERISA and the Internal Revenue Code.

NOTE 8 – GUARANTEED INTEREST CONTRACTS WITH INSURANCE COMPANY

The Plan has guaranteed interest contracts with Empower. Empower maintains the contributions in pooled unallocated accounts. The accounts are credited with earnings on the underlying investments and charged for plan withdrawals and administrative expenses charged by Empower. The contracts are included in the financial statements at fair value because they are not considered fully benefit responsive. While they promise contract value for a benefit event, such as termination or disability, there is possible market value adjustment when the funds are withdrawn prior to maturity. The fair value of the guaranteed interest contract at December 31, 2024 and 2023 was \$1,138,157 and \$1,628,940, respectively.

NOTE 9 – INFORMATION CERTIFIED BY THE ASSET CUSTODIAN

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the custodian, jointly Empower Annuity Insurance Company of America and Empower Trust Company, LLC, has certified that the following data included in the accompanying financial statements and supplemental information is complete and accurate:

- Investments as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment activity, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024
- Investments as shown in the schedule of assets (held at end of year) as of December 31, 2024
- Notes receivable from participants as of December 31, 2024 and 2023

The Plan’s independent accountants did not perform auditing procedures with respect to this information, except for comparing such information with the related information included in the financial statements and supplemental information.
