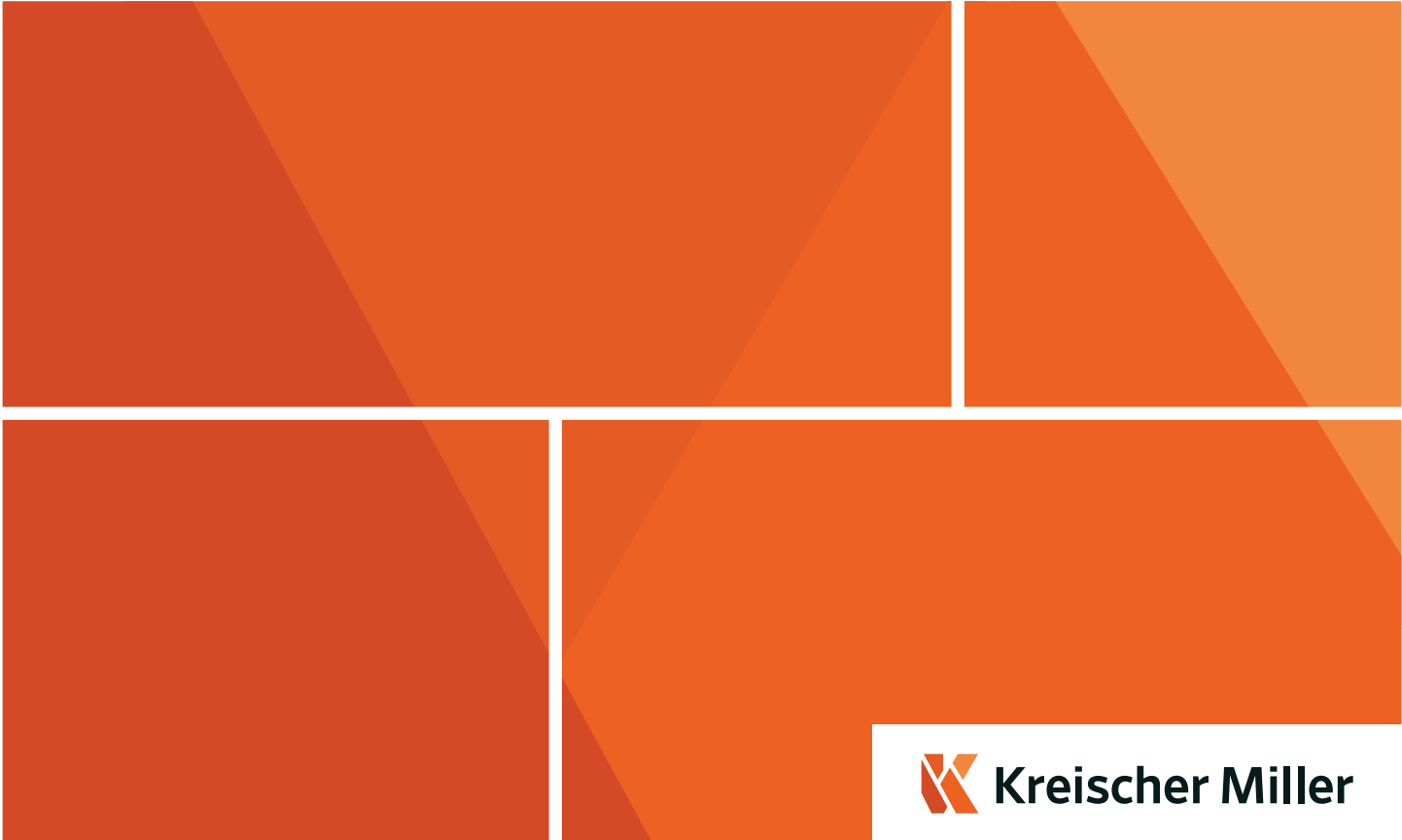

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of B & G Manufacturing 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

#### **(1) Description of Plan**

The following description of the B & G Manufacturing 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more detailed description of the Plan's provisions.

##### ***General***

The Plan is a defined contribution 401(k) and profit sharing plan covering all employees of B & G Manufacturing Co., Inc. (the Company) who have attained the age of twenty-one. Employees are eligible to participate beginning the first day of the subsequent month of employment. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan Administrator is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings and monitors investment performance.

##### ***Contributions***

Each year, participants may contribute a portion of their eligible compensation, as defined by the Plan, subject to Internal Revenue Service (IRS) limitations. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may elect to have their deferrals be either pre-tax or after-tax (Roth) contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

The Plan includes an auto-enrollment provision whereby all eligible employees, as defined, are automatically enrolled in the Plan at a 6% contribution rate unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their contributions invested in a designated balanced fund until changed by the participant. If an employee becomes a participant in the Plan under the automatic enrollment rules, the participant's salary deferral contribution percentage will automatically increase each July by an additional 1% (up to a maximum of 10%), unless the employee elects to have a different contribution percentage applied.

The Plan provides for a discretionary Company matching contribution and, in 2024, the Company matched 50% of the first 6% of compensation that a participant contributed to the Plan. Additional amounts may be contributed at the discretion of the Company's board of directors. Participants direct the investment of their contributions into various investment options of the Plan.

##### ***Participant Accounts***

Each participant's account is credited with the participant's contribution, allocations of the Company's contribution and plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### *Vesting*

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service as follows:

##### *Notes Receivable from Participants*

Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from 1 to 5 years, or longer for the purchase of a primary residence. The loans are secured by the vested balance in the participants' account and bear interest at rates that range from 4.25% to 9.50%. The rate is to remain fixed throughout the duration of the loan. Principal and interest are paid ratably through bi-weekly payroll deductions.

##### *Payment of Benefits*

On termination of service due to death, disability or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, annual installments, or a joint and survivor annuity. For termination of service due to other reasons, participants will receive the vested interest in their account as a lump-sum distribution. The Plan also provides for withdrawals for financial hardship.

##### *Forfeited Amounts*

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$3,294 and \$7,900, respectively. These accounts may be used to pay plan expenses and to reduce future employer contributions. During 2024, forfeited nonvested accounts of \$28,344 were used to reduce employer contributions.

#### **(2) Summary of Significant Accounting Policies**

##### ***Basis of Accounting***

The accompanying financial statements of the Plan are prepared under the accrual method of accounting.

##### ***Use of Estimates***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

##### ***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Gains and losses on the sale of investments are determined on weighted average cost which includes transaction expenses. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### ***Contributions***

Contributions from plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

##### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

##### ***Payment of Benefits***

Benefits are recorded when paid.

#### (2) Summary of Significant Accounting Policies, Continued

##### *Expenses*

Certain expenses of maintaining the Plan are paid by the Plan. Other expenses are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

##### *Subsequent Events*

The Plan has evaluated subsequent events through July 31, 2025, the date the financial statements were available to be issued.

#### (3) Investment Information Certified by the Trustee

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from the information certified as complete and accurate by Fidelity Management Trust Company (Fidelity), a qualified institution.

#### (4) Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;

- inputs other than quoted prices that are observable for the assets or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

*Registered investment companies:* Valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded.

There have been no changes in the methodologies used at December 31, 2024 and 2023.

#### (5) Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

#### **(6) Tax Status**

The Plan is a volume submitter plan sponsored by FMR LLC. The IRS has determined and informed FMR LLC by a letter dated June 30, 2020 that the volume submitter plan was designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan itself has not received a determination letter from the IRS. Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **(7) Related Party Transactions and Party-In-Interest Transactions**

Plan investments are shares of registered investment companies managed by an affiliate of Fidelity, the trustee of the Plan. Therefore, transactions with Fidelity's affiliate qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment.

#### **(8) Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
