### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Rendr Care Physicians 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). ### 1. Description of the Plan

The following brief description of the Rendr Care Physicians 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document and summary Plan description for a complete description of the Plan's provisions.

#### *General*

The Plan is a defined contribution plan and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan was established on August 1, 2020. The Plan covers all employees of Triboro Administrative Services, LLC (the Company or the Employer) and certain affiliated entities, who have completed three consecutive months of service and have attained at least 18 years of age. Employees who are covered by a collective bargaining agreement, nonresident aliens, and scheduled to work less than 500 hours are not eligible to participate in the Plan. Mid Atlantic Trust Company (MATC) is the custodian of the Plan.

Beginning January 1, 2022, the Plan began allowing Employer safe harbor matching contributions into the Plan.

The Plan, at certain times, is amended and restated for regulatory and certain other administrative Plan changes.

#### *Contributions*

Each year, participants may contribute up to the annual dollar limitations as imposed by the Internal Revenue Service (IRS) through a pre-tax salary deferral (\$23,000 and \$22,500 in 2024 and 2023, respectively). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions (\$7,500 for both 2024 and 2023). Participants may also contribute amounts representing distributions from other qualified retirement plans (rollovers/transfers).

The Company may, in its sole discretion, make Employer matching and qualified non-elective contributions based on a formula determined by the Company. For the Plan year beginning January 1, 2022, the Company makes safe harbor matching contribution in an amount equal to: 1) 100% of the matched employee contribution that are not in excess of 3% of eligible compensation, plus 2) 50% of the matched employee contribution that exceed 3% of eligible compensation but do not exceed 5% of eligible compensation. The employer safe harbor matching contributions made by the Company during the years ended December 31, 2024 and 2023 were \$3,513,440 and \$2,935,649, respectively. There were no Employer matching or qualified non-elective contributions made during the years ended December 31, 2024 and 2023.

#### *Investment Options*

All of the Plan's investment options are fully participant directed. Participants may direct the investment of their account balances into any of the Plan's available investment options.

The life insurance policies provided by Metropolitan Life Insurance Company (Metlife) can be terminated by participants at any time and the cash surrender value of these policies reverts back to the participant's account. The cash surrender values of these policies at December 31, 2024 and 2023 were \$1,109,827 and \$959,709, respectively.

### ***Participant Accounts***

Each participant's account is credited with the participant's contributions, Employer contributions, and rollovers, if any, and subject to the provisions of the Plan and the Plan's investment earnings and losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### ***Vesting***

Participants are immediately vested in their elective deferral contributions, rollover contributions, Employer safe harbor matching contributions, qualified non-elective contribution, plus actual earnings thereon. All other non-qualified matching and contributions, are vested as follows:

### ***Forfeitures***

Forfeitures of terminated participants' non-vested account balances may be used to reduce future matching contributions of the Company or to pay reasonable Plan expenses. At December 31, 2024 and 2023, the balance in the forfeiture account was \$0 and \$4,354, respectively.

### ***Notes Receivable from Participants***

Participants may borrow from their vested accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Notes bear interest as stated in the Plan document at the time the loan was initiated. The maximum term of each note is up to five years, unless used to purchase a primary residence. Principal and interest are paid ratably through payroll deductions. Participants can have up to one outstanding loan at the same time.

### ***Payments of Benefits***

Participants are eligible to receive the vested interest in their account under the following circumstances: (a) attaining normal retirement age, (b) attaining the age of 59½, (c) separation from service, (d) becoming disabled, or (e) upon death. Participants may elect to receive the value of their account in the form of a single lump-sum payment or installment payments.

### ***Hardship Withdrawal***

In cases of financial hardship, as defined by the Plan, participants may be eligible to receive a distribution from their salary deferral account balance.

### ***Plan Expenses***

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. However, the majority of the expenses are allocated to participants and certain direct expenses incurred by an individual participant shall be deducted from that participant's account only.

### ***Excess Contributions Payable***

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 excess contributions of \$20,447 to the applicable participants in May 2025.

## **2. Summary of Accounting Policies**

### ***Basis of Accounting***

The financial statements of the Plan are prepared under the accrual method of accounting in conformity with accounting principles generally accepted in the United States of America (GAAP).

### ***Use of Estimates***

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

### ***Investment Valuation and Income Recognition***

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurement.

Whole life insurance policies are stated at their cash surrender value and are not within the scope of Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*.

The Plan presents, in the statements of changes in net assets available for benefits, the net appreciation (depreciation) in the fair value of investments, which consists of realized and unrealized gains or losses on investments purchased and sold, as well as held during the year. Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

### ***Payment of Benefits***

Benefit payments to participants are recorded when paid.

### *Notes Receivable from Participants*

Notes receivable from participants are stated at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent notes receivable are reclassified as a loan discharge based on the terms of the Plan document. Fees charged by the Plan relating to notes receivable from participants are paid from the participants' accounts. No allowance for credit loss has been recorded as of December 31, 2024 or 2023.

### **3. Risks and Uncertainties**

The Plan invests in mutual funds, whole life insurance policies and a money market fund. Due to various risks (e.g., interest rate, market volatility, and credit) associated with certain investments and the level of uncertainty related to changes in the value of investments, it is reasonably possible that changes in the values of investments will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

The Plan's exposure to a concentration of credit risk is limited by the diversification of investments across various participant directed fund elections. Additionally, the investments within each participant-directed fund election are further diversified into varied financial instruments.

### **4. Certified Investment Information**

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividend income, and interest income on notes receivable from participants for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by MATC, a qualified institution.

### **5. Fair Value Measurements**

ASC 820, *Fair Value Measurements and Disclosures*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

*Level 1* - This level consists of inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - This level consists of inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - This level consists of inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Cash Equivalents* - The Plan considers all highly liquid investments with a maturity of 90 days or less when purchased to be cash equivalents. The cash equivalents consist of interest-bearing cash in a money market fund and, therefore, have been included as Level 1 investments.

*Mutual Funds* - Mutual funds are valued at the daily closing price, as reported by the fund, mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and, therefore, have been included as Level 1 investments.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes that its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 6. Related Party Transactions and Party-in-Interest Transactions

Certain Plan investments are managed by Metlife and MATC, the custodian, and, therefore, these transactions qualify as party-in-interest transactions. Notes receivable from participants, would also qualify as exempt party-in-interest transactions. Additionally, certain employees and officers of the Company, who are also participants of the Plan, perform administrative services for the Plan at no cost. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

### 7. Tax Status

As of August 1, 2020, the Plan adopted CCH Incorporated DBA ftwilliam.com's non-standardized pre-approved profit-sharing plan with cash or deferred arrangement (CODA). Accordingly, the Plan is permitted to rely on the document provider's advisory letter. The IRS has determined and informed the document provider by an updated letter dated June 30, 2020, that the volume submitter profit-sharing plan is designed in accordance with the applicable sections of the Internal Revenue Code (Code). The Plan administrator believes the Plan is designed and operated in compliance with the applicable requirements of the Code and, therefore, believes the Plan is qualified and the trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### 8. Plan Termination

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan, subject to the provisions of ERISA. In the event of a Plan termination, no further contributions shall be made to the Plan, and each participant will be fully vested as to their account balance.

### 9. Late Remittances

During the Plan year ended December 31, 2024, employee withholdings and loan repayments in the amount of \$502,912 were not remitted within the appropriate time period. These transactions constitute prohibited transactions, as defined by ERISA. The Company has taken corrective action and lost earnings are applied to participants' accounts in 2025.

### 10. Subsequent Events

The Plan has evaluated subsequent events through July 31, 2025, the date that the financial statements were available to be issued. There were no other subsequent events identified requiring disclosure or adjustment to the financial statements.
