### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Eastern Shore Rural Health System, Inc. 403(b) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. ### Note 1 – Plan Description

---

The following description of the Eastern Shore Rural Health System, Inc. 403(b) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

#### *General*

The Plan is a defined contribution plan covering all eligible employees of Eastern Shore Rural Health System, Inc. (the “Company”). Employees are immediately eligible to participate in the Plan upon starting employment. Employees who have attained at least one year of service and are 18 years of age or older are eligible for employer matching contributions. Employees who normally work less than 20 hours per week are not eligible employees for all Plan purposes. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company’s Board of Directors (Board) is responsible for oversight of the Plan. The Plan’s 403(b) Advisory Committee determines the appropriateness of the Plan’s investment offerings, monitors investment performance, and reports to the Board.

#### *Contributions*

Each year, participants may contribute up to the maximum allowed by law of their annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Company may make matching contributions equal to a discretionary percentage of salary deferrals for eligible participants. The Company’s matching contribution is 50% of a participant’s contribution up to a maximum of 5% of a participant’s eligible compensation. Participants direct the investment of all contributions into various investment options offered by the Plan. Contributions are subject to certain IRS limitations.

#### *Participant Accounts*

Each participant's account is credited with the participant’s contributions and Company matching contributions, as well as an allocation of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

#### *Vesting*

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company’s contribution portion of their account is based on years of continuous service. A participant is 100% vested after six years of credited service.

#### *Payments of Benefits*

On termination of service, a participant may elect to receive either a lump sum amount equal to the value of the participant’s vested interest in his or her account or installments. In-service withdrawals are permitted for participants who have attained age 59 ½ or for a qualified financial hardship.

### *Forfeited Accounts*

Forfeited non-vested accounts totaled \$10,671 and \$11,515 at December 31, 2024 and 2023, respectively. These accounts will be used to reduce future employer contributions or to pay administrative expenses of the Plan. In 2024, employer contributions were reduced by \$38,187 from forfeited non-vested accounts.

## **Note 2 – Significant Accounting Policies**

---

### *Basis of Accounting*

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (GAAP).

### *Estimates*

The preparation of financial statements in conformity with GAAP requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates and assumptions.

### *Valuation of Investments and Income Recognition*

The Plan's investments are recorded at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### *Excess Contributions Payable*

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions.

### *Benefit Payments*

Benefit payments are recorded when paid.

### *Administrative Expenses*

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to benefits paid to participants and recordkeeping are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

### *Subsequent Events*

Subsequent events have been evaluated through July 17, 2025, the date the financial statements were available to be issued.

---

### **Note 3 – Fair Value Measurements**

---

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 consists of unobservable inputs and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are only used when Level 1 or Level 2 inputs are not available.

#### *Level 1 Measurements*

The fair values of mutual funds are based on quoted net asset values of the shares held by the Plan at year end.

#### *Level 2 Measurements*

The fair value of the stable value fund is based on quoted market prices of the shares held by the Plan at year end, or if the trust includes contractual components, the fair value is based on quoted prices for similar assets or liabilities in active or non-active markets.

The following tables set forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any inputs that is significant to the fair value measurement.

### Note 4 – Investment Contract with Insurance Company

The Plan holds a stable value investment contract with MassMutual. The contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1%. The crediting rate is reviewed quarterly for resetting. The average yield credited to participants was approximately 2.95% and 2.75% for 2024 and 2023, respectively.

### Note 5 – Related-Party Transactions and Party-In-Interest Transactions

Certain administrative functions are performed by employees of the Company. These employees are also Plan participants. No such employee receives compensation from the Plan.

Certain Plan investments are mutual funds managed by Empower Trust Company, LLC (Empower) and its affiliates. Plan investments also include a guaranteed investment contract sponsored by Empower. Empower is the record keeper for the Plan and is responsible for the investment of and accounting for Plan assets. The Plan paid certain expenses related to plan operations to vendors in addition to Empower and its affiliates. These transactions qualify as party-in-interest transactions under ERISA. Administrative fees paid by the Plan were \$56,995 for 2024.

### Note 6 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

### Note 7 – Tax Status

The Plan has been designed to qualify under Section 403(b) of the *Internal Revenue Code (IRC)*. The terms of the Plan have been prepared to conform to the sample language provided by the *Internal Revenue Service (IRS)* in Revenue Procedure 2007-71. The Plan is required to operate in conformity with the *IRC* to maintain the tax-exempt status for the Plan's participants under Section 403(b). The Plan Administrator and the prototype Plan Sponsor believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the *IRC* and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the *Internal Revenue Service*. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
