Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of South Atlantic Services, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C) (“ERISA Section 103(a)(3)(C) audit”). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of South Atlantic Services, Inc. 401(k) Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (“investment information”) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA (“qualified institution”).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

1. Description of Plan

The following description of South Atlantic Services, Inc. 401(k) Plan (the "Plan") provides only general information for the Plan sponsored by South Atlantic Services, Inc. (the "Company"). Participants in the Plan should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan became effective on July 1, 1991 as a defined contribution plan. The Plan covers all non-union, non-leased, full-time resident employees of the Company who have completed 30 consecutive days of employment. Service with any temporary employment agency where services were rendered to the Company are credited towards this eligibility service requirement. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions

Participants are automatically enrolled in the Plan with a 5% pre-tax deferral election once an employee becomes an eligible employee. Participants will also receive an automatic deferral increase of 1% each year after their initial enrollment date, effective up to 10%. Participants may elect to contribute a different percentage of their pre-tax or after-tax annual compensation, not to exceed the maximum allowed by the Internal Revenue Service ("IRS"). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan also permits rollover contributions from other qualifying retirement plans. The Company may make a discretionary employer match. During 2024, the Company made a discretionary employer matching contribution at a rate of 60% of the first 10% of employee elective contributions.

Participant Accounts

Employee contributions and employer contributions activity are maintained separately in each participant's account. Participants direct the investment of their account balances into various investment options offered by the Plan. Participants may change their investments daily. Each participant's account is credited with the participant's contribution, the Company's contribution, and an allocation of plan earnings and administrative expenses. Allocations are based on participants' compensation or account balances, as defined. A participant is entitled to the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately 100% vested in the salary reduction amount contributed to the Plan. Vesting in the Company's discretionary matching contributions is based on the years of continuous service. Participants are vested in the Company's discretionary matching contributions at 25% after two years of service and increases by 25% each year thereafter. Participants are fully vested after completing five years of credited service.

Forfeitures

At December 31, 2024, forfeited accounts totaled \$331. Forfeitures can be added to any employer discretionary contribution, used to reduce any employer matching contribution or allocated as an additional employer matching contribution. During the plan year ended December 31, 2024, the Plan used \$50,909 of forfeited accounts to reduce the employer matching contribution.

Payment of Benefits

Generally, a participant becomes eligible to receive benefits on their normal retirement age (65), death, disability, termination of employment, or reasons of proven financial hardship. Distributions under the plan may be made as a 100% of a participant's account balance in a lump sum, as substantially equal installments, or partial withdrawals. Fully vested participants are eligible to take in-service withdrawals once they attain age 70½. If the vested balance is less than \$5,000, a lump sum distribution is made. Effective January 1, 2024, this amount increased to \$7,000. Early retirement is permitted for participants who are 55 years old and have at least 10 years of vesting service.

Hardship Withdrawals

Upon approval by the plan administrator, a participant may withdraw all or part of their fully vested accounts for immediate and severe financial need. In accordance with IRS regulations, the participant must exhaust all other assets available prior to obtaining the hardship withdrawal. Effective January 1, 2023, the Plan was amended to limit the number of hardship withdrawals to two during a plan year.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 reduced by the excess of the highest outstanding balance of all other loans from the Plan during the one-year period ending the day before the loan was made over the outstanding balance of loans from the Plan on the date on which the loan was made or 50% of their vested account balance. A participant can only have one loan outstanding at a time and can only request a loan for hardship or financial need. The loans are secured by the balance in the participants' accounts and bear interest at a fixed rate of prime plus 2.0% (9.5% at December 31, 2024) as of the date of the new loan. Principal and interest are paid ratably through payroll deductions. Total notes receivable from participants were \$70,325 and \$56,380 at December 31, 2024 and 2023, respectively.

2. Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

2. Significant Accounting Policies (Continued)

Cash and Cash Equivalents

The Plan considers all invested cash balances to be cash equivalents.

Payment of Benefits

Benefits are recorded when paid.

Investment Valuation and Income Recognition

Investments are comprised of a fully benefit-responsive investment contract, collective investment trust funds, and mutual funds. The Plan's investments are reported at fair value except for its fully benefit-responsive investment contract ("FBRIC"), which is valued at contract value (see Note 8). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 6 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on the trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Realized and unrealized appreciation and depreciation in value of investments are allocated to the participant accounts based on participant holdings in each fund.

Plan Expenses

Certain plan expenses are paid by the plan sponsor as provided by the plan document. Expenses related to specific participant transactions (notes receivable from participants and distributions) are charged directly to the participant's account.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid, interest. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the plan document.

3. Federal Income Taxes

The Plan adopted a Non-Standardized Pre-Approved Profit Sharing Plan document. This document received an opinion letter dated June 30, 2020, in which the IRS stated that the document was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). As allowed by the IRS, the Plan is relying on the opinion letter issued on the plan document for its own qualification. The plan document has been amended for changes required by the IRS since receiving the opinion letter. The plan administrator believes the Plan is designed and currently operating in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

3. Federal Income Taxes (Continued)

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would be sustained upon examination by the applicable authorities. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that, as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in process.

4. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become fully vested in their accounts.

5. Investments

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The following information included in the accompanying financial statements and supplemental schedule was obtained or derived from information certified as complete and accurate by Reliance Trust Company ("Reliance"), the trustee of the Plan, and was not subject to audit for the years ended December 31:

Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820, *Fair Value Measurements and Disclosures*, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels:

Level 1 Inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority.

Level 2 Inputs are based on significant other observable inputs such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs are unobservable and significant to the fair value measurement.

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. The Plan uses Level 2 inputs when market prices are not attainable but other observable inputs are available to arrive at a fair value, and Level 3 inputs were only used when Level 1 or Level 2 inputs were not available. There were no Level 2 or 3 investments in the Plan.

Level 1 Fair Value Measurements

The fair value of mutual funds is based on quoted net asset values of the shares held by the Plan at year end.

Collective Investment Trust Funds

These investments are valued using the net asset value (“NAV”) of units of the collective investment trust funds. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investments for an amount different from the reported net asset value.

7. Collective Investment Trust Funds

The Plan invests in various collective investment trust funds (“CITs”) maintained and administered by Northern Trust Investments, Inc. and Great Gray Trust Company. The CITs sell new units and repurchase outstanding units on a daily basis. The CITs administered by Great Gray Trust Company require the plan sponsor to provide a five-day written notice for withdrawals which will exceed \$1 million of the assets invested in each CIT. There are no unfunded commitments. The CITs administered by Northern Trust Investments, Inc. have no commitment to the Northern Trust Collective Funds for which it holds investments and may redeem their investments on a daily basis.

8. Fully Benefit-Responsive Investment Contract

The Transamerica Stable Value Core Option (“SVO”) is a fully benefit-responsive group annuity contract. This product seeks to provide maximum return consistent with a guarantee of principal. The investment has a portfolio investment rate design in which all deposits are credited with the same interest rate. The effective credited interest rate is set semi-annually and effective on the first day of the semiannual period. Contract charges may reduce this return. Transamerica Life Insurance Company (“Transamerica”) credits interest daily and with no set maturity. The performance of the FBRIC is calculated as the annual effective credited rate for each year. The average rate was 1.58% and 1.17% for 2024 and 2023, respectively.

Permitted participant-initiated transactions are those allowed by the underlying defined contribution plan and occur at contract value with no conditions, limits, or restrictions. Since the SVO is an obligation of Transamerica, the occurrence of an event that limits the ability of the investment to transact at contract value is not probable. Principal and interest for participant-initiated benefit payments are fully guaranteed by the entire general account assets of Transamerica. There are no unfunded commitments and investments may be redeemed daily.

As described in Note 2, because this contract is fully benefit-responsive, it is included in the financial statements at contract value as reported to the Plan by Transamerica. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

9. Risks and Uncertainties

The Plan invests in various investment securities as directed by its participants. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

10. Party-in-Interest Transactions

Plan investments are managed by Reliance, the trustee as defined by the Plan, and therefore these transactions qualify as party-in-interest transactions. Transamerica is the Plan's recordkeeper. Fees paid by the Plan to Reliance, Transamerica and other parties-in-interest for contract administration, advisory and professional services amounted to \$58,472 for the year ended December 31, 2024.

11. Subsequent Events

The Company has evaluated events and transactions for potential recognition or disclosure in the financial statements through July 2, 2025, which is the date the financial statements were available to be issued.

In December 2022, Congress passed the Setting Every Community Up for Retirement Enhancement Act of 2022 ("SECURE Act 2.0") that continued the retirement system reform previously passed in 2020. Certain provisions of the SECURE Act 2.0 are effective at various dates through 2026, with the plan amendment for the adoption of SECURE Act 2.0 due by December 31, 2026.
