### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Lux Enterprises, Inc. Employees' Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

### Note 1 – Plan Description

---

The following description of the Lux Enterprises, Inc. Employees' Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### *General*

The Plan is a defined contribution plan covering all employees of Lux Enterprises, Inc. (the "Company") who have one month of service with the exception of union employees, nonresident aliens, and leased employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### *Contributions*

Each year, participants may contribute up to 100% of annual compensation as defined in the Plan, up to the maximum allowed by *the Internal Revenue Code (IRC)*. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan. Eligible participants are enrolled automatically into the Plan at a default rate of 5% of eligible compensation. The Company may make matching contributions at the discretion of the Plan Sponsor. Contributions are subject to certain limitations.

#### *Participant Accounts*

Each participant's account is credited with the participant's contributions, the Company's discretionary matching contribution, if any, and an allocation of Plan earnings, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### *Vesting*

Participants are immediately vested in their contributions and previous employer discretionary contributions plus actual earnings thereon. Vesting in the Company's matching contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 33% vested after one year, 67% vested after two years, and 100% vested after three years.

#### *Notes from Participants*

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan transactions are treated as transfers between the investment fund(s) the participant invests in and the Participant Loans fund. Loan terms range from one to five years. Notes are secured by the balance in the participant's account and bear interest at a rate of one percentage point over the prime interest rate as of the second business day of the month the inception of the loan occurs. Interest rates range from 4.25% to 9.50%. Principal and interest are paid ratably through payroll deductions.

### *Payment of Benefits*

Upon termination of service due to death, disability or retirement, a participant or a participant's beneficiary in the case of a participant's death, may elect to receive a lump-sum amount equal to the value of the participant's vested interest of his or her account. Partial withdrawals may be elected by participants who must receive required minimum distributions. Annuities are the normal form of distribution for transferred pension assets. In-service distributions are permitted for participants who have attained the age of 59½ or for a participant's vested interest in amounts from previously merged plans with the exception of the old defined benefit account.

### *Hardship Withdrawals*

Hardship withdrawals are permitted pursuant to IRS regulations.

### *Administrative Costs*

Plan fees and administrative expenses are paid by the Plan, as provided in the Plan agreement.

### *Forfeited Accounts*

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$2,421 and \$14,733, respectively. These accounts will be used to pay Plan expenses or to reduce future employer contributions, if any. During the year ended December 31, 2024, employer contributions were reduced by \$19,304 from forfeited non-vested accounts.

## **Note 2 – Significant Accounting Policies**

---

### *Basis of Accounting*

The financial statements of the Plan are prepared using the accrual method of accounting.

### *Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

### *Investment Valuation and Income Recognition*

The Plan's investments are reported at fair value or net asset value ("NAV") for Galliard Stable Value Fund K. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment advisors, trustee, and insurance companies. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### *Notes from Participants*

Notes from participants are reported at their unpaid principal balance plus any accrued but unpaid interest.

### *Payment of Benefits*

Benefits are recorded when paid.

### **Note 3 – Certified Information**

---

Certain information included in the accompanying financial statements and supplemental schedule was obtained from data that has been prepared and certified to as complete and accurate by Newport Trust Company, the former trustee of the Plan, as of December 31, 2023 and by Newport Trust Company, LLC for the period January 1, 2024 through November 13, 2024 and Ascensus, LLC, the current trustee of the Plan, for the period November 14, 2024 through December 31, 2024. On November 13, 2024, the Newport Trust Company, LLC was acquired by Ascensus Trust Company. This information is as follows:

### **Note 4 – Fair Value Measurements**

---

The Plan's investments in mutual funds are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 inputs consist of unobservable inputs and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 or Level 2 inputs are not available.

The collective investment trust fund is valued using the NAV practical expedient and is excluded from the fair value hierarchy.

### *Level 1 Fair Value Measurements*

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

### *Investments Measured Using the Net Asset Value Per Share Practical Expedient*

The following table summarizes investments for which fair value is measured using the net asset value per share practical expedient as of December 31, 2024 and 2023. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. There is no notice period if the Plan initiates a full redemption of the collective investment trust.

### Note 5 – Stable Value Fund

The Galliard Stable Return Fund K is a stable value fund which invests in stable value investment vehicles such as guaranteed investment contracts, bank investment contracts, and synthetic guaranteed investment contracts issued by highly rated financial institutions and corporations as well as obligations of the U.S. Government or its agencies. The fund's principal objective is to provide investors with a moderate level of stable income without principal volatility. To achieve this, the fund invests in instruments which are not expected to experience significant price fluctuation in most economic or interest rate environments. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Contract value represents contributions made to the fund, plus earnings, less participant transactions at contract value. Plan management believes that the occurrence of events that would cause the Galliard Stable Value Fund K to transact at less than contract value is not probable.

Certain events limit the ability of the Plan to transact at contract value with the financial institution issuer. Such events include the following: (1) material amendments to the Plan's structure or administration; (2) changes to the Plan's competing investment options including the elimination of equity wash provisions; (3) complete or partial termination of the Plan, including a merger with another plan; (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA; (5) bankruptcy of the Plan Sponsor or other Plan Sponsor events (e.g., the closing or sale of a subsidiary, employing unit, or affiliate) which could cause a significant withdrawal from the Plan; (6) any change in law, regulation, ruling, administrative or judicial position, or accounting requirement, applicable to the Plan; or (7) the delivery of any communication to a Plan participant designed to influence a participant not to invest in the Plan. At this time, the Plan does not believe that the occurrence of any such market value event, which would limit the Plan's ability to transact at contract with participants, is probable.

### Note 6 – Related Party Transactions

Certain Plan investments are managed by Newport Trust Company and the Ascensus Trust Company, who are the trustees as defined by the Plan, and therefore, these transactions qualify as a party-in-interest transaction. Fees paid to the trustees were \$27,688.

Newport Trust Company provided certain administrative services to the Plan pursuant to a Services Agreement between the Company and Newport Trust Company. Newport Trust Company received revenue from mutual fund and collective trust fund service providers for services Newport Trust Company provides to the funds. This revenue was used to offset certain amounts owed to Newport Trust Company for its administrative services to the Plan.

If the revenue received by Newport Trust Company from such mutual fund or collective trust fund service providers exceeds the amount owned under the Services Agreement, Newport Trust Company remits the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay Plan Administrative expenses. During 2024, \$33,989 was received from this revenue sharing arrangement. The Plan may make a payment to Newport Trust Company for administrative expenses not covered by revenue sharing.

### Note 7 – Tax Status

---

The non-standardized pre-approved plan document obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service stated that the pre-approved plan, as then designed, was in compliance with the applicable requirements of the *IRC*. Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the *IRC* and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

---

### Note 8 – Plan Termination

---

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

---

### Note 9 – Administration of Plan Assets

---

Certain administrative functions are performed by officers or employees of the Company. These employees may also be Plan participants. No such officer or employee receives compensation from the Plan.

---

### Note 10 – Risks and Uncertainties

---

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

---

### Note 11 – Subsequent Events

---

Management evaluated all activity of the Plan through July 30, 2025 (the issue date of the financial statements) and concluded that no subsequent events have occurred that would require recognition in the financial statements or disclosure in the notes to the financial statements.
