### Report on the Audit of the Financial Statements

#### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the accompanying financial statements of BayCare Health Systems, LLC Employee Welfare Benefit Program, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits and benefit obligations as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits and benefit obligations for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of BayCare Health Systems, LLC Employee Welfare Benefit Program's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

#### ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:



**NOTE 1 DESCRIPTION OF PLAN**

**Organization**

The following description of the BayCare Health Systems, LLC Employee Welfare Benefit Program (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan was established January 1, 1998 for the purpose of providing health, dental and prescription drug benefits covering substantially all employees of BayCare Clinic, LLC and BayCare Health Systems, LLC (collectively, the Company). Certain plan assets are held in a voluntary employees' beneficiary association (VEBA) trust. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**Contributions**

The Plan is supervised by United Medical Resources (UMR) which monitors the funding needs of the Plan with regards to medical and prescription drug benefits and Delta Dental of Wisconsin, Inc. (Delta Dental) which monitors the funding needs with regards to dental benefits. Claim payments, administrative expenses and insurance premiums are paid from the Plan. In addition to deductibles and copayments, participants contribute specified amounts based on applicable monthly premiums for their respective benefit elections. Employee contributions are withheld through payroll deductions.

UMR and Delta Dental coordinate collection and disbursements of funds as well as claim eligibility. Any expenditures in excess of employee contributions received are funded through employer contributions. The Company contributed \$10,483,774 and \$10,011,073 for the years ended December 31, 2024 and 2023, respectively.

**Benefits**

The Plan provides medical, dental and prescription drug benefits to full-time and part-time employees of the Company after completion of 30 days of continuous service. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

**Stop Loss Coverage**

The Plan has entered into stop-loss insurance arrangements in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims).

**Self-Insured Benefits**

Plan benefits are self-insured. The claims for self-insured benefits are processed by the Plan's third-party claims processor under administrative services only (ASO) arrangements. The claims processors pay claims directly to or on behalf of participants and are then reimbursed by either the Plan's VEBA trust or general assets of the Company. Despite the Plan's utilization of a third-party claim's processor, ultimate responsibility for payments to providers and participants is retained by the Plan.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

**Payment of Benefits**

Premiums paid by either the Company or the VEBA trust are recorded in the accompanying statements of changes in net assets available for benefits.

Claim payments are recorded when paid by the third-party claims processor.

**Stop Loss**

Premiums for stop loss insurance are included as stop loss insurance premiums in the accompanying statements of changes in net assets available for benefits. Stop loss refunds totaling \$2,209,179 and \$777,319 have been netted with benefits paid for claims in the accompanying statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, respectively. The stop loss reimbursements receivable was \$1,489,189 and \$777,321 as of December 31, 2024 and 2023, respectively.

**Pharmacy Rebates**

The Plan entered into a rebate program with certain of its third-party administrators. Rebates due from the third-party administrators are recorded when earned. Rebates due as of the financial statement date have been reported as a receivable, with the offset being netted against claims paid. Pharmacy rebate income of \$678,008 and \$480,563 has been netted with benefits paid for claims in the accompanying statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, respectively. Pharmacy rebates receivable was \$331,285 and \$321,619 as of December 31, 2024 and 2023, respectively.

**Benefit Obligations**

Plan obligations for claims payable and claims incurred but not reported were estimated by the Plan administrator based on actual claims paid subsequent to year-end.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

**Administrative Expenses**

Administrative expenses may be paid either by the Plan or by the Company. Expenses paid by the Company are excluded from these financial statements. Administrative expenses consist primarily of administrative fees paid to third-party claims administrators and professional fees. These expenses are reported on the statements of changes in net assets available for benefits as administrative expenses.

**Subsequent Events**

The Plan has evaluated events and transactions for potential recognition or disclosure in the financial statements through July 28, 2025, the date on which the financial statements were available to be issued.

**NOTE 3 PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to modify the benefits provided to and contributions required of participants, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Company or be used for the purpose other than for the exclusive benefit of the Plan's participants.

**NOTE 4 FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Money Market Mutual Fund:* Valued at the daily closing price as reported by the fund. The money market mutual fund held by the Plan is an open-end mutual fund that is registered with the Securities and Exchange Commission. This fund is required to publish its daily net asset value (NAV) and to transact at that price. The mutual fund held by the Plan is deemed to be actively traded.

**NOTE 5 TAX STATUS**

A trust was established under the Plan to hold the Plan’s assets and was intended to qualify pursuant to Section 501(c)(9) of the Internal Revenue Code (IRC). Accordingly, the trust’s net investment income is exempt from income taxes. The trust obtained a favorable tax determination letter from the Internal Revenue Service (IRS) dated July 14, 1999, and the Plan administrator believes the trust continues to qualify and to operate in accordance with applicable provisions of the IRC. However, as a result of the Plan’s funding policy, from time to time the trust may be subject to income taxes. Payments for income taxes of \$113,182 and \$53,701 have been netted under administrative expenses for the years ended December 31, 2024 and 2023, respectively, related to unrelated business taxable income.

In addition, the Plan and the trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the trust. The Plan administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the related trust is tax-exempt.

**NOTE 5 TAX STATUS (CONTINUED)**

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 6 CERTIFICATION OF INVESTMENT INFORMATION**

Associated Trust Company, N.A., the trustee of the Plan, has supplied the Plan administrator with a certification as to the completeness and accuracy of all investment information reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statements of changes in net assets available for benefits for the years then ended, and the supplemental schedule of assets (held at end of year) and supplemental schedule of reportable transactions as of or for the year ended December 31, 2024.

**NOTE 7 PARTY-IN-INTEREST TRANSACTIONS**

As described in Note 1, the Plan has several arrangements with service providers. Fees paid by the Plan for service provider administrative services amounted to \$261,093 and \$253,329 and are included under administrative expenses on the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, respectively. In addition, a portion of the stop loss insurance is provided by BayCare SP, an insurance provider wholly owned by BayCare Clinic, LLP. Stop loss insurance premiums paid to BayCare SP amounted to \$839,492 and \$614,558 and are included under stop loss insurance premiums on the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, respectively. The stop loss reimbursement receivable due from BayCare SP amounted to \$1,216,697 and \$685,854 and is included on the statements of net assets available for benefits as of December 31, 2024 and 2023, respectively. These transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

**NOTE 8 RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the value of certain investments will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

The liability for claims payable and claims incurred but not reported (IBNR) was estimated by the Plan administrator based on actual claims paid subsequent to year-end. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

**NOTE 9 OTHER LIABILITIES**

Other liabilities represent amounts due to providers and participants related to the operation of its Healthy Lifestyle Premium Discounts Program and stop loss insurance premiums. The total amount due related to the Healthy Lifestyle Premium Discounts Program at December 31, 2024 and 2023 was \$146,913 and \$153,011, respectively.
