INDEPENDENT AUDITORS' REPORT

To the 401(k) Committee of
Tellurian Services 401(k) Retirement Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Tellurian Services 401(k) Retirement Plan ("Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Note 1 - Description of the Plan

The following description of the Tellurian Services 401(k) Retirement Plan ("Plan") provides only general information. Participants should refer to the plan document and trust agreement for a more complete description of the Plan's provisions.

General

The Plan, amended as of July 15, 2024, is intended to be a qualified retirement plan that enables eligible employees to save for retirement. The Plan covers substantially all employees of Tellurian Services LLC ("Company"). Tellurian Management Services LLC and Driftwood Asset Services, LLC are participating employers of the Plan. There is no age requirement or service requirement to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

During October 2024, Woodside Energy Group Ltd ("Woodside") completed the acquisition of the Company. The Company and Woodside representatives have discussed the status of the pending plan merger of the Plan into the Woodside Energy USA Services Inc. Retirement Savings Plan. Currently no timeline has been established and the Plan will continue to operate independently.

Contributions

Participants may elect to defer a percentage of their eligible compensation into the Plan as a pre-tax contribution equal to the lesser of 90% of their eligible compensation or the maximum amount permitted by Internal Revenue Code ("IRC"). Participants are eligible to designate their elective contributions to the Plan on an after-tax or Roth basis. The Plan also contains an automatic enrollment features in which the Company will automatically enroll an employee in the Plan at 6% of the employee's eligible compensation unless the employee elects to stop or change this automatic contribution. Participants who are projected to be age 50 or older by the end of the plan year may also make catch-up contributions to the Plan.

Participants can roll over part or all of an eligible distribution they receive from an eligible retirement plan as a rollover contribution into the Plan.

The Company may make a discretionary matching contribution. Employer discretionary matching contributions, if made, are computed by the Company based on a participant's eligible compensation deferred into the Plan each payroll period. During 2024, participants' contributions were matched by the Company at 100% of the first 6% of eligible compensation deferred by a participant.

Participant accounts

Each participant's account is credited with the participant's contributions, rollover contributions, employer contributions, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Note 1 - Description of the Plan (Continued)Vesting

Participants are vested immediately in their contributions, rollovers, employer matching contributions, plus actual earnings thereon. After two years of service, participants are 100% vested in employer discretionary nonelective contributions plus actual earnings thereon.

Notes receivable from participants

Loans from vested account balances shall be made available to all participants on a reasonably equivalent basis. The minimum loan is \$1,000 and the maximum amount is the lesser of one-half of the participant's vested account balance or \$50,000 reduced by the highest outstanding loan balance in their account during the prior twelve month period. All loans shall bear a reasonable rate of interest. Repayment should be made through after-tax payroll deductions in level payments on at least a quarterly basis over a five year period unless it is for the purchase of a principal residence. A participant may only have 1 loan outstanding at any given time.

Payment of benefits

Participants are eligible to request a distribution from their vested account balance based on any of the following events: death, disability, retirement, required minimum distributions, and termination of employment. The entire vested account balance will be paid to the participant in a single distribution or other distribution that the participant elects.

Participants may defer the receipt of their distribution until a later date. However, a participant cannot postpone it if the vested account balance is \$5,000 or less in which case the Company will direct the trustee that any account exceeding \$1,000 be distributed to an Individual Retirement Account or Annuity for the participant's benefit. If the vested account balance is \$1,000 or less, the Company will direct the trustee to distribute it to the participant in a lump sum distribution without the participant's consent.

Participants may also take an in service withdrawal from the Plan. A participant may apply to withdraw certain contributions to satisfy specific and heavy financial needs as a hardship withdrawal. In addition, if a participant has reached age 59½, they may elect to withdraw all or a portion of their entire vested account while still employed by the Company.

Forfeited accounts

If a participant terminates their employment with the Company and are less than 100% vested in their employer account, the participant will forfeit the non-vested portion. Forfeitures are retained in the Plan and may first be used to pay administrative expenses. Any remaining amounts will be used to reduce future employer contributions payable under the Plan. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$1,288 and \$28, respectively.

Note 2 - Summary of Accounting PoliciesBasis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires the Company to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expenses when they are incurred.

Payment of benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent events

The Plan has evaluated subsequent events through July 31, 2025, the date the financial statements were available to be issued.

Note 3 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- Mutual funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- Collective trusts – Valued at NAV of units held. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the trust less its liability. This practical expedient is not used when it is determined to be probable that the collective trust will sell the investment for an amount different than the reported NAV.

Note 5 - Related Party Transactions and Party in Interest Transactions

Certain Plan investments are managed by Fidelity Investments. Fidelity Investments is the recordkeeper of the Plan and, therefore, these transactions qualify as party in interest transactions. The Plan also engages in transactions with participants related to notes receivable. These transactions are covered by an exemption from the prohibited transactions provisions of ERISA and the IRC.

Note 6 - Plan Termination

The Company has no legal or contractual obligation to make annual contributions to or to continue the Plan. The Company reserves the right to terminate the Plan at any time. In the event the Plan should terminate, each participant affected by such termination shall have a vested interest in their account of 100 percent.

Note 7 - Tax Status

The non-standardized pre-approved ("pre-approved plan") adopted by the Company received its latest favorable opinion letter dated June 30, 2020, in which the Internal Revenue Service ("IRS") stated that the pre-approved plan, as then designed, was in compliance with the applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the Company believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires the Company to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 1 - Description of the Plan

The following description of the Tellurian Services 401(k) Retirement Plan ("Plan") provides only general information. Participants should refer to the plan document and trust agreement for a more complete description of the Plan's provisions.

General

The Plan, amended as of July 15, 2024, is intended to be a qualified retirement plan that enables eligible employees to save for retirement. The Plan covers substantially all employees of Tellurian Services LLC ("Company"). Tellurian Management Services LLC and Driftwood Asset Services, LLC are participating employers of the Plan. There is no age requirement or service requirement to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

During October 2024, Woodside Energy Group Ltd ("Woodside") completed the acquisition of the Company. The Company and Woodside representatives have discussed the status of the pending plan merger of the Plan into the Woodside Energy USA Services Inc. Retirement Savings Plan. Currently no timeline has been established and the Plan will continue to operate independently.

Contributions

Participants may elect to defer a percentage of their eligible compensation into the Plan as a pre-tax contribution equal to the lesser of 90% of their eligible compensation or the maximum amount permitted by Internal Revenue Code ("IRC"). Participants are eligible to designate their elective contributions to the Plan on an after-tax or Roth basis. The Plan also contains an automatic enrollment features in which the Company will automatically enroll an employee in the Plan at 6% of the employee's eligible compensation unless the employee elects to stop or change this automatic contribution. Participants who are projected to be age 50 or older by the end of the plan year may also make catch-up contributions to the Plan.

Participants can roll over part or all of an eligible distribution they receive from an eligible retirement plan as a rollover contribution into the Plan.

The Company may make a discretionary matching contribution. Employer discretionary matching contributions, if made, are computed by the Company based on a participant's eligible compensation deferred into the Plan each payroll period. During 2024, participants' contributions were matched by the Company at 100% of the first 6% of eligible compensation deferred by a participant.

Participant accounts

Each participant's account is credited with the participant's contributions, rollover contributions, employer contributions, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Note 1 - Description of the Plan (Continued)Vesting

Participants are vested immediately in their contributions, rollovers, employer matching contributions, plus actual earnings thereon. After two years of service, participants are 100% vested in employer discretionary nonelective contributions plus actual earnings thereon.

Notes receivable from participants

Loans from vested account balances shall be made available to all participants on a reasonably equivalent basis. The minimum loan is \$1,000 and the maximum amount is the lesser of one-half of the participant's vested account balance or \$50,000 reduced by the highest outstanding loan balance in their account during the prior twelve month period. All loans shall bear a reasonable rate of interest. Repayment should be made through after-tax payroll deductions in level payments on at least a quarterly basis over a five year period unless it is for the purchase of a principal residence. A participant may only have 1 loan outstanding at any given time.

Payment of benefits

Participants are eligible to request a distribution from their vested account balance based on any of the following events: death, disability, retirement, required minimum distributions, and termination of employment. The entire vested account balance will be paid to the participant in a single distribution or other distribution that the participant elects.

Participants may defer the receipt of their distribution until a later date. However, a participant cannot postpone it if the vested account balance is \$5,000 or less in which case the Company will direct the trustee that any account exceeding \$1,000 be distributed to an Individual Retirement Account or Annuity for the participant's benefit. If the vested account balance is \$1,000 or less, the Company will direct the trustee to distribute it to the participant in a lump sum distribution without the participant's consent.

Participants may also take an in service withdrawal from the Plan. A participant may apply to withdraw certain contributions to satisfy specific and heavy financial needs as a hardship withdrawal. In addition, if a participant has reached age 59½, they may elect to withdraw all or a portion of their entire vested account while still employed by the Company.

Forfeited accounts

If a participant terminates their employment with the Company and are less than 100% vested in their employer account, the participant will forfeit the non-vested portion. Forfeitures are retained in the Plan and may first be used to pay administrative expenses. Any remaining amounts will be used to reduce future employer contributions payable under the Plan. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$1,288 and \$28, respectively.

Note 2 - Summary of Accounting PoliciesBasis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires the Company to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expenses when they are incurred.

Payment of benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent events

The Plan has evaluated subsequent events through July 31, 2025, the date the financial statements were available to be issued.

Note 3 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- Mutual funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- Collective trusts – Valued at NAV of units held. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the trust less its liability. This practical expedient is not used when it is determined to be probable that the collective trust will sell the investment for an amount different than the reported NAV.

Note 5 - Related Party Transactions and Party in Interest Transactions

Certain Plan investments are managed by Fidelity Investments. Fidelity Investments is the recordkeeper of the Plan and, therefore, these transactions qualify as party in interest transactions. The Plan also engages in transactions with participants related to notes receivable. These transactions are covered by an exemption from the prohibited transactions provisions of ERISA and the IRC.

Note 6 - Plan Termination

The Company has no legal or contractual obligation to make annual contributions to or to continue the Plan. The Company reserves the right to terminate the Plan at any time. In the event the Plan should terminate, each participant affected by such termination shall have a vested interest in their account of 100 percent.

Note 7 - Tax Status

The non-standardized pre-approved ("pre-approved plan") adopted by the Company received its latest favorable opinion letter dated June 30, 2020, in which the Internal Revenue Service ("IRS") stated that the pre-approved plan, as then designed, was in compliance with the applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the Company believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires the Company to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
